Freebies Destroying Country Economy

Political climate is heating up. Elections are fought to win. Political parties leave nothing to imagination. Nation's developmental programmes and economic health are acutely compromised. Freebies can have adverse consequences on the fiscal health and macroeconomic stability of the state and thus the country, by increasing public expenditure, deficits, debts, and inflation. There is no legal definition of a freebie. The difference between freebies and government welfare schemes is not clear, but a general thumb rule is to assess whether a political party has planned the fiscal room before announcing a freebie or a so called people welfare schemes. Political parties position their plans as welfare for the needy, and dismiss the same of the opposition as wasteful giveaways. There is a sea difference between electoral-win oriented freebies and government announced real welfare schemes which are well thought, planned, duly budgeted with funds sources well defined without jeopardising the funds for other sectors and or diverting funds from more productive and essential sectors such as infrastructure, agriculture, industry, etc. The money that could have given better infrastructure is given to free bus rides, the investment for renewal energy is given as free 200 units of power, etc. Freebies have a negative impact on the environment too, by encouraging overuse and wastage of natural resources, such as water, electricity, or fuel, as people tend to over use them, just because it is free. Freebies are seen as a way of luring voters or bribing them with populist promises. Some examples of freebies are free cash transfers, loan waivers, laptops, TVs, bicycles, electricity, water, etc. These freebies naturally are at the cost of tax payers. If at all the political parties are so much passionate about providing relief as freebies, why not free bus rides only for senior citizens? Why generalize for all women who do not need this free ride? Freebies are a double-edged sword. Anywhich way you swash the sword it has to rip apart the tax payer. Several countries have gone bust. Venezuela and Sri Lanka are latest victims of freebies termed as subsidies at the cost of destructions of their country economy. India could face the same prospect of sub-national bankruptcies if States continue to dole out freebies to influence the voters; all denting the exchequer sucked mercilessly from poor tax payers. We have selfish leaders to doom the national economy. AAP's Kejriwal set the doomsday trend. Now we have a lineup of parties. Leading the freebies mockery in the name of people welfare are AAP, Congress, DMK, YSR Congress, BRS and TMC, to name the leaders. Freebies, aimed at benefiting the targeted population in the short term, create the dangerous "Dependency Syndrome. Freebies are always for a particular targeted voter segment. This makes targeted people lazy, revenue isn't generated in the system and slowly people are so dependent on the Government, as a result the government gets completely ruined. Victims of Freebies create a negative pattern of dependency who expect more in the future and become less motivated to work hard or pay taxes. It can reduce the sense of responsibility and accountability of the beneficiariesThis is unhealthy for the beneficiaries and the Nation. Several top bureaucrats have time and again flagged their total discontent and critical concerns over populist schemes and mindless freebies announced by political parties during elections, just to win, not mindful of they affecting the national economy. Freebies must be understood from an economic perspective and connected to taxpayers' hard earned money. It is time to draw a Line Between Welfare and Freebies. Election Commission of India (ECI) has to be empowered to regulate and monitor the announcement and implementation of freebies by political parties during elections. This should include giving the ECI more powers to de-register parties, impose hefty penalties, or take contempt action for violating the model code of conduct or the court orders on freebies. Judicial Intervention becomes indispensable to frame measures. The Supreme Court has suggested setting up an expert committee to look into the issue of freebies and their impact on the economy and democracy and stricter legal reforms to ban political parties from freebies-politics. Mother of all deterrent for political parties is Voters' Awareness. In a democracy, the power to block or allow the parading of freebies is with the voters. Educating voters about the economic and social consequences of freebies and encouraging them to demand performance and accountability from political parties is another way forward to ban political parties to announce freebies during elections and in their manifesto. It is for the voters to decide if they want to Chase a Chimera for illusionary pleasures or long term prosperity!

SINKING AAP ?



Chief Minis-Delhi ter Arvind Kejriwal who climbed the popularity ladder entering politics with his Aam Aadmi Party (AAP) sweeping the Delhi State elections this decade. AAP was elected to rule Delhi for the second straight term, based on freebies those were to dent the state economy later, and he also captured the confused Punjab in last year's State elections, grabbing the mantle from the then ruling Congress with the same freebies culture. He appeared to have stolen the limelight with his favorite statements that: except for him all others in he was the president of the Board of Control for Cricket in India (BCCI) from May 2015 to February 2017 politics are corrupt. he will move around freely without security, he will travel in his old self-owned car, will not take to luxury life and continue to live in

his own small flat and he put all the corrupt in jail. These were all his own public statements at that time, about 9 years ago when he formed his AAP end of 2012 caving out of the popular Anna Hazare andolan, mass movement against political corruption. All these are gone for a toss. What he does and is now are exactly the opposite. All these have gone for a wild toss! Arvind Kejriwal today is down, quite and fallen from grace in politics. His government is all out scandals and scams. He lives in luxury government mansion that was specially renovated for him at a whooping cost of over Rs 48 Crore, which is under CBI investigation. Moves around in a fleet of cars, wearing expensive branded apparels in private, has security ring and is in the midst of scandals and scams those are under CBI, DRI and ED investigations. Three of his favoured AAP leaders, two of them also Ministers, Manish Sisodia, Satyendar Jain, and Sanjay Singh, have all landed in jail after being arrested by central probe agencies in money laundering cases.

What happened to Kejariwal? He has always been riding high on ego, arrogant with the bureaucracy and was like an empty vessel, always making noise, but no action. In the last 9+ years Delhi under Kejriwal has seen development. What one sees as Delhi was all the hard work of his predecessor Delhi CM late Shiela Dixit. Even today after several years of her demise, people of Delhi remember her as the most efficient and passionate CM ever who lifted and dreamt of Delhi as a world's astonishing capital. Autocratic to the core, Kejriwal went about neutralising anyone who was seen as a competitor or pricked his conscience. it is a story of a nemesis confronting hubris!

The India Against Corruption (IAC) movement steered by Arvind Kejriwal as 'Messiah' and a force for good, for ramming through the groundbreaking Lokpal Act in 2013. It was considered a middle-class uprising against political corruption that deprived the government several lakhs of crores to the exchequer or having siphoned laksh of crores from it. To give the devil a decent credit, he was undoubtedly the moving force in the crusade against corruption when he entered politics with his AAP banner dramatically.

His tactics in attempting to overshadow RSS and BJP philosophies were dramatic. Kejriwal roped in Hindutva icons Ramdev and Sri Sri Ravishankar to the IAC fold which drama was busted his own close aide at that time Prashant Bhushan. At the end, Kejariwal's third rate copsand-robbers narrative was just a ploy to steal the limelight of the Hindu voters and that he never really had any such affinity towards Hindutwa at all.

What was unknown at that time was his inner craving for Power. He became the Delhi Chief minister, for possibly the first time in history without any portfolios for himself. Having got a taste of power, albeit without accountability, he lusted for more. Kejriwal realised that the anti-corruption movement had run its course and he needed to migrate to where the real power was to remain relevant in the public sphere. Here is where he started making mistakes. But he was helpless, as scams and scandal of his government started getting exposed. The Liquor scam, school building scam in the name of building world class government schools, renovation of his official bungalow, jal Board 70K crore embezzlement, to name a few were great potential bombs to devastate his political stakes. Though Kejariwal says these allegations, the ED and CBI investigations tell a different story.

Kejriwal went about rearing his self-serving politics. His first mega mistake was to sever his ties with his close aides Prashant Bhushan and Yogendra Yadav who were then touted to be the conscience of AAP. His possible next mistake was to nominate a CA and a Businessman from his cast to Rajya Sabha that annoyed those eligible suitors who slaved for the party and Kejariwal's

success. His literal downfall started from here. The Liquor same consumes almost all of his credibility. Three of his close aides who have been picked by the investigating agencies and languishing in jail for the past several months berate Kejariwal's claims that they are framed.

Under his administration Delhi has seen no developments at all. Not an iota of infrastructure development seen. Almost all the revenue earning departments are running in losses. Delhi Transport corporation, DTC, is running at loss of 9+ crores a day, thanks to h is free ticket for women. Delhi electricity board is running in losses owing to his freebies of 200 units free electricity. Jal Board liabilities have increased to a whooping 70K crores, which many allege is owing to rampant corruption and siphoning of money from its budget.

His big promos trumpeting that the government schools have been transformed to global excellence schools also has been exposed in that he just made beauty interiors to the school building and class rooms of some schools. Teaching staff and the standard remains the same as earlier. Teachers protests continue to haunt his administration.

Having betrayed several of his own people who slaved for him and his party, the preacher of public morality now is running here and there, running scared, with the fear of may be picked up by the agencies and put behind bars to join his close aides already languishing there.

Should this happens what will happen to his political ambitions? It is being rumoured that Kejariwal is making his plan-B for the extreme eventuality. It is rumoured that he just might bring in Raghav Chadha, the RS MP from Punjab to Delhi to be the Delhi CM, elevate Atishi Marlena Singh as Dy Chief Minister and put his wife Kavita as the AAP party chief and later nominate Raghav's wife Pareeniti Chhopra to the Rajya Sabha. All these are possible wild guesses, but does not look impossible.

Kejariwal today is totally confused on his political goals and directions he should take, falling from grace like a hot potato. The image and positions of other parties aren't good either. But all said when the Delhi elections come in it would be a bad choice for the people to choose between the Devil and the Bigger Devil and it is possible the smaller Devil gets it again! RAJ DARBAR

Pandian To Succeed Patnaik?

In a surprise move V Pandian, Karthikeyan most controversial figure, but also the most powerful bureaucrat in Odisha for over a decade, and considered by all in the State as the De-Facto Chief Minister, has taken voluntary retirement (VRS). More surprisingly his VRS request for cleared by the Centre in just flat 3 days, in spite of the fact that the Department of Personnel and Training (DoPT) had asked Odisha Chief Secretary to take disciplinary action against him!

This also has surprised many as VRS requests takes months to get approved, but his was cleared and settled in less than 3 days. Is it the 2024 election effects or something else than that meets the eye?

Both the BJP and Congress earlier had moved the DoPT under the Ministry of Personnel, Public Grievances, Pensions, seeking action against the IAS officer, V K Pandian. The DoPT had written a letter to Odisha's Chief Secretary asking the top official to take appropriate action against the officer amid an allegation of violating the norms of the All India Conduct Rules.

But now the focus shifts elsewhere!

A 2000-batch IAS officer, Pandian served as the private secretary to Odisha Chief Minister Naveen Patnaik since 2011. His VRS was cleared by the Centre on a super express speed, just in less than 3 days!

A day after the Centre approved the voluntary retirement of "powerful" Odisha cadre IAS officer and Naveen Patnaik's private secretary and closest aide V K Pandian, the state government appointed him as chairman of 5T (transformational initiatives) and Nabin Odisha with a Cabinet rank.

An order issued by the state general administration department said Pandian would work directly under the chief minister, which indicates that the erstwhile bureaucrat of the 2000 batch would continue to wield "extraordi-nary influence" in Odisha governance. Though the state government order gives no clarity on Pandian's new role as chairman of 5T and Nabin Odisha, sources said the former IAS officer would work with more authority. since major programmes and projects of the state government are taken up under the 5T, which has Pandiyan's footprints in almost every Odisha government department now.

The $5\overline{T}$ initiative. launched in Patnaik's fifth and current term to overhaul the administrative apparatus, is believed to be Pandian's idea. The Ts stand for 't'ransparency, 't'eamwork, 't'echnology and 't'ime, leading to 't'ransformation. Under it, the Patnaik government claims to have transformed over 4,000 high schools in Odisha, with refurbished classrooms, laboratories and playgrounds.

With the Odisha government having recently approved the Rs 4,000 crore 'Ama Odisha, Nabin Odisha (Our Odisha, New Odisha)' scheme under which every panchayat will get Rs 50 lakh to take up different projects, it will now be implemented under the direct supervision of Pandian.

But this said, how the Biju Janata Dal (BJD) workers and Leaders look at his elevation, who are already against Pandiyan, an outsider's rise in local politics. But all of them got the pulse of the Odisha Chief Minister Naveen Patnaik when Pandiyan used party funds and state owned helicopters for official work and that Patnaik stated openly that Pandiayan's acts had his pre-approval.

Though he initially had the reputation of being reticent and elusive, Pandian had been leading more from the front of late. He was often seen in public with the Chief Minister. With the CM's support Pandian was definitely the most influential top notch IAS officer in the State.

Pandian was always appreciated for his efficiency, transparency, vision and meticulous planning and implementation. This earned a name and slowly the CM appears to have started assigning him jobs that supports the CMs political ambitions and initiatives. Pandian always was appreciated for his perfected planning.

With popularity comes passion for power, however far one tries to distance from such personal greeds. It is this extraordinary influence that Pandian holds in the State that has come under scrutiny not just from the Opposition, but also from sections of the BJD. Though there were

among the old guard of the BJD about Pandian's rising prominence and their own growing irrelevance, CM continues his faith in Pandiayan. Wielding such an influence and being close to the CM, it is only natural that Pandian, is becoming the latest target of CM's own and Opposition parties in the State. BURMANS-DERA BABA ₹1006 Cr Fraud

It is all accusations and counter accusations drama all over again by the Burmans of Dabur India, Religare Chairperson Rashmi Saluja and its Independent Directors and the new entrant, Dera Chief Babaji. **Dabur India promoters** Burmans are being accused of siphoning over Rs 1000 Crore from Religare owned entities to Radha Soami Satsang Beas in Punjab. Then there is the evergreen fraudsters **Ranbaxy's** Singh brothers. This fraud drama now has jailed conman Sukesh Chandrasekhar also entering the scene!

The ongoing spat between billionaire broth-Malvinder Singh Shivinder Singh, ers. and who once together owned Fortis Healthcare and Ranbaxy Laboratories, has taken a sharp twist after a complaint before Delhi Police that has directly named Radha Soami Satsang Beas Gurinder Singh Dhillon known as Babaji for illegally benefitting, conspiring and diverting funds more than Rs 1000 crores from Religare group of companies through the Burmans game plays. These sensational charges, asking the police to probe the Dera head, have been made in two different plaints, one submitted by Religare's current management and second by Malvinder himself! In a separate move, SEBI also has intensified its investigations and examining how **REL's** share price has been dropping consistently from Rs per share to Rs 235 per share with charges of "Dabur's hostile takeover" by REL's independent board. Too many coincidences directing at planned fraud. The SEBI complaint accuses the Burman family of having a categorical nexus with Gurinder Dhillon and the original promoters of Fortis-Religare, that is brothers Shivinder and Malvinder Singh.

In the same Delhi Police complaint, the Religare company's Vice President Manpreet Singh Suri, has also sought probe against Shivinder's wife Aditi for allegedly paying illegal gratification of Rs 200 crore to jailed conman Sukesh Chandrasekhar to "bribe government officials for obtaining bail for her husband from the judicial custody".

Supreme Court had last year jailed both Malwinder and Shivinder while Malwinder had this year in June secured a bail.

In a separate complaint, the accused Malvinder Singh too had told Delhi Police, that he requested the Dera baba to settle the loans extended by Religare and or its subsidiaries to Gurinder Dhilllon and his family members, including his son as the total outstanding of Religare had crossed beyond Rs 5,400 crores.

The complaint also named six firms, as subsidiaries of Religare, were used by Shivinder to aid Gurinder in Punjab's Beas, and his associates in achieving his goals from inside the jail, but now on bail. These six companies are: Best Healthcare Private Ltd, Modland Wears Private Ltd, Fern Healthcare Private Ltd, **Devera Developers Pvt** Ltd. Green Line Buildwell Pvt Ltd, and Adept Lifespaces Pvt Ltd. It is also alleged in the same **Delhi Police complaint** that these companies were acquired without proper due diligence.

There are serious charges of 'share manipulation' against the Burmans. The Burman family — Mohit Bur-man, Amit Burman, Gaurav Burman and Saket Burman — who run the Dabur Group, the 138-year-old FMCG company that manu-factures Hajmola, Real Juices, Vatika hair oil, Chywanprash among other personal care products, had made a public offer for acquisition of shares of REL at Rs 235 per share. Interestingly, coinciding with this open offer, the share prices of REL dropped systematically to Rs 235 per share. It looks like a perfect plan orchastered by the brain tank of Burmans.

"In the foregoing circumstances, it is highly probable that the present hostile takeover of **REL** has been carefully planned by the Burman Group. The Burman group acquired about 7.5 % of REL shares in the month of August 2023. It is verily believed that the Burman Group has there after persuaded various persons to purchase shares of REL and after the public announcement on September 25, 2023 to sell the shares so purchased at the proposed offer price of Rs 235 in order to ensure that the value of the scrip which was Rs 271.55 per share on September 29, 2023, drops consistently to the proposed offer value of, that is Rs 235 per share," the complaint has said.

"It is the general practice that the share price of an acquiring company drops and the target company's short-term share price tends to rise because the shareholders only agree to the deal if the purchase price exceeds their company's share value. But REL's share value have dropped by 11 %," it added.

Security Exchange **Board of India (SEBI)** has intensified its probe on the accusations of market manipulation done by India's oldest Ayurveda major Dabur India after the complaints with Delhi Police made startling disclosures on systematic diversion of more than Rs 1,006 crore from a core investment company Religare Enterprises Limited (REL) to **Punjab's spiritual group** Radha Soami head **Gurinder Dhillon based** out of Beas in Amritsar. "It has been pointed out earlier, that the Burman

Group acquired a 7.5% stake in the company (REL) through a block deal worth Rs 533 crore on August 16, 2023 which increased their stake from 14 % to 21.5 % in the company. Notably, the 7.5 % stake was bought by the Burman through Investment Opportunities V PTE, which in turn, had bought these shares from Resilient **India Growth Limited** in January 2021, which had bought these shares from the Dhillon Group (Gurinder Dhillon of Radha Soami Satsang in Beas) in December 2017. Therefore, it's the shareholding of the Dhillon Group that has been finally acquired by Burman which further reveals nexus between acquirers with Dhillon & Singh brothers," reads the detailed complaint by REL before SEBI.

From where the money is flowing for the Burman family and its group that is attempting a total takeover bid of REL? The complaint states that only, an in-depth forensic investigation by the SEBI would reveal the source of funds. The investigation by the SEBI on this proposed acquisition by the Burman family, that also jointly owns IPL cricket team Punjab Kings, has begun following these charges sensational made by the board of independent directors of the REL itself, in a 99page complaint.

The board of independent directors that has approached the SEBI against these charges was constituted the India's central bank Reserve Bank of India (RBI) in 2018. These damning revelations come barely less than three weeks after **Delhi Police's Economic Offences Wing (EOW)** separately launched mega probe into alleged fund diversion, between 2017 and 2018, from as many as six subsidiary companies of Religare - Modland was used to divert Rs 223 crore, Devera gave Rs 122.6 crore,

Fern Healthcare handed over Rs 292.5 crore, Best health care deposited Rs 207 crore, Adept and Rosestar gave Rs 152.8 and Rs 8 crore to Dera baba's family members: Gurinder Dhillon (himself), Gurkirat, Gurpreet Dhillon, Shabnam Dhillon (deceased wife of Radha Soami Satsang **Beas**) — to Gurinder Dhillon and his family members including his son.

Story continues. As these investigations are in process, Burmans who have made a controversial 'open offer' that is to bring in fresh consideration of Rs 2,116 crore into REL, also have, on their part, filed a complaint.

Entities controlled by the billionaire Burman family, the largest shareholders of Religare Enterprises Ltd, have written to the Securities and Exchange Board of India (SEBI) and stock exchanges, seeking a probe into trades in the shares of the financial services firm by Chairperson Rashmi Saluja and her beyond imagination annual drawings from REL.

Entities controlled by the billionaire Burman family - MB Finmart, Puran Associates, VIC **Enterprises and Milky** Investment and Trading Co - that collectively hold 21.24% in Religare said the REL Chairperson Rashmi Saluja sold a portion of her personal holdings in the firm soon after a 45-Miniutes meeting at The Oberoi Hotel in Delhi with a representative, possibly their exclusive financia advisor JM Financial, of the Burmans extending an "open offer". The Burmans have also alleged and taken exception to the huge annual compensation of Rs 150 Crore that she takes home. REL in turn has questioned from where the Burmans huge cash is flowing from?

The drama goes on. Corporate wars are always complex, but very interesting.

ED Destroying Coop Sector



Kerala Chief Minister Pinarayi Vijayan on Monday accused central agencies such as the Enforcement Directorate (ED) of targeting the cooperative sector banks in the state while turning a blind-eye to large-scale financial irregularities in other parts of the country.

Kerala CM Vijayan alleged that agencies like the ED were coming to Kerala to portray something being wrong with the cooperative banks here, with the "ill-intention" of destroying the sector. The CM said that such politically motivated moves would neither be accepted nor permitted in the state.

He was speaking after inaugurating a conference here on the topic of protecting the cooperative sector. Vijayan said there were deposits worth over Rs 2.5 lakh crore in cooperative sector banks in the state which were functioning efficiently and professionally. "With the aim of destroying this sector, central agencies are coming here," CM Vijayan alleged.

Referring to the Karuvannur bank scam, Vijayan said that once the corruption in that establishment was revealed, both the cooperation department and the police had taken action. While action was taken against the culprits, the government did not shut down the bank but tried to support it in order to safeguard the trust the people have on cooperative banks. he said.

"Instead of investigating large-scale irregularities in other parts of the country where no action has been taken by the state governments, it is coming it is coming only to Kerala," he further alleged. Vijayan also claimed that the ED is an agency that has been severely criticised by many top courts of the country.

He said that various public sector banks in the country had over Rs 66 lakh crore worth of non-performing assets and, of those, around Rs 16 lakh crore was waived off by the central government. "These huge irregularities were committed by those at the helm of huge corporate companies. They committed the frauds and escaped to foreign nations," Vijayan said.

He further alleged that 15 percent of such businessmen are those with links to the BJP at the Centre. "Therefore, they are safe. No one questions them. There are some banks who are complicit in such activities, but the ED never sees them, never reaches them and does not question them. "Instead, it targets the cooperative sector banks which are the backbone of our state. This is not acceptable and will be opposed," Vijayan said.

He called upon everyone to come together as one and oppose such activities of central agencies like ED. The Enforcement Directorate, which is investigating the multicrore Karuvannur bank scam, has arrested a local CPI(M) leader and Wadakkanchery Municipal **Councillor P R Aravindak**shan. The agency also arrested a former employee of the bank C K Jills, who allegedly syphoned off Rs 5 crore in bank funds. The ED had earlier arrested two people in connection with the alleged issuance of 'benami' loans from the bank. Kerala MLA A C Moideen was interrogated for over nine hours by the ED. The investigation into the alleged fraud, beginning in 2010 in the Thrissur-based bank, stems from 16 FIRs registered by the Kerala Police (crime branch) in Thrissur, Kerala.

MAHUA GETS Yechury Support



Sitaram Yechury extends support to Mahua Moitra, calls TMC "undemocratic & corrupt"

Kolkata: Standing Trinamool Conbv gress Member of Parliament (MP) Mahua Moitra, CPI-M General Secretary Sitaram Yechury said that the Ethics Committee is not meant for harassment and it should probe and find out the real facts. Meanwhile, with an eye towards 2024 Lok Sabha polls, Yechury also made it clear that CPI-M will not support Trinamool Congress in Bengal, which is "corrupt and undemocratic" but the party will be part of IN-DIA bloc, where Trinamool is also a part.

"I was in the Ethics Committee for more than ten years in Rajya Sabha. It had its meeting for 4-5 times in the period of ten years. The Committee generally does not meet so often. The way this complaint was received and the Committee met twice in such a short interval...it is really amusing. Why is it done in such haste? The Committee's meeting has been called in such haste as Adant's are involved," Yechury said.

"If you want to probe, do the investigations properly. The committee is not meant for harassment, it is meant for probing, investigating and finding out what really happened," the CPI (M) generally secretary said.

Moitra reportedly participated in the Ethics Committee meeting

recently but walked out of the meeting. Some opposition MPs, including BSP MP, also left the meeting in the middle of it, saying unethical questions were being asked to Moitra.

BJP State President Sukanta Majumdar lashed at out CPI-M and Trinamool saying, they are all part of the same alliance and targeting to remove Prime Minister Narendra Modi from power.

Meanwhile, clearing his standing on Trinamool in Bengal, Yechury referred to the famous saying, "Keral me kusti, Delhi me dosti", and added that "this is going on for long from the time and everyone knows about it."

"In case of Bengal, we are opposed to Trinamool but they can come with all as part of INDIA bloc. Trinamool is and anti-democratic party and tainted with corruption in Bengal. If the party comes with INDIA Bloc to defeat BJP, we have no objection. However, our fight against the party will continue in West Bengal," Yechury said.

Trinamool cannot be an alternative to the BJP," Yechury emphasized. "In case of corruption, ED can take action but it cannot harass the opposition parties. The people who are corrupt should be convicted but when the same person is defecting to BJP," Yechury said while talking about ED raids in various states, including Bengal.

In this decade the Government of India is always focused on exports and has been rolling out schemes and encouraging exporters to perform more and more taking India to greater levels. There is an endless of items that are exported out of India.

India exports items like Coffee, Tea, Kali Mirch (Black Pepper), Elaichi (Cardamom) that makes up for the premium priced items being exported.

Agriculture exports plays crucial roles in economic development in India, such as provision of food to the nation, enlarging exports, transfer of manpower to non-agricultural sectors, contribution to capital formation, and securing markets for industrialization.

Indian spices exports, a part of the agricultural produce items, play a major role in the growth of our country's economy. Spices are high value and low volume commodities of commerce in the world market.

All over the world, the fast-growing food industry depends largely on spices as taste and flavor makers. Health conscious consumers in developed countries prefer natural colors and flavors of plant origin to cheap synthetic ones. Thus, spices are the basic building blocks of flavor in food

Spices contribute one of the key sectors of the Indian economy. It is the economically and commercially significant agriculture crops in the world. Indian spices are the most sought-after globally, given their exquisite aroma, texture, taste and medicinal value. Traditionally, spices in India have been grown in small land holdings, with organic farming gaining prominence in recent times. Given the importance and high value of the spices exports, India still lags behind in volume despite good high quality produces owing largely to the corruptions that is rampant and the nexus of the government officials with the Spieces Mafia.

Elaichi, Cardamom, is one such spices which has very high revenue potential for the government. But rampant corruption in the customs department



and spices mafia nexus is making India lose over 1000 crore in revenue to the government.

Teni District of Tamil Nadu produces huge quantity of Elaichi. The areas that produce Elaichi include Pody, Podymettu, Khambhammettu and Munar. The quality is par excellent and is the most sought after Elaichi produce by the overseas buyers. It is being alleged that due to lackluster attitude of officials of Central Excise and Customs and State Government's Excise Department and rampant corruption in this department is making the exchequer lose over Rs 1000 crores in revenue. In short, the dreaded Bureaucracy-Mafia-Polity nexus is literally destroying this industry in this Tamil Nadu district. Mafia goons working for the spices smugglers are at work in this small Elaichi producing district of

TN. They force the producers to sell at lowest costs to them, who in turn sell them at way too high prices. Allegedly, the smugglers force the producers to sell their Elaichi produces @ Rs 600 / Per Kg. They then export them @ Rs 5000 / Per Kg, but without paying the taxes. This again is a case of GST frauds.

Modus operandi. Fraudsters create several bogus and benami companies. These are to generate bills and pass on input credits within the same company cluster, or just not pay the GST at all. The fraud transactions involve fake purchase invoices at inflated prices and pass on fraudulent input tax credits, or just not pay at all, thus denting the government chequer by several crores of rupees. In short: This is a case of issuing fake invoices, where the fake and or inflated invoices are issued to one person and the goods are diverted to some other person. The person who purchases invoices may utilize the credit for payment of taxes at the time of export of goods and claim refund of the said tax paid, resulting in loss of revenue. This is no small loss, but runs into several hundred thousand crores month after month.

It is being alleged that local politicians and his close confidantes in nexus with local corrupt officials are fanning such types of illegal businesses, under the blessings of officials of Central Excise and Customs and State Excise Department, the illegal activity is thriving and flourishing resulting in exchequer, revenue, loss to the government.

It is open and fearless nexus among the Spices Mafias, Politicians and corrupt Officers. The Finance and the Commerce Ministries are in the know of these frauds and smuggling of this spice from neighboring Kerala where the distribution system is in total disarray. What the customs vigilance department doing to halt this illicit spices trade that is denting the government exchequer by several hundred thousands of crores? Are they also a part of this corrupt nexus gang? Finance and Commerce ministries are sleeping over this huge revenue loss issue. It is time the central government took stern measures to stop this illicit business in this district and elsewhere, bust the crime nexus, book all the culprits irrespective of the status and position and attach all their assets immediately. It is time for genuine exporters to do their business and move forward taking Indian spices exports to new heights.

But it appears they will respond and call the next meeting only after they are through with the ongoing elections," said Bihar CM Kumar, who had hosted the first meeting of opposition leaders in Patna in June which set the tone for the formation of the coalition. The Congress on its part and to counter Nitish Kumar' concern and accusation, asserted that the new opposition I.N.D.I. alliance bloc had been formed for the 2024 Lok Sabha elections at the national level and was not state specific.

Asked about Kumar's remarks, Bihar Congress chief Akhilesh Prasad Singh in a press conference held in AICC HQ in Delhi said, "It was a CPI event. I have heard his speech. The intention of his remarks is that the Modi government should be removed as soon as possible. But it will be removed only when the elections are held and the time comes." Communist Party of India (CPI) general secretary D Raja made a fervent appear to the public at the rally to dislodge the BJP government at the Centre, as it is "anti-poor and working to benefit only a few corporate houses in the country", besides "compromising" with the Constitution and Democracy". "We are confident that the BJP would be defeated in the 2024 parliamentary elections, and a pro-people government would be formed at the Centre, since popular anger against the present central government is visible everywhere," D Raja said while addressing his party state-level rally.

D Raja also upheld the cast-based headcount done in Bihar by the Nitish Kumar-led Grand Alliance (GA) government, and demanded holding a similar census across the country in all Statesand UTs. He also commended the Bihar aliane formt saying Bihar provided the lead for the opposition unity by form-

ing a GA government. Raja also added that the I.N.D.I. aliance bloc is also strong, depite some local or state-level complexities, which will be resolved soon. "Our political vision is clear that the BJP government at the Centre has to be removed," Raja said. He also added that the Left parties have been telling the Congress to develop mutual trust and accommodation if we are to win the elections and remove BJP from its rule. CPI's D Raja summarized the Bihar CMs remarks in his speech at the CPI rally. The summary of the Bihar chief minister's remarks was that the parties that have come together should be more pro-active and jointly dislodge the Modi government, he said.

Talking about the Congress taking on others such as the BJP and the BRS in the upcoming state polls, Rajya Sabha MP and Congress Working Committee member Syed Naseer Hussain said at all the places, "we are fighting the elections with full force and all the survey reports that have come have shown us in the lead and that we are going to form government".



Ajay Maken elevation to Treasurer of the grand old Congress Party had not gone well with many congress loyalists. Ajay Maken, a member of the Congress Working Committee (CWC) and one of the past General Secretaries of the All India Congress Committee (AICC) had been Union Cabinet Minister in former Prime Minister Dr Manmohan Singh's Cabinet and Minister under former Delhi Chief Minister Late Shiela Dixit. Two times Parliament Member and three times State Legislative Member, Ajay Maken, 59, took the mantle of Treasurer of Congress party early this month, replacing and succeeds former Union minister Pawan Kumar Bansal, who served as the Congress treasurer after the demise of Ahmed Patel in November 2020.

Ajay Maken is considered close to Congress bosses Rahul Gandhi and Sonia Gandhi and now occupies a key position in the party hierarchy, along with such leaders as Congress general secretary KC Venugopal and the party's Madhya Pradesh in-charge Randeep Surjewala. Maken quit as the party's Rajasthan incharge in November 2022.

He caught the political limelight when Maken won as the first NSUI candidate in a direct election to be elected as the President of Delhi University Students Union (DUSU) in 1985, the first B.Sc. Chemistry (Hons.) final year student in this post. Since then he had been having a nice time in the party.

the State level, At he was Speaker of Delhi Legislative Assembly (2003-04) at the age of 39, Maken was the youngest Speaker in the Country, a Cabinet Minister of Power, Transport and Tourism (2001-2003) at the age of 37, the youngest until that time and Parliamentary Secretary to the Chief Minister Sheila Dikshit (1998-2001). He shot more to prominence when he defeated the popular BJP candidate Jagmohan in 2004 from the New Delhi Parliamentary constituency and going on to retain the seat in 2009. However. Maken was defeated in the 2014 general elections rolling under the BJP's Narendra Modi wave, by the more popular BJP candidate Meenakshi Lekhi. He served as the



Congress General Secretary until 2015, when he resigned after the party's failure to win any seat in the 2015 Delhi Legislative Assembly election.

Maken is credited with privatising power distribution in Delhi and moving public transport to a clean fuel system (Compressed Natural Gas, CNG). It was under Maken's supervision that the Delhi Metro work was sped up and officially launched on December 25, 2002.

Despite his rise from being a youth leader to becoming the priced CWC member, his rise has been, per party workers, has not been on his own merits. Soft spoken and lying low profile, has always been accused of going round the party bosses to steal meaty posts in the party. Though several party loyalists feel he is not the best fit for the party Treasurer post, he appears to fit the Gandhi's bills who would wish to have soft target of "Yes Sir" and "Yes Madam" man for this key sensitive position as the man would be rolling and sitting on loads of party cash, accounted and unaccounted. Understandable!

Maken naturally does not match the caliber of his predecessors late Sitaram Kesri, Motilal Vohra or Ahmad Patel who were all stalwarts, popular leaders, shrewd and powerful and who all had the knack and power needed for 'Vasooli' jobs as the party depends on their acumen to raise and manage huge money bags to fund such a big National Party. But nothing matters as long as he suits the bill of Gandhis', party's supreme bosses.

'Vasooli', the fund collection process for the party is very secretive and requires those special arrogant talents to both

convince and also pressurize the party donors to shell out the dough. This is a special job. Does Maken have those mandatory traits to collect from targeted sources? This is naturally is done through a huge complex web, network, of party office bearers starting from the bloc level to district levels. For instance party's district level Secretaries are generally entrusted with the fund collection from their targets in their districts. This goes to the next circle above and to the City and to State level Secretaries who all deposit, again a through a complex network of sources and channels. Does Maken have the capability to manage these people from bottom to top, ask the loyal party workers who appear to have known Maken and his work style for years.

Party workers say that Maken is not management genius and that his rise in the party is not through any hard work or mass popularity but owing to that special trait of being able to convince using his 'yes sir' 'yes madam' characteristics that made him climb up the ladder. This new position has come in a gold palter to a person who had been without any significant post for a long time, since he resigned as President of Delhi Pradesh Congress Committee few years ago and few months ago as General Secretary In Charge of Rajasthan.

But, all said, Maken today has reached the most important and sensitive position of being Treasurer of one of the biggest National Party and he shoulders greater responsibilities, that comes as a mandatory rider with power and now the onus is on him to prove to his bosses his honesty and caliber reflecting the faith they have entrusted him.



Nongress gets a strong candidate for its Bihar out-✔ fit. Former Tamil Nadu Director General of Police (DGP) (Vigilance) Braj Kishore Ravi joined the Congress Party in the presence of Congress Party MP and Congress Working Committee (CWC) member Syed Naseer Hussain and Bihar Congress Pradesh Committee President Akhilesh Prasad Singh at the AICC Head Quarters in New Delhi. 

The week-long event was inaugurated on Kerala Piravi Day on 10 November 2023. Addressing the gathering, Vijayan said the massive participation of the people shows that Keraleeyam was a huge success. The Kerala CM also said the government will consider the suggestions and directions received



during the 25 seminars that took place during the last seven days, as part of the event. While senior BJP leader O Rajagopal attended the event and witnessed the concluding ceremony, the opposition Congress-led UDF and the **BJP** boycotted the event altogether alleging that the Keralayeeam was a 'financial extravaganza' and was not needed at a time funds are badly needed for developmental programs of the Kerala State. The Chief Minister, in his speech, reiterated that the Keraleeyam festival will be continued in coming years. "We assure you that all the suggestions and directions that came from the seminars organised here will be considered for the further development of Kerala and its society," Vijayan said.

He stressed the need for more central assistance for further development in many sectors including the coastal area and its community. Vijayan also called for a change in the union government's National Rubber Policy in order to protect the interests of rubber farmers in this sector.

Kerala Finance Minister K Balagopal, who spoke at the event said the Kanakakunnu venue of the Keralayeem alone witnessed a footfall of over a lakh every day. "It shows that lakhs of people visited Keraleeyam and it will be a platform for the further development of the state," he said. In an apparent reference to the Congress party, Balagopal said those who criticise the event should at least raise their voice against the central government, which was 'refusing' to pay what is due to the state government. With 42 venues, 25 seminars aimed at shaping the future of New Kerala, exhibitions, food festivals, and grand art performances, the festival showcased Kerala's commitment to secularism, unity, and unique culture, according to the government.


Ten-Fold Increase In Farm Loans

Union Minister of Home Affairs and India's 1st Cooperation Minister since this Ministry formed, Amit Shah was addressing a gathering of farmers and people from the cooperative sector in Gandhinagar Lok Sabha constituency on Tuesday after inaugurating India's first liquid nano di-ammonia phosphate (DAP) plant of the Indian Farmers Fertiliser Cooperative Limited (IF-FCO) on the Ahmedabad-Kalol highway.

In our country 60% people are engaged in farming and about 60% of the country's land is suitable for agriculture. However, for a very long time farmers and farming activities have been neglected in our country. Impressing upon the focus the Prime Minister Narendra Modi government had been giving the farm sector, he coined several statistical figures.

Amit Shah said farmers and farming activities had been the most neglected in India for a long time. Indian farmers have for long felt neglected, but a significant shift has taken place under the leadership of Prime Minister Narendra Modi's government at the Centre with the country's budget for farmers witnessing more than a tenfold increase, Shah said.

Union Home Minister Minister of Cooperation Amit Shah attacked



previous governments saying that previous governments had done a lot of injustice to Indian farmers. "Farmers received loans totaling seven lakh crores in 2013-14, whereas the Modi government at the center provided loans totaling 19 lakh crores in 2023-24." Shah Added.

"Before Prime Minister Modi came to power in 2014, the budget for farmers was only Rs 22,000 crore, while the Modi government's budget for 2022-23 is Rs 1,22,000 crore," Shah said.

He said that the production of cereals has increased from 323 million tonnes in 2013-14 to 665

million tonnes presently under the Modi government. The minimum support price for rice, wheat and millet has seen 68%. 62.5% and 68% rise in 2023-24 as compared to 2013-14.

Union Minister of Cooperation Amit Shah gave the statistics of how unfair the previous governments have been in the Minimum Support Price (MSP) in products. agricultural Shah claimed that "In previous governments, the MSP of rice was Rs 1310, while the Modi government increased it to Rs 2203, which is an increase of about 68 per cent, the MSP of wheat was Rs 1,400, the Modi govern-

ment increased it to Rs 2275, while the MSP of pearl millet (Bajra) was Rs 1250 was increased by the Modi government to 2500 rupees which shows an increase of 100 per cent."

Amit Shah was addressing the gathering at the inauguration program of India's 1st IFFCO Nano DAP (liquid) manufacturing unit at Kalol, Gujarat. Addressing the Gather-ing at IFFCO Shah said the Modi government has increased the budget by one lakh crore rupees, and the Modi government is continually implementing farmer-friendly actions."

In a bid to enhance India's self-sufficiency in the fertiliser sector, IFFCO's Nano DAP (Liquid) boasts an 8 % nitrogen and 16 % phosphorus composition, providing a cost-effective alternative to the conventional 50 kg bag of DAP, which is presently priced at \Box 1,350 for farmers.

IFFCO has registered for a long-term patent on its nano urea and nano DAP, according to Shah.

"Following the pandemic, Corona, when fertilizer prices increased in global markets, the Modi government did not impose additional burdens on farmers, in 2013-14, the fertilizer subsidy was 73,000 crores, which will increase to 2,55,000 crore rupees in 2022-23," said Shah. Shah said that fertilisers should be scarcely used but till the time there are no alternatives found, its dependency remains.

"The outlay for subsidy on fertilisers back then was □73,000 crore, which presently stands at $\Box 2,55,000$ crore. All this while keeping the prices of fertilisers unchanged," said Shah. He emphasised the im-

portance of transitioning from heavy dependence on urea towards natural farming. "If farmers aspire to embrace natural farming without compromising crop yield for three years, they can employ Nano urea and Nano DAP while incorporating cow dung into their farming practices, which encourages the thriving of earthworms. By following this approach, in just two years, you can seamlessly transition to natural farming without any loss in crop productivity," he said.

During the day, the Union Home Minister attended various programs, including laying the foundation stone for a sports complex in Gandhinagar and laying the groundwork for various development projects in Sanand.

Earlier, Shah also attended the 'Raas Garba' in Ahmedabad, Gujarat. Devotees worship Maa Durga's nine incarnations during the nine-day Navratri festival in order to obtain her blessings.

The scheme, PVTG Development Mission, will be a huge step towards the empowerment of tribals.

In the 2023-24 budget, this scheme was announced for improving socio-economic conditions of the PVTG. In 2021, the Modi government announced that the birth anniversary of revered tribal warrior Birsa Munda, who was born in Jharkhand, will be commemorated as the "Janjatiya Gaurav Divas.

According to officials, there are 75 PVTG in 18 states and Union territories living in 22,544 villages spread across 220 districts having a popu-

These tribes stay in scattered, remote and inaccessible habitations, often in forest areas and hence the mission has been planned to saturate PVTG families and habitations with basic facilities such as road and connectivity, telecom electricity, safe housing, clean drinking water and sanitation, improved access to education, health and nutrition, and sustainable livelihood opportunities, they said.

The mission will be implemented through the convergence of 11 interventions of nine ministries under a host of existing welfare programmes covering rural roads, rural housing and drinking. Some scheme norms will be relaxed to cover these remote habitations, an official announcement said.

The Union Terri-tory of Andaman and Nicobar Islands (A&N) cluster, located in the Indian Ocean, are a group of 572 islands in the south eastern part of the Bay of Bengal. These islands are situated close to Indonesia and Thailand. A&N is a Treasure house of Tribes, The Andaman and Nicobar Islands cluster are home to **5** Particularly Vulnerable **Tribal Groups: Great An**damanese, Jarwas, Onges, Shompens and North Sentinelese.

A&N is of high strategic importance to the country from both economic and securistandpoints. A&N ty when fully developed will strengthen and enhance India's maritime capabilities multifold. These islands not only provide India with a key maritime space but also carry significant potential in shaping the strategic and military dynamics of the India in the Indian Ocean region. India's key maritime partners such as the US, Japan, Australia and France acknowledge and recognise the strategic location of the Andaman and Nicobar.

However, this all important UT island cluster has not received the importance it deserves. Environmental degradation is a major concern at present and hence, needs greater focus on sustainable development to flourish the island economy and also to ensure it provides and boosts India's defence capabilities.

In addition to the issues the local population face owing to the ignorance of the governments to implement tangible and meaningful development in this islands cluster. Added to these are the Illegal Migration and Smuggling. This UT Islands cluster faces greater challenges to their internal security through illegal migration from littoral and other states, poaching of marine and forest resources, arms and narcotics smuggling, majorly through uninhabited islands and natural disasters.

A&N islands cluster also has the history of Unsustainable **Devel**opment. Andaman and Nicobar have become a major tourist attraction, and this has resulted in many development projects being initiated in this region. While at one side it will transform the islands substantially, it would also cause loss of ecological stability owing to overcrowding of the island.

The Developmental activities are also impacting the coral reefs in the area, which are already under threat from warming oceans, and are of enormous ecological importance. **Environ**mentalists have already flagged the loss of mangroves on the island as a result of haphazardly planned development projects and underscoring the Geological Volatility. The Andaman and Nicobar island's groups lie in a seismically highly active zone. Due to this, the region is prone to a number of natural disasters.

Long neglected by previous government, now the islands cluster gets a boost from the current government. There are several key projects planned and being implemented. NITI Aayog's **Proposal for Little Anda**man calls for the development of a new greenfield coastal city to compete with Singapore and Hong Kong. NITI Aayog's another project for Great Nicobar that includes an international container transhipment terminal, an airport, a power plant, and a township also are in process. A&N's Airport has already been inaugurated and in operation. Others in progress, per reports.

Then there is also Japan's Overseas Development Assistance program where Japan had approved a US\$ 265 crore grant aid for Andaman and Nicobar Islands development projects.

All these are good to hear. But the ground reality is that the people of the islands cluster face innumerous problems affecting their daily life. Being a island cluster cost-effective and efficient transportation within the island and between islands is still a big issue. Despite being surrounded by vast sea, people do not have proper potable drinking water facility. Electricity to islander homes is a very big issue. Unemployment of the local youth have increased many fold, as the rampant corruption has allowed the outsiders from other states have penetrated deep and fanned the 'job for cash' trend. Local youths suffer as a result. Roads are still bad with hardly any maintenance.

These being so, as they are, rampant corruption in this island administration also has damaged the fabric of the social life of the local people. All previous island administration and the Central governments, MPs and local polity had all been ignorant to the issue of the people of this islands cluster, busy making money for themselves. Relief alas appears to have dawned on this islands cluster not.

A&N islanders now have an efficient and able administrator in their Chief Secretary Shri Keshav Chandra, a 1995 batch IAS officer, who has served in various departments in Delhi in different capacities. He received great appreciation for all his works in his previous stints, including his committed initiatives in his association with the Delhi Urban Shelter Improvement board. His is ready to listen to the people and the polity on the issues plaguing the island so that he could take actions to resolve them quickly. His people-friendly nature and his passion for doing good for the people is making him to be the most liked performing top bureaucrat of this remote UT island cluster.

Officials On Payroll Of Polluting Factory? Bityanil For Allowing Pollution?

The Puducherry coastal region in the recent years faces a severe threat due to unplanned and uncontrolled disposal of wastewater and had a serious issue on the rapid increase in the pollution levels.

It is alleged that Vaigai Industries in Karaikal is the culprit in polluting the air and water resources and devastating the cultivable soil that has been poisoned badly making the cultivable land slowly turning into barren uncultivable land. The farmers and people of the villages constituting the entire land area of and around this highly polluting factory are deeply worried, their income almost gone owing to not being able to generate any farm produces and are naturally up in arms. Disposal of municipal wastes, industrial wastes and waste generated by numerous recreational and commercial activities had degraded the quality of coastal water and also caused a serious health hazard to marine biota's and in returns to human. Moreover a multitude of anthropogenic impacts are attributed due to accelerated coastal settlements and development of small-scale and largescale industries, expansion of harbors and tourism related activities in the coastal zone. Experts say, to understand the pollution level in the coastal zone, it is required to assess the level of coastal water pollution both spatially and temporally, in order to make further recommendations for safe disposal of wastewater.

The main source of pollution in the identified estuaries and coastal belts of the Puducherry coastal region are mainly due to direct discharge of untreated industrial effluent and domestic sewage at various points along the coast. Vaighai Chemical Industries Limited in Karaikal, a unit of the Vaigai Group based out of Tamil Nadu, operates a chemical manufacturing plant that produces the dangerous and highly polluting chemical, Potassium Chlorate, operating in Melakasakkudi Vadapadi area next to Nedungkadu. This chemical unit manufactures and or supplies several chemical components as raw materials for use in match sticks, firecrackers and explosives. The very location of this manufacturing plant created controversies. There was strong opposition to its location in the middle of the village. Nothing happened and the factory units stayed where it started owing to its big clout with the political bosses and of course the play of money power. Following incidents like boilers exploding and catching fire in this factory, there have been several serious allegations that the factory's hazardous and other wastes are now being released into the canals that irrigate the agricultural lands, without being properly treated per chemicals safety and pollution control norms.

The dangerously heavily polluted dark brown coloured untreated Aqueous effluent waste from the plant process along the northern meridian is being deposited inside the factory premises, waiting for the arrival of the monsoon season. They are never treated, cleaned and disposed off safely and properly immediately upon their generation in the factory manufacturing process. As the monsoon sets in, the plant opens this stagnant hazardous waste secretly and indiscriminately to mix with the rain water and flow into the drains. The public is complaining about the color of the water in the drain as this untreated hazardous waste is being opened from time to time into the drain during the rainy season.

Independent of its location, it is utmost necessity that the plant waste be properly treated and disposed of safely and securely. The government granted permission to the plant with conditions that included prioritized attention to the safety of health of the workers of the plant and the people inhibiting the area. But, as it is to be understood, the plant never followed any safety guidelines or norms properly. It also did not ensure safe and secure disposal of its factory wastes, all of which were very hazardous in nature. Coming to the details, the said industry is the supplier of the dangerous raw materials needed for the match sticks. firecrackers and explosives industry that flourishes in locations like Sivakasi and other locations throughout India. Of the semi-finished raw materials that this company produces for the firecrackers and match box making industry, among others, while Chlorine is locally

produced and Potassium is locally purchased, the key ingredient Ammonium is imported. It is alleged that the company imports large quantities of this ammonium component from foreign countries and that most of the materials pass through customs without paying proper import duty, naturally with the connivance of few corrupt customs officials, with support from local polity. Customs duty evasion it is alleged, makes the import of this dangerous chemical too easy for the company to continue its money games using this factory, not mindful of the environment destruction they are fanning in the area. It is alleged that the Director of the company was camping at the factory, since complaints of high pollution and other issues were being raked in by the people of the villages to ensure no untoward actions are taken by the concerned departments that might lead to closure of the unit that is making very huge profits for the company. The department officials had taken note of the critical pollution issues being faced by the local farmers and the p population and fearing violent protests, the department recently hoodwinked the people by sending, of all departments. Revenue department officials team to visit the factory recently. Everyone knows how and what the Revenue officials will and can do. It is alleged that these officials were greased by the Director and senior management of the factory and served them a delicious meals that included the

expensive Biryani, among other to name. Once this pleasing ceremony of the officials was completed, the Revenue officials team left. Naturally they cannot take any action as this is not their responsibility.

It surprised and shocked the people that why the administration did not send relevant teams from their Pollution department, Agriculture department and industries department as the issues are related to polluting the land, water and air of the area? Everyone knows, it is alleged that the polluting company bribes the officials of all these department and that's why the factory doing its roaring flourishing business despite having destroyed the land, air and water resources of the area by polluting them all beyond normal solutions. It is alleged seriously that all the concerned officials and departments are under the payroll of this dangerously polluting factory and that is the reasons why no serious action is taken against this dangerously polluting chemical factory that is not following even the minimally scribed norms nre

It is only natural for a FMCG behemoth with Rs 7000 Crore in cash reserve to look for acquiring brands that add further value to its existing brands and item categories. Dabur also Dabur Ltd, an Indian multinational consumer goods company, founded by S. K. Burman, manufactures Ayurvedic medicine and natural consumer products, and is one of the largest fast-moving consumer goods (FMCG) companies in India. Dabur derives around 60% of its revenue from the consumer care business, 11% from the food business and remaining from the international business unit.

The current chairman, Dr. Anand Burman, and vice-chairman Amit Burman, are part of the fifth generation of the family. They were among the first business families in India to separate ownership from management, when they handed over the management of the company to professionals in 1998. In 1997, Dabur set



up a wholly-owned consumer goods subsidiary called Dabur Foods under which it launched its fruit juice brand called Real. In 2022, Dabur acquired a 51% stake in the Indian spices company Badshah Masala for [588 crore.

Dabur off loaded its pharma business in 2003 and hived it off into a separate company, Dabur Pharma Ltd where the German company Fresenius SE bought a 73.27% equity share in the new pharma company.

With Rs 7,000 crore cash reserve, Dabur India is said to be looking for acquisition opportunities in the online space,

in healthcare and home & personal care segments and with several D2C (Direct to Consumer) brands operating in it, according to its CEO Mohit Malhotra.

The company is scaling its presence in the online space, which includes e-commerce channels and D2C business, where it plans to introduce more innovations under existing brands and through inorganic opportunities. "We are introducing innovations there. Those innovations are coming on the back of existing brands and these innovations will come on the back of some new brands that we might

launch or we are looking Dabur Red and Vatika, at an acquisition for a new brand," Malhotra told PTI. The company would pursue organic growth with new brand launches in skin care and premium skin care, and the rest would be through acquisitions. Malhotra added that besides acquisition, innovation is also very important, which not only attracts younger or new-age consumers but also grows the lifecycle of a brand. All the nine power brands of Dabur India, are slowly evolving, adding value additions to brands and also to systemize the huge consumer oriented business.

Dabur has nine power brands, eight in India and one in the overseas markets, which together account for 70 per cent of its total sales. They are: Dabur Chyawanprash, Dabur Honey, Dabur Honitus, Dabur PudinHara, Dabur Lal Tail, Dabur Amla, Dabur Red Paste, Real and Vatika.

Its juice brand Real's revenue is to grow to Rs 2,000-2,500 crore in the next five years. Besides, it has three Rs 1,000 crore brands Dabur Amla, which Danir expects to increase to Rs 1,500 crore. Dabur has 17 brands that are above Rs 100 crore but less than Rs 500 crore in size, said Malhotra while addressing the investor meeting last week.

Earlier this year, Dabur completed the acquisition of 51 per cent stake in Badshah Masala to enter the branded spices and seasoning market, making its total growing brands to 17. Now, Dabur is expanding Badshah to international markets targeting the international diaspora. Despite the controversies of Burmans thrashing black money overseas and its honey brand getting a negative report of sugar syrup adultration and a legal spat in a neighboring country on the name of one its brands and their current legal battle with the board of Religare, Burmans are taking the Dabur power brands to newer growth heights and looking anxiously to disrupt the supply chain innovatively, both online and offline to enter deeper into newer market and buyer segments.

Havells India In DRI Net

The Directorate of Revenue Intelligence conducted (DRI) а search operation at the corporate office of Havells India located in NOIDA, Uttar Pradesh.

The searches by DRI comes over alleged mis-classification in the import of heating elements by Havells India, a electrical goods manufacturing major in India. DRI acts as the lead agency to check smuggling and cases of commercial fraud.

Havells India has been accused of using methods to evade import levies and also rumoured to have been engaged in smuggling of key premium components for its India manufacturing unit, majorly to cut making costs so as to be able to compete in the local market with aggressive pricing of its finished products.

The DRI search was



conducted over "alleged mis-classification in import of Heating Element," the company said. Havells India, a major electrical goods and appliances manufacturer, Havells India stated that the impact on its financial and operational activities cannot be quantified at this time. but in a preliminary assessment, it is not expected to have a material impact.

For 2022-23, Havells India reported a revenue of Rs 16,868.38 crore.

The company has 15 manufacturing units and 90 per cent of the products sold in the country are manufactured inhouse. Havells India operates in the consumer electrical and appliances market with brands such as Havells, Lloyd, Crabtree, Standard and REO.

AAP MLA Caught In PMLA

Punjab AAP MLA Jaswant Singh Gajjan Majra was arrested by the Enforcement Directorate (ED) in a bank fraud-linked money laundering case. He was evading several summons sent by ED. Eventually, Majra was picked up by ED when he was on a public meeting event. The sources alleged that Gajjan Majra, a legislator from the Amargarh assembly constituency, had skipped multiple summons issued to him in the past and hence, was detained by the officials and then arrested after questioning. The central agency raided the MLA and some others in September last year as part of this PMLA investigation that stems from a March 2022 FIR filed by the CBI (Anti-Corruption Branch, Chandigarh).

The CBI FIR was registered against Tara Corporation Limited (TCL), renamed Malaudh Agro Limited on September 24, 2018, its directors Jaswant Singh (Gajjan Majra), Balwant Singh, Kulwant Singh, Tejinder Singh, their associates and other sister concerns in Ludhiana, Malerkotla, Khanna, Payal and Dhuri.

ED officials said they had seized mobile phones, hard drives and loads of Indian and foreign currencies and hundreds of discriminatory documents from multiple premises that were searched. It said the Bank of India's Model Town branch in Ludhiana had sanctioned a loan on cash credit limits aggregating Rs 35 crore to the company as against hypothecation of stocks and book debts on 23.09.2011 under sole banking arrangement. "On the basis of information available, an investigation was initiated against the above-said persons and their associates in order to ascertain the money laundering activities undertaken by them for laundering their proceeds of crime," the agency added.

Fraudsters do not spare even the most feared Lord Saturn, Shani. More than Rs 10,000 crores worth of temple lands now is encroached by political bigwigs and government officials in benami names it is alleged. They have been enjoying the temple property and earning income without paying any rent or lease to the temple for many years. Tirunallar 'Sri Dharbaranyeswarar' Temple, more popularly known as 'Tirunallar Saniswaran Temple', the most revered and the holly temple is dedicated to the deity Shiva, located in a village, Thirunallar of karaikal district of Union territory of Puducherry.

The greatness of the Thirunallar Saniswaran Temple is that offering prayers at this temple are believed to reduce the malefic effects of planet Saturn or the Shani Dosha as well as increases the positive effects of Saturn thereby help people benefit from great announces, challenges, and limitations. For over a thousand years, devotees visiting Thirunallar Saniswaran Temple have found their misfortunes and bad luck to decrease as this is the only temple in the world where Lord Shani is believed to have lost all his power to Lord Shiva. The holy tank named Nalan Theertham of this temple possesses healing powers literally and metaphorically. And devotees strongly

believe that a holy dip in the sacred waters of Nalan Theertham washes off all kinds of afflictions and misfortunes caused by their past karmas.

The temple has six daily rituals at various time slots, and four yearly festivals on its calendar. Mahasivarathri festival celebrated during the month of the Chittirai (March - April) is the most prominent festival of the temple for the presiding deity. Sanipeyarchi, Sani (Saturn) changes its rashi or position, is a 2 day long most prominent and popular festival conducted every 2.5 years years. Lord Sani (Saturn) is believed to change its rashi (zodiac) or position. This holly occasion witnesses thousands of devotees visiting the temple from all over the world. Thirunallar Saniswaran Temple is considered one of the 'Saptha Vidanga Sthalams'. Each idol or Murti in these seven temples has the Lord representing a unique dance form. The processional deity or Somaskandhar of Thirunallar Saniswaran Temple is 'Naka Vidangar' and the unique dance he performs here is 'Unmatha Nadanam'. Hence the place is also known as Nakavidangapuram'.

The temple has six daily rituals at various times from 6:00 a.m. to 9:00 p.m., and four yearly festivals on its calendar. Mahasivarathri festival celebrated during the month of the **Chittirai** (March - April) is the most prominent festival of the temple for the presiding deity, while Sanipeyarchi festival that occurs every 2.5 years is the most prominent for Shani.

Puducherry Hindu Religious Charities Depart-

ment does not respect the traditions, rituals and ceremonies of Thirunallar Saniswaran Bhagawan Temple. Devotees offer money in cash and other kinds of cashable offerings to the temple and the income received in the temple is very huge. Despite this, the devotees who come to the temple are deprived of even basic facilities. Of the thousands of devotees who come to the temple, if any suddenly fall ill, they have to be taken to the nearest city that is 5 Kms away. There is no ambulance services for emergencies. Allegations are that huge temple funds are being used to pay the salaries of Puducherry government employees. Devotees have long been demanding to start at least a small clinic near the temple for the elderly, heart disease, nervous tension and blood pressure patients.

Hundreds of thousands of crores are being looted in the guise of regular demotion, construction and renovation of temple properties. It is alleged that the contracts are awarded to the preferred contractors without tenders and paid using the income of the temple from devotees. It is alleged that the corrupt government officials appointed as Executive Officers, are misusing the discretionary authority to spend from temple funds for such wasteful construction activities, in lieu of huge illicit commissions from these contractors. Interestingly, it is also being alleged, that several employees are appointed directly under recommendations from local politicians as nominees, circumventing the employment rules and without considering their merit. Lakhs of devotees throng to the temple every day during the Sanipeyarchi occasion to bathe in Nalan Theertha Sarovar, light sesame oil lamps and worship Lord Shani. 48 days before and 48 days after the transit of Saturn are considered very holly and important and the devotees come in lakhs as waves of sea. Bandhakal Mugurtam is the most important event for this festival. Despite all the allegations, Dharumapuram Atheenam is trying its best to maintain the Shani Bhagavan temple is well. They have been managing this temple affairs for hundreds of years. Anything clean, efficient and good is never tolerated by majority government officials. It is only natural that the **Puducherry** Government **Hindu Religious Charities** Department, the government authority looking after the income and expenditure budget details of the temple, allegedly is blocked the clean administration of the Atheenam trust, to allegedly hide the illicit transactions and acts of its appointed Executive Officers who are the controlling authority for the funds of the temple.

It is being alleged that the Charities Department of the Puducherry government controls and operates the temple as a revenue-generating corporate entity, rather than as a place of sacred worship or a healing center. The income of this temple is never properly audited, it is alleged. The Chola kings who built this temple gave strategically located prime premium lands worth billions to the temple. This has been usurped by many people who sit as administrative officers in Shani Bhagavan Temple. The land of temple other than the constructed area is used for cultivation for regular funding of the temple management. But the government authorities have kept the temple lands without paying any money for paddy, urad, paddy and other commercial produces which are for the running of the temple.

Several hundreds of Hotels, Lodges, Prime Residences, Cottages, Pooja offering shops, and artifact shops have been built illegally around the temple, allegedly by encroaching upon the temple premises.

All these do not have **Karaikal Town Planning** (JTP - Junior Town Planning) approval. More than Rs 10,000 crores worth of temple lands now is encroached by political bigwigs and government officials in benami names it is alleged. They have been enjoying the temple property and earning income without paying any rent or lease to the temple for many years. are

mounting that the temple patrons and the temple officials were so complicit even in the ill-fated decisions of changing the rituals and event schedules. A supporter of local MLA Siva released an audio on WhatsApp, threatening Darumai Adeena Akayat Thambiran on his opposition to these decisions. Tension persists in Tirunallar as it is said that if the Saint Thambiran sits near the temple flag and offers prayers and prasad, his beard will be cut off. Strangely no action has still been taken to book the culprit. A public outrage has started against this open threat to the holly Highness.

Why the police is not acting on this open threat by a local goon of the local politician? What is the fear? The temple administration officer, local MLA, Siva, due to the hidden threats of non-working salaried employees, Dharmai Adeena Ordinance Thampiran Sri La Sri Kandaswamithampiran Swami did not attend the Shanibhagwan temple's Shanipairchi festival on the opposition to the rituals. As a result, the temple administrator, Arunagiri, and the priests poured the holy water on the bare ground that they had brought to pour the holly water, do Abhishekh, on the holly deities of the temple. Devotees coming to Shani Bhagavan Temple are naturally frightened by this incident. Many people are confused as to whether something bad will happen to them as the holy water was poured on the ground, starting with the Shanipairchi bandhakal mugurtam dispute. **Devotees believe that** this is the reason why the tragedy of removing Chandrapriyanka, who is a Virgo, and Rangasamy, who is an Aries, were removed from the position in the Puducherry cabinet. Devotees of Lord Shani are demanding that the Puducherry government intervene, book the culprits in the temple, charity department and polity fearlessly and reinstall the peace in the area and the holly rituals in the temple as it is being performed from time immemorial.

frauds and scams. However stronger laws are framed and tighter checks made, fraudsters find novel ways to evade paying taxes. Stronger the laws and tighter the checks at different levels, the fraudsters supported by their financial wizards and conniving officials find newer avenues to evade them, commit frauds.

Rs 20,124 Crore GST Fraud In 3 Months? This is what Finance Minister Nirmala Sitaraman admitted in Rajya Sabha way back in 2021. The government detected GST frauds to the tune of Rs 20,124 in just 3 months of it 'special GST drive'. A nationwide special drive against unscrupulous entities for availing and passing on Input Tax Credit (ITC) fraudulently on the strength of fake and bogus invoices was carried out at that time, when this whopping tax evasion fraud was detected.

Giving details of detection of GST Frauds from November 9, 2020 (Date of initiation of special drive) to January 31, Finance Minister said 2,692 cases were booked by the officers involving GST and or ITC frauds of Rs 20,124.19 crore. This is no small figure in such a short time that too found by government agencies themselves. The amount recovered during this special drive period was Rs 857.75 crore and 282 persons were arrested. Later during the same year, 2021, the MOS for Finance admitted again that the quantum of fraud between 2020-21 and 2021-22 (till July 2021) at Rs 56,805 crore. In another reply to another question in the parliament, then Minister of State for Finance Anurag Singh Thakur said the income tax department has detected undisclosed income of Rs 2,223.88 crore between April-December 2020-2021 fiscal. Searches were conducted on 250 groups between April-December, 2020, and total assets seized stood at Rs 6,500.78 crore.

These were government admittance in early 2021. We are now in end of 2023. What would be the status as on date? This means fraudsters would have looted to several lacs of crores by now! What has the govligence and vigilance agencies done to curb these frauds, book them, cease and attach their assets, as on date?

Recently, early this month, Dr Amit Mitra, a leading Economist and a former State Finance Minister and currently Principal Chief Advisor to West **Bengal Chief Minister Ma**mata Banerjee,, referred to the central government's shocking admission in the Lok Sabha that Rs 1.15 lakh crore of fraud have been detected from GST invoices between 2018-19 and 2022-23, all deducted just from GST Invoices. This is just the government detected amount on GST frauds! This is just the tip of the iceberg?

Goods and Services Tax (GST) replacing multiple tax regimes followed by the Central and State governments, majorly, Value Added Tax (VAT) or more popularly known as the erstwhile Sales Tax (ST) and Central Sales Tax (CST) was put in place from midnight of 01-Jul-2017. Both VAT and GST have the same taxation slabs. It is a comprehensive, multistage, destination-based tax: comprehensive because it has subsumed almost all the indirect taxes except a few state taxes. Multi-staged as it is, the GST is imposed at every step in the production process, but is meant to be refunded to all parties in the various stages of production other than the final consumer and as a destination-based tax, it is collected from point of consumption and not point of origin like previous taxes. In simple terms, GST is the digitized form of VAT. Since its introductions varying amendments were made to make GST as rational as possible and to make Indian Goods Tax regime compatible with the global trading processes. For instance, e-Way Bill, IntraState e-Way Bill, Reverse Charge Mechanism, **QRMP** Scheme and the likes to name a few that has evolved to make the GST more effective, simpler and the same time tighten the system to shoo away fraudsters and for faster detection of frauds. But all these are gone for toss in front of our great gambler fraudsters. Law breakers always

makers! Lacks of crores are being swindled day in and day out. Government is aware of everything that is going around, but plays complacent owing to black sheeps in the system, the corrupt officials who are part of the nexus gang: officials-fraudsters-polity.

Every day we hear about GST frauds being unearthed, running into multiples of hundreds of thousands of crores. 1.15 Lakh crore is the current updated GST fraud amount as admitted by the government itself!

Dr Mitra alleged that GST frauds are proliferating across the country, happening in each and every State, on one hand and on the other that MS-MEs are facing problems due to a web of regulations that is so overpowering for the MSMEs that they are on the verge of deregistering back to their informal status. Pointing to these concerning issues, Dr Amit Mitra urged Union Finance Minister Nirmala Sitharaman to convene a GST Council meeting on priority to discuss these issues. Like Dr Mitra, everyone is deeply concerned and annoved at the amount of the fraud amount, which would run into several lakh crores more, if those not yet detected but thronging in the system is added up.

The 'humongous' fraud taking place in the country and the suffering of the **MSME** in the current GST regime require a total rethink by the Centre and the GST Council on the structure and GST.

It was found 69,426 GST identification numbers verified during the last two months, 20,893 were found to be non-existent, and the amount of GST evasion detected in that period was to the tune of Rs 19.638 crore. It is to be noted with interest that out of the 1.4 crore businesses registered with GST, only 0.42 per cent of registered taxpayers were verified, which yielded the shocking 30 per cent non-existent and fraudulent registrations Dr Mitra added. In other words, since the inception of GST, year after year we have been helplessly watching massive fraud taking place in this porous GST system.

The economist also drew



the union finance minister's attention to the complex web of GST that has been thrust upon the MSMEs and said that till date 770 notifications have been issued. The rates of more than 400 items of goods and around 100 categories of services have been changed till date. How the government could expect that an MSME company would be able to keep track of these hundreds of notifications and changes and still cope with this gargantuan regulatory structure?

Though the intent of GST was to bring the informal sector entrepreneurs into the formal arena through a simple and transparent GST system, the unfortunate fact is that 90 per cent of the GST is contributed by large taxpayers who can cope with this complex web of regulations. Dr Mitra's concerns are fully justified. It is imperative that the GST Council meeting is convened immediately that exclusively focuses on these two big issues and quickly find holistic and sustainable solutions

to control frauds & simplify regulations, keeping the **MSMEs in mind.**

The Need of the current situation is to employ Information Technology progressively and by developing a robust risk profiling mechanism that be put in place immediately to identify and monitor the whole regime, supported by appropriate actions through more challenging reforms in the tax regimes of all categories and types.

When will all these tax frauds end? Slower reforms in phases are not going to solve issues? What is needed is strong political will for implementing challenging reforms in wholesome and quickly that should make fraudsters and conniving government servants' shiver in fear. Is it asking for more from the government in the general good of the Nation and the people of the country whose hard earned money extracted by the government in the name taxes is being siphoned out by fraudsters and scammers'?
