A well planned and Tech-wizards frauds gang orchestrated multi-crore financial scam is being coloured as technical glitch?

A whooping Rs 820 Crore clean sweep from UCO Bank's coffers in just 3 days, using IMPS Instant bank to bank online transfer mode. This is being viewed as suspicious mass IMPS (Immediate Payment Service) transaction where the customers were thousands of UCO bank customers who received surprised credits in their accounts, without the senders' accounts being debited. The question is if this is a scam by fraudsters, vengeance, play to test skills to hack and transact by ill-minded hackers or just another technical glitch?

Originally considered a glitch, technical error issue, that occurred in the Interbank Mobile or Immediate Payment System (IMPS), a 24/7 instant domestic fund transfer facility accessible through various channels, including internet banking, mobile banking apps, ATMs, and bank branches is now under investigation.

It has been alleged that during November 10-13 2023 a mindboggling 8,53,049 suspicious mass IMPS transactions took place in which an amount totaling Rs 820 crore was wrongfully credited, of varying amounts, to the accounts of over 41,000 UCO Bank account holders. These were against the said suspicious IMPS digital transfers from 14,500 different customer accounts of 7 private bank account holders, without their accounts being debited. These 41,000 **UCO** bank account holders are said to have received surprise credits of varying amounts in their accounts. As a result Rs 820 crore was lost by UCO Bank.

It is further alleged that this intricate network involved a staggering 8,53,049 IMPS transactions originating from 14,000 account holders across 7 private which were all shown as 'failed' transactions in the private bank holder accounts, while they were received as success in UCO bank system and wrongly credited to 41,000 UCO Bank account holders.

On November 15, UCO Bank filed an FIR with the Central Bureau of Investioraite at with the last of the state of the

gation (CBI) against two of its support engineers and other unidentified individuals. CBI took over on the complaint then on.

CBI conducted searches, in connection with Rs 820 crore suspicious IMPS transactions at UCO bank, at 67 locations in seven cities across Rajasthan and Maharashtra focusing on people who received the surprise money, withdrew instantly and used it rather than returning it to the bank. This second round of searches follows the searches those were conducted in December 2023 at 13 locations involving private individuals and UCO Bank officials in Kolkata and Mangalore.

CBI has stated that the search operations targeted the premises of suspected and or accused individuals, including private persons and bank officials, resulting in the recovery of around 130 incriminating documents related to UCO Bank and IDFC, some evidences in the form of 43 digital electronic devices including 40 mobile phones, 2 hard disks, and internet dongles, laptops, computer systems, email archives, and debit/ credit cards. Additionally, 30 suspects were also found and examined on the spot. CBI is hopeful that it will get to the bottom of this and almost sure most part of the amount would be recovered.

Numerous account holders have exploited this situation, making wrongful gains by withdrawing funds through various banking channels. Do you expect a guy to call the bank and ask them to take back the wrong credit in his account? No way. This is India!

Is this a technical glitch? This is what is being investigated. A staggering 8.53 lakh IMPS transactions. 14500 different account holders from 7 private banks first getting debited for an IMPS transactions they never initiated and then instantly the transactions showing as failed. But at the same time UCO bank gets the IMPS transfers and sets 41000 **UCO Bank customers to get** surprise credits? All these doesn't look like a technical glitch but a well orchestrated scam that has been given the colour of technical error to avoid getting caught instantly. It sounds more likely that just a team of devil technical wizards orchestrated this to benefit the chosen few, but amazingly has given the colour of a glitch by effecting surprise credits to close to a million UCO Bank account holders.

Several questions arise but remain unanswered. How will and how much time will it take the investigating agencies to scan the identity of close to a million account holders to identify the real thief gang? Even though total of 8 banks involved only UCO Bank, a government owned bank is singled out to bear the total loss? Why only UCO bank, that too when this bank's system was not at all involved in initiating the transfers? What would have happened if the customers accounts would also have been debited? Would the banks credit the wrong debits instantly? Unlikely! **CBI** engaging hundreds of officials on this search operations and investigations sounds an alarm bell signifving a possible scam using technology.

The Finance Ministry and the central and other financial and cyber and other investigations agencies should sit together often, track the modus operandi and find the loopholes those are being often used and evolve solutions right from early detection and stopping such frauds in the future. **RAJ NITI**

The Galwan Valley military standoff in 2020 highlighted the fragility of status quo and the urgent need for effective mechanisms to manage and de-escalate crises. Dr Jaishankar's remarks underscore the fundamental reality that the ongoing tension in Ladakh serves neither India nor China. Instead, it only perpetuates a cycle of mistrust and escalatory actions that undermine the prospects of peaceful coexistence and regional prosperity.

Central to Dr Jaishankar's statement is that the resolution of tension in Ladakh is not the conventional military posturing but needs a multifaceted approach. While maintaining robust defence preparedness is absolutely essential to safeguard national interests, lasting peace hinges only on cordial dialogues, mature diplomacy and mutual respect for territorial integrity. To put things in perspective, the Ladakh dispute has roots in history, with the main cause being an ill-defined, 2,100-milelong border. The Line of Actual Control (LAC) is the de facto border between India and China, but vaguely defined. Rivers, lakes and snow-caps along the fron-




tier mean the line can shift, bringing military forces face to face at many points, thus sparking a possible confrontation.

In this scenario, it is difficult to resolve the deadlock and ascertain the territorial boundary quickly. India's stance on Ladakh aligns with its broader foreign policy objectives, characterised by a commitment to upholding the principles of sovereignty, territorial integrity and peaceful resolution of all disputes.

By emphasising the importance of dialogue and diplomacy, India seeks to create an environment conducive to constructive engagement with all stakeholders. The External Affairs Minister's remarks also highlights the critical role of Pakistan in the regional dynamics. Pakistan's sustained support for cross-border terrorism and its destabilising activities pose significant challenges to regional peace and security.

Addressing the issue of terrorism is a prerequisite for normalising relations between India and Pakistan. As a responsible member of the international community, India advocates for concerted efforts to completely eradicate terrorism. It will also be a vital step towards promoting continued stability in the whole of the South Asian region.

Non-controversial, soft spoken and popular Bharatiaya Janata Party (BJP) leader Bhupendra Patel is the 17th Chief Minister of Gujarat taking over the mantle from Vijay Rupani in 2021. He is the Gujarat CM for the 2nd time since 2022, following BJP's record seventh consecutive victory in the state's Legislative Assembly elections, his first term being that in 2021 till date the state went in for the assembly elections in 2022. Gujarat CM Bhupendra Rajnikant Patel rose through the ranks to become the first Chief Minister from Ahmedabad, Gujarat's business capital and its largest city. He fought his first major election in 2010 as a Corporator from the Ahmedabad Municipal Corporation (AMC) and went on to become the standing committee chairperson, before he went on to contest Assembly elections in 2017 in which he defeated Congress candidate Shashikant Patel by a huge margin of over one lakh votes. He has since retained this seat since then. He was the surprise but unanimous choice of the Prime Minister Narendra Modi and the legislators, as he has not been embroiled in any major controversy in his career.

Holding a diploma in civil engineering, Patel was in the real-estate and construction business for the last 25 years. His sonin-law runs a construction company. Patel started out by running a shop selling firecrackers in Dariapur in Ahmedabad's walled city area and won elections from the Memnagar Nagarpalika in the 1990s, the area now a part of Ahmedabad Municipal Corporation limits. He rose through the ranks to become the first chief minister from Ahmedabad, Gujarat's business capital and its

largest city. Patel, 60, won the Ghatlodia seat, part of the Gandhinagar Lok Sabha constituency, with the highest margin of 1.92 lakh votes in the 2022 elections. He is popular Rashtriya Swayamsevak Sangh (RSS) activist and had been a known face in people welfare activities. He is the trustee of Sardardham Vishwa Patidar Kendra and Chairman of the standing committee of Vishwa Umiya Foundation. He is a follower of Akram Vignan Movement founded by Dada Bhagwan.

A low-profile BJP leader and the first from the Kadva Patidar sub-group to become CM. Patel, who was then a first-time MLA, replaced Vijay Rupani in September 2021 in a surprise move. This was seen as part of the party's larger plan to carry out institutional changes across the different levels of leadership in the state before the 2022 elections. The Patidar community, which forms BJP's core vote bank, was seen as drifting away from it over the last few years. The 2015 Patidar agitation, which led to Hardik Patel becoming a significant leader, was also seen as a sign of the community's dissatisfaction with the BJP. Bhupendra Patel hence became the fifth Patidar leader to become CM, after Anandiben Patel, Keshubhai Patel, Babubhai Patel and Chimanbhai Patel. In 2022, CM Patel launched a new Gujarat IT/ITeS policy 2022-2027. His government also became the first state to set up a committee to study modalities and implementation of Uniform Civil Code in the state, applying the same to the citizens of the state.

Under his Chief Ministership, Gujarat rose further to become one of most favoured foreign investment-friendly destination. Gujarat now boasts of several mega industries that is boosting not only the State's but also the nations' economy. A cricket enthusiast. Patel has been spearheading the sports infrastructure developmental programs as Gujarat prepares itself to bid for Youth Olympics 2029 and Olympics 2036 which has remained the key focus of the Chief Minister who has been chairing several high-level meetings as he doesn't want anything left to chance as the State bids for these two prestigious global sports events. The CM also has been pushing hard for setting up a 'knowledge and sports corridor' in three different locations in Ahmedabad.

Prime Minister Narendra Modi recently announced in Chennai that the Centre was working on hosting the two Olympics. The Youth Olympic Games are a multi-sports event for athletes from 15 to 18, modelled after the Olympic Games. It is only natural that CM Pateel doesn't want to miss this opportunity that will also trigger all round fast-paced development of the State.

The incidental CM has skirted controversy and gained public acceptance with his easy accessibility, cordiality with all including the opposition party leader and his no-nonsense working style. Gujarat CM Patel's working style with strong will to resolve complex problems quickly has made him a very popular leader in the party and among the people of Guiarat. He has also been touring extensively to connect with the people and the party workers ensuring quick solutions even to complex issues.

Patel now has the huge responsibility to shoulder to help BJP garner all of the 26 Lok Sabha seat in the crucial 2024 general election where Prime Minister Modi has set a target of 400+. **UT AFFAIRS**

This announcement came hours after Congress Leader of Opposition in Lok Sabha Adhir Ranjan Chowdhury said

that the two former IAS officers have been given the positions. Gyanesh Kumar and Sukhbir Singh Sandhu have been appointed in the place of Anup Chandra Pandey and Arun Goel. Pandev had demitted office on attaining the age of 65 years, while Goel resigned suddenly in a move that surprised many and necessitated the expedited appointment of the two new **Election Commission**ers. It was critical that the Election Commission has all three members in their respective positions, as the Lok Sabha elections are around the corner. The poll panel is headed by Chief Election Com-missioner Rajiv Kumar. Sources said the **Commission is likely to** announce the dates of the Lok Sabha polls on March 15 or 16.

The appointment of the two new Election **Commissioners** came after a meeting was held of a three-member high-level selection board led by Prime Minister Narendra Modi. Adhir Ranjan Chowdhury was one of the three members of the panel appointed to pick the poll

The local BJP unit of Chandni Chowk has been offering support to Pakistan refugees housed in the Delhi Refugee camps who were moved to these camps 13 years ago when **Congress government was** in power. Surprisingly the local AAP MLA and their party workers were missing from relief works in these camps even during the trying Covid pandemic times, BJP alleges.

After the Aam Aadmi Party's allegation that the Central Government is trying to bulldoze the houses of Pakistani Hindu refugees in the National Capital, Delhi BJP President Virendra Sachdeva said that it is regrettable to see AAP leaders including Minister Saurabh Bhardwaj indulging in "dirty politics".

"In an order, the Na-tional Green Tribunal (NGT) had ordered long ago removal of encroachments on the river bank south of Gurdwara Mainu ka Tila but with a humanitarian approach, the concerned wing of DDA delayed it. When removal became inevitable the DDA issued a notice of removal but in the notice, it offered Pakistan refugees temporary alternate accommodation against **BJP efforts and interven**tion of the LG," he said.

Byju's Shuts Shop

Bangalore: In a surprise and drastic move Byju Raveendran, the founder and former CEO, has shut Byju's chain coaching centres across the country, except for their Head Office at IBC Knowledge Park in Bengaluru, where over 1,000 employees work. All other office premises across the country have been vacated by the EduTech giant. **Employees at Bengaluru** headquarters and the 300 Byju's tuition centres will continue by working from home.

Byju's said the decision has been taken to address imminent liquidity crisis. The process has been going on for the past few months as the company did not renew several of its contracts for offices across cities as a way to cut costs. The closure of all offices across the country is said to be a decision of Byju's India CEO Arjun Mohan's restructuring strategy endorsed by Byju Raveendran. Byju's has been facing a crisis and has laid off thousands of employees in the past year. It has also defaulted on paying the full salaries of its employees for the month of February 2024. It released a part of the salaries and promised to pay the rest once it is able to use the funds from the rights issue.

EduTech firm, The once valued at over US\$20 billion, has been suffering massive losses with over 90% downgrading in valuation. Byju's has lost key investors. Even its auditor Deloitte resigned over concerns regarding corporate governance, as well as a legal dispute with lenders in the United States. Raveendran is locked in legal fights with several of its lenders in the US amounting to over a \$1.2 billion in loans alone. Raveendran, once touted to be the poster boy of India's EduTech start-up ecosystem, who witnessed a meteoric rise before his swift fall owing to the ongoing crisis, has been under fire for the firm's phenomenally dipping fortunes. The Edu-Tech company has been facing financial challenges, including cash-flow issues and several disputes including those with its creditors.

The embattled Edu-Tech company has been in a legal tussle with its investors regarding the legitimacy of funds raised from a recently completed rights issue offering. The company's major stake-

holders recently voted to remove Byju Raveendran from his position as chief executive officer (CEO) and strip him of his authority. Byju Raveendran, the founder and former CEO, has faced a loss of support from key investors following a series of crises.

However, Byju Raveendran has contested this decision, claiming that the resolution was passed during a meeting attended only by a "small cohort of select shareholders" and asserted that the resolutions from the extraordinary general meeting were invalid and ineffective. Raveendran, a former engineer, an Indian entrepreneur, investor and educator who, with his wife Divya Gokulnath, co-founded Byju's against whom the **Enforcement Directorate** (ED) has been investigating various allegations. He is now facing the heat of an enforced travel restriction outside the country, as the Directorate of Enforcement (ED) seeks a 'look out circular' (LOC) against him, over alleged foreign exchange violations amounting to a whooping loot of ₹9,362.35 crore under FEMA. The move is aimed at preventing Raveendran, who has been frequently travelling between Delhi and Dubai for the past several years, from leaving the country till the investigations are completed.

The coaching Institutes' fees are sky high making it possible only for the richer to pursue them, as the more and most eligible from the weaker sections are left out to mend on their own with little success. It is just that these Institutes are looting the public.

Commercialization of education should not be allowed any time longer. It is time for the government to intervene putting an end to unjustified exorbitant fees by framing appropriate laws so that professional coaching becomes affordable to all, even to the weakest sections in the society. Though this is unlikely, with their political lobby so powerful, poor only can hope for pleasant changes in coming times should their destiny change spiking upwards ever.

There are only very few like the famous Khan Sir who appear committed to shaping the career of youth at most affordable prices despite using highend advanced teaching techniques enabling job avenues even to those from the lowest income groups. But such nationalist minded professional career mentors cannot cover all of the aspiring youth of the country.

It will only be right the greedy and the wrong-doers are punished halting their luxury run at the cost of the poor parents of the students who are wooed by such coaching centres.

Following the experiments on introducing "Open Book" exams which is still in pilot experiment process, continuing the reforms in the education system per the New Education Policy (NEP), The National Council for Educational and Research Training (NCERT) has introduced a new and revolutionary student assessment system, the Holistic Progress Card (HPC), aiming to transform and provide a comprehensive overall evaluation of students' progress right through the year including their performance at home as follow up of their school class studies.

Through this new 'HPC report card' students won't be evaluated just at the end of the year by teachers, but throughout the year. It will take into account the skills and competencies of students assessing various aspects of their learning including their communication skills, socio-emotional skills, cognitive abilities, and creativity, through descriptive forms of evaluation instead of only evaluating their academic qualities that is in practice in the current student evaluation system.

The HPC aligns with the National Curriculum Framework for School Education (NCFSE), aiming to make evaluation more learner-centric. The HPC promotes self awareness and self-esteem as Students would be engaged not in just evaluating not only their own performance but also that of their classmates. It diverges from traditional evaluation methods by incorporating inputs from classmates, and self-assessment by students and more so inputs from parents on their child's ability to do homework, follow lessons, and balance screen time with extracurricular activities at home.

In the new Student's Evaluation system, the Parents will play a crucial role in the assessment process, providing insights into a child's performance at home. Peer evaluation fosters collaboration and mutual learning among classmates, enhancing the overall learning experience.

Developed by PARA-KH, a standard-setting body under the NCERT, the HPC has been already designed for the foundational stage (Classes 1 and 2), the preparatory stage (Classes 3 to 5) and the middle stage (Classes 6 to 8), notes an Indian Express report. Work is currently on to prepare one for the secondary stage.

Following successful pilot studies in select states, NCERT has directed states and UTs to adopt the HPC according to their contextual requirements, to start with. Nearly 15 to 16 states, along with CBSE schools, have embraced this innovative assessment model. Plans are underway to digitise student records through the Vidya Samiksha Kendra platform, streamlining the assessment process. CBSE has adopted the HPC model for the foundational stage, categorising students into beginner, progressing, or proficient categories.

Workshops and consultations with state and central boards are underway for the development of the HPC for the secondary stage, which will also include board exams.

Prime Minister Narendra Modi Government's ambitious NEP reforms thrust is based on the **NEP committee formed** in 2017 headed by Dr K Kasturirangan who presented their recommendations in 2020. It is too good to see the most needed reforms in the educations sector that has only been following what the Britishers left behind as their legacy for the Indian educationists to follow, which was filled with flaws and not conforming to the cultural and mindsets of the majority people of the country.

However, caution has to be followed while proceeding with the NEP recommendations as one has to keep in mind the current school student duct which in itself needs a lot of reform to fit into the changing needs and global trends. It is good to involve the parents in the student evaluation system and also the student to assess those of their classmates. This may produce misleading inputs as many a students in urban area are unruly and the rural areas are still in the hands of the upper and the affluent. It is possible that the parents on their own give a wrong report or that the unruly ward himself pressurizes the parents to give a wrong report in his favour. There are also chances that unruly students may bully the able and sober students to produce favorable inputs in their favour.

While it is commendable and all should welcome the reforms in this sector, one should also follow caution in introducing the newer reforms keeping in mind the negative impacts on good and able students' community of the country.

Wayanad Fight Of Titans BJP Weakening

It's Rahul Gandhi vs Annie Raja in Kerala's Wayanad parliamentary constituency! Strange are Indian political games, 'Friends outside, foes inside'!

Rahul Gandhi, going by latest congress LS seat list, will sweat it out in Wayanad to defeat Annie Raja, the CPI National Executive Member, General Secretary of the National Federation of Indian Women and wife of CPI General Secretary D Raja. Wayanad voted for Rahul in the last 2019 LS elections with an astounding margin.

While it is a compulsion for the CPI to field its strong candidate in Wayanad that it got as its seat share from Left Democratic Front (LDF), for Rahul it is a safe winning seat choice, and now a prestige issue. The LDF candidate Annie Raja has already kick-started her campaign in Wayanad. She is unlikely to give up. Rahul is yet to be seen in the constituency, as the party feels he has already won the seat.

As two big names of the newly formed opposition grouping I.N.D.I. alliance bloc clash in Wayanad, Rahul has again come under fire from the LDF for choosing to pit himself in a seat where his main opponent is an alliance party candidate outside Kerala.

"We have announced our candidates and we are contesting to win seats because we need to be at the forefront of the fight against fascist forces. Now it is for the Congress to decide, they can put any candidate that is their right but we hope that good sense will prevail," Annie Raja said. Unfortunately, it didn't. Who is to blame?

CPI general secretary D Raja said that Gandhi and the Congress must seriously introspect about whom they consider their primary target, the BJP or the Left. Rahul Gandhi's stature is such that he should have fought the LS polls from any other seat, directly confronting the BJP, CPI leader Raja added.

But then, even in 2019,



Rahul had contested against a CPI candidate. The difference this time is, the LDF has fielded a well-known face. Wayanad is largely considered a safe seat for the Congress leader Rahul and it has been a citadel of the Congress party for sometime now. Earlier to Rahul, Wayanad sent Congress leader MI Shanavas to the Lok Sabha twice in 2009 and 2014. The parliamentary Wayanad constituency predominantly comprises of tribals, the marginalized and the minority communities.

In 2019, Rahul Gandhi was elected from the constituency defeating CPI's P P Suneer by a whopping 4,31,770 votes. The BJPbacked BDJS candidate Thushar Vellappally trailed behind to close as third.

IUML bats for Rahul. For the LDF's allegation, Indian Union Muslim League (IUML) leader and ex-MLA C Mammotty says that the LDF should have thought well before fielding a national leader like Annie Raja in a constituency where it is a cakewalk for the Congress. But the Wayanad CPI (M) district secretary P Gagarin contradicts saying the voters here feel let down by Rahul Gandhi.

Annie Raja, a native of Kerala, is a familiar face with the people here with her home nearby and easily accessible. Mammotty counters saying a national leader like Rahul Gandhi has ensured that he visited the constituency during troubled times of catastrophe or tragedy like the floods or man-animal conflict. CPI(M)'s Gagarin refuses to buy the argument. He says people voted for Rahul last time expecting him to solve the issues faced by the people. But in the last five years, he has failed to intervene effectively to solve the burning issues of the constituency, he added.

The man-animal conflict, night travel ban on Kozhikode-Kollegal National Highway which passes through Bandipur Tiger Reserve, railway connectivity and the livelihood issues of the tribals and farmers have remained unattended.

Significantly, in 2019, Rahul had managed to net an amazing chunk of LDF votes. Gagarin says this is not going to happen this time around as things have changed since then.

There are several other burning issues those could greatly spice up the contest this time. Interestingly, the **BJP** is yet to announce its candidate. BJP is slowly making inroads expanding its south footprints and no more can be considered insignificant. However, even if BJP is to field a tribal leader like CK Janu, Wayanad is likely to witness a no-holds barred fight basically between the two leaders of the same anti-BJP grouping, with 'coalition dharma' going for a great spin! Interesting would be, who will have the last laugh, Rahul or Raja?

BJP Weakening SECULARISM

Kerala Chief Minister Pinarayi Vijayan decried 'weakening secularism' in India, raising concerns over the "increasing attacks on secularism and minorities in India" and called the Kerala state a "safe haven" for minorities. Kerala Chief Minister expresses concern over minorities' experiences in India

Pinarayi Vijayan alleges some elements undermining diversity and secularism Says Kerala taking action to ensure equal justice and protection Kerala CM Pinarayi Vijayan stated that minorities in India are facing bitter experiences, and there is an increasing attack on the nation's sense of secularism. He expressed concerns regarding the "weakening secular nature" of the country and said that Kerala stands apart in this aspect. Condemning the use of religion for political purposes, he expressed concern over the erosion of the separation between politics and religion. The Kerala Chief Minister further accused certain elements of attempting to destroy diversity and asserted that minorities are not receiving their due share of progress.

In a bid to address these concerns, Kerala is actively taking effective action to ensure equal justice and protection for all residents, promoting an environment where living in the country does not pose particular concerns for any community CM Vijayan said during a face-to-face program with minority groups, projecting Kerala as a "safe haven" for mi-



norities. The Chief Minister was interacting with representatives of Muslim organisations, Mutavallis, Mahalla committee officials, Madrasa teachers, and students during the IN-SAF program organised by the Minority Welfare Department in Thiruvananthapuram.

Vijayan further stated it is unfortunate that in various states like Haryana, Chhattisgarh, Uttar Pradesh, and Manipur, minorities face attacks, insecurity, and their places of worship, houses, and commercial establishments are demolished using bulldozers.

CM Vijayan said that Kerala, in contrast, stands as a symbol of unity, bringing together people of different faiths without distinctions. He also alleged that efforts to demonise Muslims and other minorities as fifth-columnists and treacherous extremists are very strong in the country. Kerala CM Vijayan added that Kerala is the only state in India without communal conflict, attributing this harmony not only to the government but also to the people of the state.

Global Standard R&D

Kerala Chief Minister Pinarayi Vijayan urged higher education institutions to attain global standards in research. Chief Minister Pinarayi Vijayan stresses the importance of conducting a serious evaluation of Kerala's research standards to achieve global excellence. Rightly, the government's significant investment in the research sector over the past three years is viewed not as an expense but as an investment for the future. The government aims for thorough reforms in the higher education sector, with a focus on efficiency and student-centric approaches, including the introduction of a four-year degree course. Kerala CM Vijayan emphasised the need for a serious evaluation of the state's performance in achieving global standards in research. CM Vijayan noted Kerala's distinction as the state with the highest expenditure on student scholarships. He urged a critical examination of the state's inability to reach world-class research standards, emphasising the importance of internal excellence. He called for serious consideration and suggestions for addressing this issue. Keala CM emphasised the need for comprehensive reforms to align with changing times. He mentioned the upcoming introduction of a four-year degree course, which aims to make the education system at arts and science colleges more efficient and student-centric. CM Vijayan highlighted the global trend towards a multidisciplinary approach in higher education and stated that the government is actively working to prepare the youth for future challenges. He expressed a vision for Kerala to become a recognised hub of higher education nationally and internationally.

BJP RUINED Indian Economy

The leaders of the left parties, CPI(M) and CPI, in a joint rally at Jind in Haryana, urged the people to oust BJP that has destroyed the Indian economy in it's a decade of rule. The CPI(M) and the CPI accused the BJPled governments at the Centre and Haryana of ruining the economy, undermining democracy and threatening the age-old socio-cultural fabric of the country.

Addressing a gathering at the 'Badlav Sandesh Rally' in Jind in Haryana, which was jointly organised by the Left parties and attended by CPI(M) General Secretary Sitaram Yechury and CPI leader Amarjeet Kaur urged people to vote out the BJP in the upcoming Lok Sabha and Haryana Assembly elections.

The CPI(M) and the CPI on Saturday accused the BJP-led governments at the Centre and Haryana of ruining the economy, undermining democracy and threatening the age-old socio-cultural fabric of the country.

Addressing a gathering at the 'Badlav Sandesh Rally' in Jind, which was jointly organised by the Left parties and attended by a large number of people, including women, CPI(M) general secretary Sitaram Yechury and Amarjeet Kaur, CPI National Decretary and AITUC leader, urged people to



vote out the BJP in the upcoming Lok Sabha and Haryana Assembly elections.

CPI(M)'s Yechury cited the enactment of electoral bonds as a "shameless" example of legalising corruption through corporate funding quid pro quo. He wondered how the State Bank of India was made to withhold the details of donor companies defying the Supreme Court order. Yechury said the electoral bond "misdemeanour" was only one in a series of several other scandals, including demonetisation, Rafale deal and Hindenburg revelations. He added that the country needed alternative policies and not change of leaders alone.

CPI's Amarjeet Kaur made a scathing attack on the Modi government for "making the farmers and workers suffer with unprecedented unemployment, poverty and mounting miseries". She said 25% of suicides last year were by daily wage workers. Even workers of the Mahatma Gandhi National Rural Employment Guarantee Scheme were starved of their rightful job days. She emphasised the need for workers and peasants' alliance to oust the "corporate communal alliance" from power.

LEFT

The two leaders exhorted the people of Haryana to give a crushing defeat to the ruling BJP-JJP in the State in tune with the I.N.D.I. alliance call to "defeat BJP and save the country". They hoped that all secular and democratic parties, forces and individuals would come together and ensure that anti-BJP votes were not divided in the ensuing Lok Sabha election.

The Haryana State unit Secretaries of the CPI(M) Surender Singh and CPI's Daryao Singh Kashyap, accused the Khattar government of mindless privatisation of education, health, electricity and other public sectors leading to the highest-ever unemployment.

Kerala's Own OTT

Kerala government has launched India's first state-owned OTT platform Kerala Chief Minister Pinarayi Vijayan launched India's first government-owned OTT (Over-The-Top) platform 'CSpace' terming it as a decisive step in the onward journey of Malayalam Cinema. Inaugurating CSpace, managed by the Kerala State Film **Development Corporation (KSFDC). The Chief** Minister said that this is a pioneering initiative that gives prominence to films with artistic and cultural value without hurting the mainstream film industry. Kerala CM detailing on the initiative noted that earning profit is the prime motive of the private-sector OTT platforms that mostly go for commercial movies whereas the priority of CSpace, on the other hand, is to onboard and stream contents with artistic and cultural values and is set to make a mark as a medium that brings home quality films. This will also help the promotion of the Malayalam language and culture CM Vijayan said. The decision that CSpace will only stream films that are already released in theatres signifies that this is not a move that will harm the interests of the film industry. Its aim is to promote good cinema without hurting the interests of the producers and exhibitors, the CM said. Another distinctive feature of CSpace is transparency in its operations and the overall earnings, the profits from revenue share. KSF-DC Chairman and eminent film Director Shaji N Karun said CSpace is a novel initiative that seeks to help producers to get back their investment through crowd-funding route. KSFDC is a stateowned company entrusted with the promotion of Malayalam Cinema and industry, under the **Department of Cultural Affairs, Government of** Kerala. For selection of the content, KSFDC has constituted a 60-member curator panel including eminent cultural and film personalities. Every content that is submitted will be evaluated by the curators considering its artistic, cultural and infotainment merit, before showcasing it on the platform. A total of 42 films have already been selected in the first phase for streaming on CSpace, including 35 feature films, six documentaries, and one short film. Films that have won national or state awards and those exhibited at major film festivals will also be streamed. As such, the films that win state, national and international awards are to be streamed on the platform. The CSpace OTT platform, which operates on a pay per view basis, allows viewers to watch a feature film for Rs 75 and shorter contents for a much lesser price. Exactly half of the amount charged goes to the content provider. Viewers can download the CSpace app from the **PlayStore and the App Store.**

CAA Challenge To Humanity

Kerala Chief Minister Pinarayi Vijayan slammed Centre for notifying the rules of CAA, an open challenge to humanity and said that the law won't be implemented in the state.

Kerala Chief Minister Pinarayi Vijayan said that the decision by the BJP-led union government to implement the contentious Citizenship Amendment Act (CAA) weeks ahead of the Lok Sabha elections is aimed at 'dividing people, inciting communal sentiments and undermining the very basic principles of the Constitution' and declared that Kerala government will not implement them.

The Centre on Mon-

day evening issued a notification of the rules of the CAA, paving the way for its implementation across the country. The law aims to give citizenship to non-Muslim migrants from Afghanistan, Bangladesh and Pakistan who came to **India before December** 31, 2014. Warning that the Centre's move will unsettle the nation, the Kerala CM called for united opposition to the decision to stratify Indian citizens who have equal rights. "This can only be seen as part of the Hindutva communal agenda of the Sangh Parivar and the ruling BJP. It is a blatant viola-



tion of the Constitution to grant citizenship to non-Muslims who immigrated to India from Pakistan, Bangladesh and Afghanistan on or before December 31, 2014 and to deny citizenship only to Muslims. Indian citizenship is being defined in terms of religion. It is an open challenge to humanity, the country's traditions and its people," the Kerala CM said.

Similar to Kerala several other States also are up in arms against the CAA legislation. But there is nothing they can do. According to the Indian Constitution, states cannot refuse to implement the CAA as citizenship falls under the jurisdiction of the Centre and not the state. Also, speaking to India Today TV, legal experts affirmed that the implementation cannot be blocked by the state governments, and they would be left with "no option" but to implement the CAA in their

states. As such this is a central subject and the era of digital communication. Those who are eligible will have to apply in the prescribed format online and upload all the mandatory documents, again online. It is all digitized. Verifications are first based on online submissions. There is no State intervention in applying by the eligible per the CAA legislation.

This being so it looks like the Kerala government would again knock the doors of the apex court. This being passed legislation by the Parliament, it is to be seen how the apex court would handle the grievances of the states.

SP-Congress Tie-up



The Samajwadi Party and the Congress finally sealed a seat-sharing deal in **Uttar Pradesh for the** upcoming 2024 Lok Sabha elections ending weeks of suspense and bickering. As per the deal, Samajwadi Party (SP) and other SP allies in UP will contest on 63 seats while the Congress gets 17 seats, a climb down on Akhilesh part who originally offered 11 seats to Congress and refused to climb down then.

This marked the end of bitterness between the two parties which had resulted in Akhilesh Yadav not joining Rahul Gandhi's Bharat Jodo Nyay Yatra in the state. The differences between Akhilesh and Congress is rooted to the 5-State Assembly elections held few months ago. The squirmishes stooped down so much that Congress Leaders in Rajasthan and Madhya Pradesh called Akhilesh by unparliamentary lingua.

The SP had originally offered 11 seats to the Congress and later had increased the offering to 17 to ease the tensions and literally arrive at a deal, should the Congress be interested. However, the grand old party wanted three more seats and also dillvdallied their decisions. **Congress** leader and Rahul Gandhi's sister Priyanka Gandhi is said to have played a major role in sealing this deal with SP.

There are 80 Lok Sabha seats in Uttar Pradesh. In the 2019 Lok Sabha elections, the Samajwadi Party had tied up with the Bahujan Samaj Party and had won 5 seats. The Congress, on the other hand, could win just one seat, Rae Bareli that was retained by Sonia Gandhi.

In a huge setback, the grand old party lost even in its bastion of Amethi where Rahul Gandhi was defeated by BJP's Smriti Irani. What would also worry the Congress is the further sharp decline in its overall vote share in the state. The Congress vote share in 2019 was 6.31% while in 2014 the party got 7.47% of votes.

The Samajwadi Party also saw its vote share decline to 17.96% in 2019 Lok Sabha elections from 22.18% in 2014. Akhilesh Yadav has already lost a key partner in the state with Jayant Choudhary's Rashtriya Lok Dal all set to join the BJP-led NDA. While the formal announcement has not been made by either side, Jayant had confirmed the move after PM Modi announced Bharat **Ratna for Chaudhary** Charan Singh.

All well that ends well is the saying. With this poll seat share deal there at least wouldn't be any vote split of these two parties among their own voters at least, as **BJP-NDA** rides high in their popularity in the State where Prime Minister Narendra Modi and CM Yogi Adityanath popularity are only rising with no anti-incumbency sentiments.

MORE BSP EXODUS

Ahead of the forthcoming 2024 Lok Sabha elections due in just two months, more Bahujan Samaj Party (BSP) leaders are crossing over to greener pastures, apparently leaving BSP supremo in disarray. It is a double whammy of sorts for Mayawati as one more of her MP left her to join BJP and yet another MP ready to leave anytime soon. But BSP supremo Mayawati is not disturbed at the exodus.

Bahujan Samaj Party (BSP) supremo Mayawati has once again confirmed that her party would contest the upcoming Lok Sabha elections independently on its own strength with complete preparation and strength while refuting rumours of the party forming any electoral alliance. In such a situation, spreading rumours about forming an electoral alliance or third front etc is fake and wrong news she tweeted recently. She further reiterated that in the interest of Bahujan community, BSP's decision to contest the elections alone is firm. It is only natural that the opposition parties to BJP are seriously worried and restless, as Mayawati refused to be wooed by them in their quest to halt Prime Minister Narendra Modi marching to his 3rd straight term and are already morally down as BJP launched its dream run with the opposition shuddering 400+ aggressive campaign.

Bahujan Samaj Party (BSP) MP Ritesh Pandey resigned from the primary membership of the party and joined the BJP recently in the presence of Uttar Pradesh Deputy Chief Minister Brajesh Pathak and other senior leaders. Pandey is an MP from the Ambedkar Nagar Lok Sabha constituency.

He was diplomatic while speaking on his cross over. Pandey said he had worked for the BSP for the last 15 years and did not want to comment on the "thinking and activities" of party supremo Mayawati.

Incidentally and interestingly, Pandey was one of the eight MPs with whom Prime Minister Narendra Modi sat down for a 'surprise lunch' in the Parliament canteen earlier this month. The MPs and the Prime Minister ate vegetarian thalis and ragi laddus during the surprise lunch during the Lunch meeting.



Pandey has represented the Ambedkar Nagar constituency since 2019. He was also a MLA from Jalalpur between 2017 and 2019 before he was elected as an MP. In a development, similar according to political sources, BSP MP from Jaunpur Shyam Singh Yadav is also likely to cross over, not to BJP but to join the Congress as he is slated to attend the Bharat Jodo Nyay Yatra.

The latest developments came almost a week after BSP supremo Mayawati dismissed rumours of forming a coalition ahead of the Lok Sabha elections.

She affirmed that her party will contest the upcoming elections independently. BSP Chief Behen Mayawati had already announced that she would have no truck with any of the parties and that BSP would be fighting the Lok Sabha elections alone across the country wherever it has its presence.

UP is the main bone of contention that returns nation's largest number of LS MPs, 80 LS seats. Worries of the **Opposition, especially** of Rahul's Congress and **Akilesh's Smajwadi Party** (SP), on Mayawati deciding to fight the poll battle all alone are natural. They know her vote bank strengths. They also know that BSP would cut across into their vote banks seriously, advantage BJP. They are all restless.

There is no denying that Mayawati has her own dedicated and loyal vote bank who never cross over to other parties ditching her. This is her strength of having built the confidence of her vote bank in her and her policies and of course her capabilities to champion their causes. **24 AKBAR ROAD**

Then there is the disturbing exodus of senior and experienced leaders from the Congress from different states and central command circles. With leaders switching political parties, and political parties switching alliances, the opposition bloc is already facing a major hit in the forthcoming Lok Sabha polls.

In this scenario, what more could the Congress do to defeat the BJP and become a game-changer in the general elections? Well this is for the political pundits and the media to analyze what next for the Congress, but not for its leader Rahul Gandhi who is going solo unhindered with no signs of any type of concerns in his mind and face to read from. That is all about Rahul Gandhi who literally appears not bothered at all on what's happening in his party and if he is aware that the LS polls are just few weeks away? Yes he is aware, undoubtedly.



Ration Card issuing system in the UT of **Punducherry** is the new green pasture target of the wrong-doers. Interesting are the ways how cleverly some circumvent, bend or ignore framed laws, rules and guidelines and accepting forged and fake documents to mint money fearlessly in several hundred crores in short time frame, that too without getting caught. Agents Raj continues in the UT of Puducherry even after so many checks and monitoring with the connivance of few fearless thick skinned unscrupulous government servants in the Department of Civil **Supplies and Consumer** Affairs that is responsible for the PDS in the territory.

The Public Distribution System (PDS), initiated by the Food Corporation of India (FCI), aims to ensure food security and adequate nutrition for the Indian population. The key to this system is the Ration Card that holds utmost importance.

The Department of **Civil Supplies and Con**sumer Affairs (DCSCA) has been designated to implement the PDS in the Union Territory of Puducherry. This department is responsible for providing the timely distribution of essential commodities like wheat, rice, sugar, pulses, kerosene oil, etc., at subsidised rates. Individuals holding valid Puducherry Ration Cards only are eligible to purchase these food items at subsidized low The colour of prices. the Ration Card that issued after severis checks including al personal verifications defines the eligibility criteria of the defined target and the prices of the commodities in the PDS. Ration card is a vital multi-purpose document that entitles the resident of a state to obtain essential goods at highly subsidised rates through the Public Distribution System (PDS). Ration card helps to efficiently implement the **Targeted Public Distri**bution System (TPDS) and the provisions of the National Food Security Act (NFSA). It also helps to ensure food and social security. Ration



cards also are considered as identity proof of the head of household along with details about all of the family members with their name, age, relationship with the head of the family, gender, income levels, etc. and further also serves as a proof of one's residence. It is annoying while it is also mind shattering to know how these all important government issued cards are issued to non-bonafide residents just to loot the government exchequer, as apart from food and other hosehold supplies certain target groups also get cash assistance through Direct Transfer System! Puducherry government issues five different types of cards based on annual family income, AAY, Red, Yellow, Green and PHH. It is the Red Ration Card that is most misused as it is linked several free and low price items benefits in addition to cash assistance at special times. Red Cards are for the economically weaker families who earn Rs 15.000 or less annually, Green Cards are for the families with annual income more than Rs. 1,20,000, Yellow Cards for families whose annual income is greater than Rs. 15,000 but lower than Rs. 1,20,000, Antvodava Anna Yojana (AAY) for the specially identified most economdisadvantaged ically households. These apart there is a PHH Ration Cards for Priority Household households, which are given special consideration in government programs.

AAY Ration Cards issued to beneficiaries falling under the government' AAY program, specifically targeting the 'most economically disadvantaged households'. Under this catthe program egory, focuses on providing essential commodities to the poorest of the poor, which often referred to as BPL (Below Poverty Line) Ration Cards. AAY cardholders receive 35 kg of food grains per month, mostly at far low heavily subsidized prices.

Of all it is the Red Ration Card that has now come under severe criticism and pointing to a greater 'easy to do' PDS card scam that allegedly runs into several hundred crores in a short time span with the booty split from top to bottom of the unscrupulous within this division in the administration.

It is being alleged that the DCSCA issued over 50000 Red cards, either new or downgraded from Yellow and Green cards, that too in just 3 months, to those who were not entitled to using false declarations and fake or forged documents. It is alleged some top notch government servants are involved in this scam, allegedly taking bribes for making this interesting card that allegedly runs into several hundred crores.

It is being alleged that anywhere between Rs 3500 to Rs 10000 are taken as bribe to make this card to those who are not entitled to. It is also being alleged that these red cards have been issued to the affluent families, who have made these cards in greed to grab the freebies and subsidized items through the Fair Price Shops (FPS) in the PDS. Not just this, but bribery goes into the FPS system as well so as to favour certain select strong and affluent owners FPS, who play along with the games of some unscrupulous DCSCA officials. Buy why the Red card? It is understable from the sleu of benefits, priorities and subsidised items which are available only to the **Red card holders.**

Latest statiscs has shocked all. Of the near 3.60+ Lakh cards issued to Puducherry families, over 2.05+ Lakh are Red cards, while the AAY cards number just around 25000. It is alleged that the alleged scam involves not only the officials from the DCSCA, but allegedly also several officials from SQUAD division who weild huge powers in authorsising the entitlement. Honest staff in the department say that when previous Director Shaktivel and Additional Director Ravichandran were at the helm they were strict and had sternly warned all that appropriate ration cards pwer factual entitlement only should be issued and there was strict vigil on wrong-doers both within and outside the department that was ruled by officials favoured Agents. They were insistant that Red card should be recommended only after a personal visit and assessment on rightful entitlements of families that they are all really poor and economically weak requiring government assistance.

Those days are gone people say. It is being allged by botht the people and the honest in the department that no work of any nature of the public gets done, allegedly without paying a bribe to the unscruplous government servant.

It is being seriously alleged that just one top official in the concerned department alone, along with his accomplices, had pocketed several crores for converting yellow to red cards in addition to issuance of new Red cards. It is shocking to note that allegations are being made that this top official alone makes over 2-3 Lakhs a day. Even though majority dealings are in hard cash, people and the honest say that even a simple investigative audit or just by scanning their **UPI-linked accounts of** digital-pay platforms like Gpay, PayTm, PhonePe to name a few and also a close scrutiny of their phone call records should easily support these allegations. Most interestingly apart from the most favoured outside independent Agents, even several officials through benami names and chosen outside individuals act as Agents to pocket the entire bribe money, it is being alleged. It is alleged that even a Superitendent rank official is minting money in several thousands a day.

There are allegations that even several in the Squad & Levy Section team are corrupt and favouring chosen FPS owners with abundant quality supplies. The squad section is functioning with one Tahsildar and one Deputy Tahsildar with the assistance of Civil Supplies **Officers and Inspectors.** They are vigil about the movement of the PDS commodities and seizure of articles illegal transportation of PDS items. When this system itself becomes corrupt can the public expect anything more ill where their interests are grossly compromised.

These are just alletions? The statistics doesn't subscribe to anything otherwise. When will the Administration take effective action to book the culprits and halt these corrupt practices? With an effective and able Chief Secretary to support will the **Pondicherry Chief Min**ister take note of these irregularities and initiate immediate corrective actions to assure the public and regains their confidence in him?

The recent 3 State wins just ahead of the forthcoming general elections impressively is a prelude to the grand 2024 finale that is to catapult Prime Minister Modi straight into his 3rd term should be read between the lines and the undeniable fact that this re-exposed the weak opposition. Massive BJP victory in these states signify Congress is in disarray.

P&S Bank 'Window Dressing' Scam

account manipulation irregularities effected in Punjab & Sind Bank has shocked the people, experts in the banking sector and also the stock market wizards. Punjab & Sind Bank (P&SB) is alleged to be manipulating its financials to artificially project a sound financial health. The bank allegedly orchestrated 'Window Dressing' a of its account holders during the third quarter financials of FY 2023-24. In a latest, P&SB is alleged to have indulged in stage-managed irregularities that had all the potential to trigger serious implications on the stability and integrity of the financial system affecting the interests of bank's retail shareholders.

Allegations are that the P&SB's CMD pressurized the employees to get the unutilised credit limits of loans of customers availed for a short duration of a week to artificially spike the bank advanced loans business transaction figures. As per audited results during the Q3 ending for the Financial Year 2023-24 the total business of the bank stood at followed by a second ₹2,01,914 crore inferred out of ₹83,559 advances and ₹1,18,355 Crore deposits. It is alleged that

Latest revelation of the unutilized loan limits were unethically shown as availed by transferring the available amounts in the sanctioned loan and other limits in customer accounts to customer's savings or current account as was applicable.

This orchestrated window dressing of accounts was to enhance the total of advances as well as deposits to tweak the health of the bank in the balance sheet. This is also to artificially make the bank appear healthy to spike its share prices in the market and also to upgrade its overall valuation, and possibly to show achievement of projected targets for the financial year.

To give shape to this window dressing irregularity initiative, the CMD's office of P&SB is said to have sent two eMails to all its branches and zonal offices. First eMail was sent on 27, December 2023 containing a detailed list of 89,565 account holder details spread over 1500 branches of P&SB, having unutilized loans and limits balance of over ₹50,000 amounting to ₹4,917.93 **Crores.**

This was, It is alleged, eMail of 29, December 2023 where progress of window dressing was sought and given in brief.

Additionally, it is alleged that majority Field Staffs were personally called and were advised to debit the respective Over Draft (OD) and Cash Credit (CC) limits of the loaned customers and credit these funds appropriately in Savings and Current Accounts of the same customers. This artificial stage-managed exercise resulted in artificial increase in advance and sanctioned loan utilisation figures of the bank customers. It is said that the CMD of the bank was desperately trying to cross the bank's business transaction figure of Rs 2 lakh Crore. Way back in January 2024 P&SB CMD Swarup Kumar Saha had said that P&SB is expected to cross the Rs 2 Lakh crore milestone on the back of robust growth in loans, adding that the 3rd quarter of 2023 the bank had witnessed good growth. He had added that Topline growth was in line with drawn out guidelines while other key parameters like asset quality and slippages were also under control. Financial Institutions operate in a dynamic and competitive environment. It is essential that they adhere to the highest standards of transparency and accountability. Any form of



manipulation or misrepresentation of financial statements undermine investors' confidence. erode public trust, and pose systematic risks to the overall financial health of the Nation's economy. The banks undoubtedly shoulder greater responsibility playing a highly significant role in creating a robust economy for the Nation.

The alleged window dressing at Punjab & Sind Bank appears to involve actions that may artificially improve the appearance of the bank's financial health and position in the market, potentially misleading stakeholders and regulators.

Such practices have the potency of far-reaching consequences for the economy. We need to have a robust and transparent financial system. Given the gravity of the situation, the need of the situation is for the Central Bank, regulators and the Finance Ministry to immediately intervene, initiate immediate and comprehensive investigations into these allegations, book the wrong doers and also halt such and other misleading actions of banks in their quest to project good health, spike share prices and hoodwink achieving the missed targets. The public have the right to know that their financial institutions are operating with highest global standard ethics and compliances. It is also imperative that the results of the investigations are made public to ensure transparency and to pin accountability.

₹150 Cr P&SB Guarantee Scam

People and the bank employees themselves stunned were and shocked when the Economic Offense Wing (EOW) raided Punjab and Sind bank branch in Indore, Madhya Pradesh. It has now come to light that the case pertains to liquor mafias and contractors, in which several hundred crores of rupees siphoned off the bank coffers in the name of bank faked bank guarantees and collaterals. EOW sleuths accuse bank officials of intentionally illicitly benefiting contractors and the liquor mafia lords against possible personal gratifications.

EOW had received information about faked, improper and or improperly verified bank



guarantees and collateral securities including documenincomplete tation, suspecting connivance of some unscrupulous Punjab and Sind bank officials.

The Economic Offense Wing suspects that there has been fraud bank guarantee scam touching at least a minimum of Rs 150 crore in the said Indore branch alone. Based on a tip off and and investigated information EOW raided Punjab and Sind Bank office in Rajbara, Indore.

Liquor contracts bids were held in February every year. For this, each contractor had to provide a bank guarantee of 12% before bidding and deposit the remaining amount in installments. But sever of the liquor

contractors participat- the liquor contractors ed, bid and bagged the contracts with bank guarantees issued by the bank on the basis of incomplete, fake and or unverified collateral and guarantee documents, after which many did not return the money which raised several questions and several complaints were filed with the EOW by unidentified persons.

Most of the contractors associated with the liquor syndicate have accounts in the Rajbara branch of Punjab and Sind Bank. The complaints were also that in many cases the bank guaranteed and issued documents guarantee exceeding the value of the property and other forms of bank collaterals and guarantees to

who all got the contracts for which they in reality were not entitled to and that huge amounts were bribed to the conniving bank employees to mete out this favour to them.

This is not an isolated case of such frauds and scams. There are several of them which come to the fore only when they are caught. Aggressive reforms, stringent checks, close monitoring are all good but only stringent laws are framed and implemented to book and heavily punish the culprits including ceasing of all their ill earned assets and stringent punishment including life term to death penalty could possibly deter people from even thinking of wrong doing.

Indian opposition not only is aimless and directionless, but also has become mindless. They are at a loss to understand and counter Prime minister Na rendra Modi and his formidable team's moves, strategies and absolute affiliation to nationalism where their thinking starts when and where others end.

Every component party of the new opposition grouping invariably are facing corruption charges against their stalwarts and are under the complex web knit by the central investigations agencies to book them one by one steadily and in a well structured phased manner has been plaguing each one of them. The opposition must listen to the people's concerns, offer concrete solutions, and demonstrate a genuine commitment to unity, now, not after the elections. This pretention must end. They should stop treating vot-

ers like idiots playing their games. The opposition has to offer the nation a credible alternative, or step aside for the able ones who can, like the current government and its formidable leader.

The fractured opposition presents a clear advantage to the BJP in 2024. Unless the coming months see wild dream of regrouping efforts which is unlikely as the time has run out, the new opposition grouping dream lies shattered, raising concerns about the ability of the opposition to function as an effective check and balance to BJP-NDA alliance. This political earthquake's aftershocks will resonate far beyond the upcoming elections, shaping the future of Indian politics in the years to come. However, the picture behind the closed doors is totally different. vietnam's largest nnancial fraud case got under way, with real estate tycoon Truong My Lan facing the death penalty. She is accused of being the mastermind in a fraud scam totaling US\$12.5 billion. The amount involved is equivalent to about 3 per cent of Vietnam's GDP in 2023.

Early March 2024, Vietnam's largest financial fraud case began, with real estate tycoon Truong My Lan risking a life term to death penalty.

According to investigators, Lan and her accomplices are accused of siphoning off 304 trillion Vietnam currency dong (US\$12.46 billion) from the country's largest bank, Saigon Joint Stock Commercial Bank (SCB). Lan effectively controlled SCB through dozens of proxies and is accused of swindling the cash.

This case is part of Vietnam government's anti-graft drive against widespread corruption in the country. The trial, expected to last until the end of April 2024 at the People's Court of Ho Chi Minh City, is part of a much wider campaign against corruption in the country which the leader of the ruling Communist Party, Nguyen Phu Trong, has pledged for years to stamp out, with no tangible results yet.

The anti-graft drive has led in recent months to multiple high-profile arrests and the resignation of top figures, including the country's former president last year, but the trial for the chairwoman of real estate developer Van Thinh Phat Holdings Group is unprecedented for its scale, with thousands expected to be summoned and about two hundred lawyers participating in the proceedings, according to state media.

Real estate tycoon Truong My Lan and her accomplices are accused of siphoning off 304 trillion dong (US\$12.46 billion) from the country's largest bank by assets, Saigon Joint Stock Commercial Bank (SCB), which Lan effectively controlled through dozens of proxies, according to investigators.

Lan has for years been a central figure in Vietnam's finance and orchestrated the merger of SCB with other two lenders in 2011 to salvage the troubled banks in a plan coordinated with the central bank. She owns several properties in Ho Chi Minh City's richest districts and has multiple assets overseas in prime premium locations, according to investigators and public information.

In addition to charges of embezzlement, Lan is also accused of giving huge bribes and of breaching banking regulations. Among the other defendants are Lan's husband, a Chinese national, and 15 central bank officials, including a senior inspector accused of taking bribes worth \$5.2 million from Lan.

Despite years of the anti-graft campaign, known locally as "blazing furnace", corruption remains widespread in the Southeast Asian country, leading many to question motives behind any arrest. In some provinces, up to 90% of applicants for land certificates paid a bribe, and kickbacks are also extremely common to receive medical services in public hospitals, according to a report published in March 2023 by the United Nations Development Programme and other organisations.

Bribe-taking amounts that would trigger citizens' denouncements ranged between 20 million dong (\$810) and 43 million dong (\$1,742) with the upper value being five times the average monthly salary in the country, indicating citizens' levels of tolerance of bribe-taking acts in the country.

For a country whose regime was founded as a land-to-the-tiller movement, one would have expected the Vietnamese government to be more sensitive to real estate issues. While abuse and corruption have been a persistent irritant in the countryside, they've increasingly spread to the cities and impacted the middle and emerging middle classes in Vietnam.

Land has always been a very sensitive issue in Vietnam. Technically, the state owns all land, but since the Doi Moi reforms and the implementation of a contract based agricultural system in the mid-1980s, people can acquire leases. Yet, not all land is created equal, and the best often goes to local officials and their cronies. Local-level officials routinely appropriate land for development projects or to profit from urban sprawl. Farmers keep complaining of unfair compensation. And even when compensation is market value, their forced sale has always remained an irritant. Farmers are often not provided with new skills to make a living. If proved, it could be one of the largest financial frauds in Asia. Even Malaysia's 1MDB corruption scandal involved for instance only about \$4.5 billion and the Vietnam land scam surpasses to a mindboggling US\$12.46 billion.

EFTA TO BOOSt US\$100 BLN

India and the four-nation bloc European Free Trade Association (EFTA) comprising Norway, Switzerland, Iceland and Liechtenstein signing the coveted free trade agreement, officially dubbed as the Trade and Economic Partnership Agreement (TEPA), is built on a progressive plan to attract US\$100 billion in investments over a period of 15 years. This is to benefit India in more ways than the conventional bilateral trade agreement. Prime Minister Naredran Modi has sealed this agreement and has rightly called this as a new turn and a watershed moment for India.

India seeks \$50 billion investment in first 10 years, another \$50 billion in next five years. This deal is expected to benefit industrial goods exports from India to the 4 European Nations bloc. The direct investments will create direct employment job opportunities of over 1 million. This commitment would be linked to duty reduction under the agreement.

The agreement has 14 chapters, including trade in goods, rules of origin, trade in services, investment promotion and cooperation, government procurement, intellectual property rights (IPRs), technical barriers to trade, and trade facilitation.

This TEPA free trade agreement is all important to India and also the 4 European Nations. Sectors related to almost all industrial goods exported from India to the EFTA. There would be more easy access to agricultural produces and products also are expected to benefit from the free trade agreement. Sectors such as pharma, medical devices and processed food items also would get a great boost.

Items such as dairy, sensitive agricultural products and soya, among others, would be kept on the exclusion list, which means no duty concessions would be provided in the agreement for these items.

Under free trade agreements, two trading partners significantly cut down or omit customs duties on the maximum number of goods traded between them, besides easing norms to foster trade in services and investments.

India's exports to EFTA nations during 2022-2033 stood at \$1.92 billion against \$1.74 billion in 2021-2022. Imports aggregated at \$16.74 billion during the last financial year as opposed to \$25.5 billion in 2021-2022, leaving a trade deficit of \$14.8 billion. With this EFTA agreement the deficit is expected to drastically reduce in the coming years of implementation of this agreement, benefiting India in all ways from inward investment to export trade and millions of job creation opportunities.

Of the four nations, Switzerland is the largest trading partner of India, followed by Norway. India's main imports from Switzerland include gold, machinery, pharmaceuticals, cooking and steam coal, and optical instruments and orthopaedic appliances, among others. Meanwhile, major exports from India include gems and jewellery, shops and boats, machinery, certain types of textlies and apparels, and chemicals, among others. The bilateral trade between the two countries stood at \$17.14 billion in the last fiscal as against \$14.45 billion in 2022-2023.

Switzerland has some of the largest pharmaceutical companies in the world, including Roche and Novartis, both of which have a presence in India. Furthermore, India has received about \$10 billion foreign direct investments (FDI) from Switzerland between April 2000 and December 2023, and is the 12 largest investor in India.

S Korea Doctors Against Doctors!

It should be intriguing as to why the doctors in South Korea have been on a strike since last two weeks. About 8,940 medical interns and residents in S Korea have left their worksites in protest, disrupting the operations of major hospitals forcing the government to deploy their defense personnel help attend the patients. Why are the doctors up in arms? Reason: They are against the government to offer more seats in medical colleges which they see as increase in competition in the jobs market! Very intriguing indeed. Thousands of junior doctors in South Korea have been refusing to see patients and attend surgeries since they walked off the job Feb. 20 in response to the government's push to recruit more medical students. The government plans to raise South Korea's yearly medical school admission caps by 2,000, from the current 3,058. The enrollment plan is meant to add up to 10,000 doctors by 2035 to cope with the country's fast-aging population. Officials say South Korea has 2.1 physicians per 1,000 people, far below the average of 3.7 in the developed world. The striking doctors-in-training say schools do not have the required infrastructure and hence, can't handle an abruptly increased number of medical students. Doctors are among the highest-paid professionals in South Korea, and the trainees' walkout has so far failed to win public support, with a survey showing that about 80% of respondents support the government's recruitment plan. Several critics, however, say the striking junior doctors sim-ply oppose the government plan because they worry adding more doctors would result in a lower income. The walkouts have led hospitals to cancel numerous planned surgeries and other medical treatments. In some major hospitals, junior doctors account for about 30%-40% of the total doctors, playing the role of supporting senior doctors during surgeries and dealing with inpatients. The strikers are among the country's 13,000 medical residents and interns, and they work and get trained at about 100 hospitals in South Korea. When the youth across the globe sweat it out to get into medical profession using one way or the other, here is a country where their own doctors are up in arms against more aspirants entering their profession. Sometimes few stand out as stranger than fiction.

Fake medicines are a big in granufactured by at Nec.

Fake medicines are a big malady and on the rise in India. There is a complex interstate intricately twined web of producing and distributing fake and counterfeit medicines fearlessly that poses a big threat to the public health and well-being.

In a shocking latest incidence that the DCA Telengana busted a spurious drugs racket, the team found the fake medicines ingredients contained were Just Chalk & Starch Powder!

The Drugs Control Administration (DCA) of Telangana in a meticulously coordinated inter-state joint operation with the State police, code named 'operation JAI', recently busted a spurious manufacturing and inter-state distribution network. They also seized fake medicines containing chalk powder and starch valued at several lakhs from a fake medicines distributor kingpin in Telegana. The officials found that the fake medicines were being sold by a non-existent company, **Meg Lifesciences. Following** the seizure, all medicines from Meg Lifesciences were subjected to a "Spurious **Drug Alert and Stop-Use No**tice" from the DCA. Based on the intelligence gathered by the investigating team, it was detected that fake medicines containing just chalk powder and starch, were being sold in medical shops by a non-existent company, "Meg Lifesciences", mostly as anti-biotic. Interrogations of the fake medicine distributor in Telengana revealed that they were all being manufactured by at Nector Herbs & Drugs facilities located at Kotdwar, Pauri Garhwal, District, Uttarakhand. The investigations further revealed that this fake medicines making and distributing racket has been going on for the past several years fearlessly fanned by the Uttarakhand firm. The complex network involved from fake medicine manufacturer to distributors and the retailers who consciously sell them for huge profits, at the cost and risk of the public health hazards.

An Assocham study says 25% of all medicines in India are fake, counterfeit, substandard and or mislabelled mostly with several spell mistakes, all of them bearing names of top pharma brands. Fake drugs constituted a staggering US\$4.25 billion (Rs 352 crore) of the total US\$14-17 billion (Rs 14 trillion) of the Indian domestic drug market. Approximately 10% of medicines in low- and middle-income countries prove ineffective because they are substandard or falsified, says the World Health Organization (WHO).

All these indicate the prevalence of counterfeit medications is far more widespread than one might think them to be, making the identification of fake medicines really too challenging. However, the Health Ministry actions to curb fake medicines spread in the market is far more wanting. Most of the time it appears that the government stands helpless with not stern action plans cines menace in the market that is affecting the health of the people. In addition the names of good brands being used by the fake medicine mafia and greedy fraudster gangs are also damaging the reputation of the big pharma brands that they built over years of hard work and intensive research in the search for effective medicines for the good of the society. The reforms in the health sector appears more focused on curbing the undue profits the big pharma companies make than dissuading the fake medicine makers. The mass promotion of generic medicines and introducing reforms in doctors premethodologies scription and their role in promoting premium priced pharma brand medicines are good to streamline this part of the health sector. But drastic reforms in the form framing stringent laws to punish the counterfeit medicine makers and distributors are still wanting as these fraudsters when caught face only simple prison terms after which they into the same racket of fake medicines. This could be halted by framing so stringent punishments that they do not dare again ever to commit the same crime again. It is also imperative that the State Health department should also become proactive and keep on the look out through their own intelligence network to hunt and finish the counterfeit medicine makers and dealers.

Two successive incidents change his career outlook thrusting him into the political arena that his late father PM Sayeed ruled for four decades in this islands cluster. His father P M Sayeed losing the 2004 Lok Sabha elections from Lakshadweep for the first time in 40 years and the former Union ministers death the next year changed young Hamadulla's mindset to pursue politics to take his father's legacy forward, dumping his career dreams to pursue law as a profession. UT of Lakshadweep has a voting population of 68,000 who will chose their next MP to represent them in Delhi. Hamadullah Saveed faces a formidable challenge from the two times sitting MP Mhd Faizal of NCP. This tiny remote island is set to see an interesting poll war in the forthcoming LS election.

Political Slug Festival

State Bank of India, SBI, that was initially in fix has now submitted the details of Electoral Bonds to the **Election Commission of In**dia (ECI) against the Supreme Court order which in turn is to upload on its website soon for public viewing. The apex court's decision to publicise political fun donors has undone the political funding reforms the government had initiated. The idea was to slowly switch from hard cash to banking routes and at the same keep the donors details

away from public viewing to avoid any political vendetta agains the donor later. It idea of the electoral bonds was that cash donations to political outfits does not get into accountable transaction channels and the government was keen to bring this unrecorded transactions onboard the banking system. In cash transactions no one knows who the donor is as the donors never want their names disclosed owing to fear of political vendetta later. The government's electoral funding reform was also to keep this most sensitive factor intact. But the apex court thought it otherwise and ordered disclosure of the donors.

SBI has complied with the apex court order by submitting the details of electoral bond buyers. It has stated that total of 22,030 electoral bonds had been redeemed out of 22,217 bought

The amount of electoral bonds was not encashed by poll parties within the validity period of 15 days, it was transferred to the Prime Minister's relief funds, the SBI said. SBI's ready records in which the date of purchase, denomination, and name of the buyer were recorded, and [in relation to the political parties] the date of encashment and the denominations of the bonds encashed were recorded."

The State Bank of India submitted records include all the relevant details such as date of purchase of each Electoral Bond, the name of the purchaser, the denomination of the Electoral Bond purchased, the date of encashment of the Electoral Bonds, the name of political parties who have received the contributions.

What more is needed for the media and the political parties to start a slug festival pointing accusing fingers at the donor and received of these political contributions. As China and few other Eastern countries battle Baldness, a whooping ₹12,000 Crore Human Hair smuggling racket, spanning a complex money trail and alleged money laundering through the three-point-corridor, has been unearthed in Hyderabad, Telengana. ED busts ₹12k Cr hair racket leading to 'balding' China and few other Eastern countries. The ongoing ₹12K crore ED probe has revealed a complex web of money trail and alleged money laundering.

An ongoing ED probe has thrown up a Rs 11,793-crore human hair smuggling racket spanning a complex money trail and alleged money laundering through the three-point-corridor. Human Hair was smuggled to Myanmar, Bangladesh, Vietnam and China from Hyderabad airport and through land routes via Mizoram and Kolkata.

authorities Indian are cracking down on human hair smuggling by investigating smuggling operations, finding out the modus operandi and tightening enforcement measures. Human hair smuggling, the illegal trade, not only poses a loss for the country's economy but also undermines export and other related tax revenues due to evasion and also poses challenges for enforcement agencies, prompting stricter measures to combat the problem. The Indian human hair smuggling often is done through land routes via neighboring countries.

The Enforcement Directorate (ED) has uncovered a massive US\$1.5 billion hair smuggling racket, with China being the primary buyer, due to high demand for Indian human hair. Indian officials are cracking down on this illegal trade, which involves smuggling human hair worth billions to countries like China, Bangladesh, Myanmar, and Vietnam, to name a few. The land routes is traced to Hyderabad-Mizoram-Myanmar "front" which has been offering illicit human hair as raw material for the



hair items making industry.

China and few Eastern countries are experiencing a significant epidemic of hair loss, leading to a high demand for wigs and hair extensions. In addition, Indian human hair is globally preferred by manufacturers due to its perceived quality, described as lightweight, lustrous, and of fine quality, particularly the Remy hair with intact cuticles.

Raw Human Hair are mainly collected from households, beauty parlours, salons, and more so majorly from temples and these primarilly cater to the beauty market globally. The Indian human hair export trade clocked US\$145 million last financial.

Two Types of Human hair are collected in India: Remy, the best grade collected from temples where pilgrims donate their hair as part of a religious vow and Non-Remy, slightly lower quality in terms of length and other attributes which are collected from households and non-temple sources by small groups in villages and cities which are seggregated and sold to hair dealers.

Illegal trading from Hyderabad to Myanmar was uncovered by ED, linked to ₹11,793 crore human hair smuggling. Investigation reveals suspected money laundering scheme involving benami shell companies, overly undervalued exports, and hawala transactions. This smuggling operation reportedly involves transportation from Hyderabad airport and through various land routes to neighboring countries. Shockingly, whole of the scam was orchestrated by just one company based out of Hyderabad, Nayla **Family Exports Private** Ltd.

In 2021, action was taken against Nayla Family Exports Private Ltd, based in Hyderabad, for their involvement in the smuggling racket. They were accused of utilizing benami import-export codes, engaging in impersonation, and committing forgery in connection with the illicit operation. The alleged money laundering activities were conducted through what is termed as a "threepoint corridor" involving Hyderabad, Mizoram. and Myanmar.

Amid the hair loss issue affecting the Chinese population, hair smuggled from Hyderabad has been transported to China. as well as other countries such as Myanmar, Bangladesh, and Vietnam. The report provided details on how the illicit funds are routed back to Hyderabad from traders operating in Myanmar and other countries where the items eventually illegally reached. A significant amount of cash totaling ₹2,491 crore, which accounts for over 21% of the total sum of ₹11,793 crore, was deposited into various accounts after being routed through a complex web of multiple channels.

In February 2022, the **Enforcement** Directorate (ED) carried out extensive searches across the country, revealing a clandestine operation focused on exporting hair to Myanmar. The **Enforcement** Directorate (ED) took prompt action, initiating cases in 2021 against Nayla **Family Exports Private** Ltd for allegedly participating in illicit practices, including the use of fictitious Import-Export Codes (IEC), impersonation, and forgery. Navla allegedly created multiple shell (benami) companies to export hair at drastically undervalued prices. According to reports, these shell entities are dissolved whenever they come under scrutiny from tax authorities, with new IECs subsequently created. Payments, estimated at around ₹8.000 crore annually, are believed to have been received through "mule" bank accounts, or hawala networks or through Chinese apps like Dokypay and Linkyun. These shell companies, majorly in the Northeast and Kolkata, from where the mass shipments were sent on-

ward via land, first to Myanmar and then to China.

Indian human hair, discarded as waste after haircuts, holds immense value overseas. Indian human hair is highly sought after, globally, contributing significantly to Indian export industry. Two Types of Human hair are collected in India: Remy, the best grade collected from temples where pilgrims donate their hair as part of a religious vow and Non-Remy, slightly lower quality in terms of length and other attributes which are collected from households and non-temple sources by small groups in villages and cities which are seggregated and sold to hair dealers. Addressing this human hair smuggling is challenging and may take time due to its complex nature and widespread implications. Human Hair exports were earlier allowed without any restrictions which was making human hair smuggling easier without any easy detection methodology. However, DGFT is looking at ways to totally halt the illegal trading. Looking at the huge illegal trading of Indian human hair, export rules were amended. Now an exporter would have to seek specific permis-sion or licence from the **Directorate of Foreign** Trade (DGFT) under the **Ministry of Commerce** & Industry. This move according to hair industry, would help in checking alleged smuggling of the product from India and also streamline the export trade. It is also imperative that the government frames more stringent punitive laws to terrorise and dissuade them from taking to illicit routes to make illegal money.

Investigations against complaints then, including that of Bharathidasan Cricket Club of Puducherry, then had proved the prime premium fertile government land grab worth several hundreds of cores by Damodaran's Siechem.

The then bold firebrand Lt Governor Kiran Bedi ordered immediate demolition and posses-sion of the grabbed land. The then Collector Dr Arun took steps to implement the LG order re-confiscate the alienated lands, for which he was unceremoniously transferred when the **Rangasamy** government came to power in 2021. Meanwhile, the smart and cunning Damodaran managed a stay from the court to halt the demolition and taking over of the grabbed land by the UT government.

It is alleged that it was then the allegedly corrupt Vallavan, touted to be close to the Chief Minister, was appointed in place of Dr Arun and was also give several other plum departments to Head. When Vallavan was appointed, the work

of transferring the alienated lands to Siechem Technology Private Limited started.

It is alleged that the Collector former of Pondicherry Valavan orchestrated a meeting between Damodaran and N Rangaswamy who had just taken over as the new **Chief Minister of the UT** and ensured the grabbed land was legally handed over to him against withdrawal of the complaint Damodaran filed to get the stay to halt demolition of the CAP cricket ground illegally built.

For this illegal lease, Puducherry Town Coun-try Planning Board Committee meeting was held on 5.8.2022. It is alleged that the former Collector with the approval of the CMO and Lt Governor ensured legal approval was given to the grabbed fertile government land to Siechem Technology, allegedly against huge illicit bribe money, say the public. The legal lease order was issued by then Kantar Selvan. Chief Executive Officer of City Planning. Subsequently, it is alleged, the lease deed was publicly registered in the office of the Sub-Registrar, Willianur. The irony is that the deed mentions that the lessor is Siechem Technology Private Limited and the lessee is Cricket Association of Puducherry (CAP). So its was not a government land lease to CAP but direct handing over of the grabbed

land to Damodaran in his company Siechem name, who in turn leased it out to CAP, making the government land grab absolutely legal.

People are annoyed that even both Pondicherry CMO and Lt Governor acted passively and endorsed the decision to award legal status to the illegally grabbed fertile government land.

There are several other allegations too that Damodaran has been acting for the businessman Srinivasan who once owned directly the Chennai Kings team in IPL. Allegations, to the shock of sports persons, are piling up against Damodaran that he in connivance with some administration officials and staff, with the blessings of top bosses in the government and the administration, have been illegally inducting outsiders into the Puducherry Cricket team using forged personal identity documents to illicitly prove that they are local residents of the UT. Naturally, these are done allegedly against huge bribe money. The local talents are denied entry into the cricket team.

Several Social Service organizations with evidence had pointed out that players from Andhra, Kerala and northern states are being fraudulently included in the Puducherry cricket team. Lawspet Chandiran, a honest Social Worker, has been raising his voice

from time to time about the Cricket Association of Puducherry (CAP)'s impersonation scandals and government land encroachments and legalizing illegal land grabbing. At one point he even approached the Madras High Court for justice. He has been fighting for return of the illegally grabbed government land and that only bonafide genuine UT of Pondicherry talents be inducted into the cricket team, trained and made to participate in Ranji Trophy, T20 and other matches and all the illegally inducted players against forged documents be removed immediately. But he was allegedly thrashed by hired goons to silence him and his alleged fight against Damaodaran.

These sent shock waves across and the public were aghast that how Chief Minister Rangaswamy is being coaxed by few officials and outsiders to damage the CM's clean image.

People now demand that the order of former Lt Governor Kiran Bedi. be upheld, demolish the illegal CAP structure and reclaim the illegally grabbed and awarded land to Siechem. People of the territory who are passionate about their Chief Minister want this government land reclaimed and the wrong-doers punished so that the CM who was coaxed into this comes out clean.
