


UNION TERRITORY INDEPENDENT CASH IS ELECTION FUND EMPEROR!

What rules the elections funding - Cash or White Donations? Cash of course is the King of electoral funding, where cash flows like the never drying river. This is more than an open secret. Supreme Court's recent decision to strike down the electoral bonds scheme introduced in 2016-17 has created ruckus among political parties? No, not really. But surely this has undone the most significant electoral funding reform. The infringement of right to information (RTI) of voters is quoted as the key to apex court's decision to end this bonds scheme. It is a fight between disclosure of funding source and privacy of the funding entity. In a way, the electoral bonds scheme addressed this, in fact more effectively. It is noteworthy that none of the common voter is interested in knowing who funded whom. This RTI is of keen interest only to political parties and some keen evil-minded activists to know the funding entity so that a well planned revenge design could germinate to arm-twist them to serve their interests in the future. A look at the estimated election expenses and the amount generated through the electoral bonds, per various reports and analysis from ADR and others, should serve as a measure as to who rules who, cash or the bonds. Roughly about ₹60 Thousand Crores is spent on 543 Lok Sabha seats, that is about ₹100 crore per LS seat, as against the Election Commission (ECI) ceiling on poll expenditure per candidate limited to just about ₹95 Lakh for Lok Sabha polls. Added to this is almost the same amount of Rs 60 Thousand Crores spent on about 4100 State Assembly seats that comes to about ₹5 crore per Vidhan Sabha seat. Cumulatively about ₹1.2 Lakh crore is being spent every election cycle, as against the meager ₹16,518 crores received through electoral bonds scheme from March 2018 to January 2024, split between about 32 National and regional parties. This is not even 10% of what was spent between the 2019 LS elections and the Assembly elections fought during the same period. From where has the huge deficit come from? Naturally the cash receipts. It is not about statistics who rules whom. It is all about clean funding, which cannot be expected in the current Indian political poll scenario where the money might dictates the strength of the prospects of the winning candidate, or say political party. Good and bad are part of lifecycle in the universe. Wisdom is to ascertain which has more of goods than the bad. Reforms as in any sector, election funding also needs drastic reforms, but not at the cost of the donors freedom to choose their choice of political affiliation without harming them in the future. There is no denying or debate on clean politics. It is undoubtedly imperative the elections funding is streamlined. But in a country where several voters take a bribe in cash or kind to vote, could any honesty be expected from the parties? West are nothing better, but still in the west businesses are not overly dependent on favours from the polity. This makes it easier for them make choices and donate per their wish. India in the current scenario is different in all ways. Clean politics starts from elections. Elections need to be free of all frills. Reforms are needed. Electoral bonds were a step forward. But the big question from where and how such huge cash is flowing from. We hear about mountains of hard piled up cash being recovered from raids. What has happened to the much touted demonetization, phenomenal digital push, tightening of financial regime to curb cash pile up? When a common man has to face a barrage of questions from the bank and tax authorities even when tiny deposits or withdrawals are made, how the biggies are able to mobilise so much of cash? There naturally are several loopholes that the biggies and the dalals are able to circumvent without being detected. First of all the cash pile has to stop. Government knows all the loopholes, but is not acting as the ruling party also needs this cash flow. Property and stock trading are huge cash generators. For instance, link all property transactions to PAN and Aadhaar to bring in more transparency.

It is easy to frame laws. Much easier to strike them down by knocking the court doors. When it comes to electoral funding, transparency can never be the answer. This will only trigger more illicit cash inflow into the poll machinery, keeping in mind the vendata designs against the disclosed donor entities. Having said this, it is now for the political parties, ECI and the reform think tanks to evolve ways to weed out this political poll funding corrupt methodologies. Drastic reforms are good, but need to keep in mind the good of all. This issue appears to be a stigma that has come to stay forever in the Indian poll war for supremacy scenario.

RELIANCE INKS 33K CR MEGA DISNEY MERGER

Mumbai: Mukesh Ambani owned Reliance Industries Limited (RIL) and Walt Disney Co have agreed to sign a binding pact to merge their media operations in India. As per the pact, the media unit of Reliance and its affiliates are expected to own at least 61 per cent in the merged entity, with Disney holding the rest.

The stake split between the partners may change, depending on how Disney's other local assets are factored in by the time the deal is closed. The deal is likely to be announced soon. The Wall Street Journal earlier this month reported that Disney had agreed to sell 60% of its Indian business to Viacom18 owned by the Reliance group. Disney agreed to sell 60 per cent of its India business to Viacom 18 at a valuation of \$3.9 billion (Rs 33,000 crore). Viacom18 is owned by Reliance Industries Limited (RIL) Chairman Mukesh Ambani. Last year, Reliance was evaluating Disney's India assets, encompassing the Disney+ Hotstar streaming service and Star India, at a valuation ranging from \$7 billion

to \$8 billion, while During the same period, Disney valued its Indian operations at \$10 billion. There were reports earlier that Disney Star, which will air the upcoming Indian Premier League (IPL) 2024 matches on its sports channels, was demanding Rs 167 crore and 83 crore for co-presenting and associate sponsorships, respectively, on standard definition (SD) channels. The deal is seen as a significant move in the Indian media and entertainment industry after the Zee-Sony deal collapsed last month.




Mission 'capture Delhi' is becoming most interesting as the crucial 2024 general elections near. All the three key contending parties, BJP, AAP and Congress are entangled in putting up a show of supremacy in the Delhi's 7 LS constituencies.

BJP cannot afford to lose any of the 7 seats it captured in 2019. For AAP's Kejariwal this is the question of 'do or die' for his relevant political survival and for the Congress that drew a blank both in LS and Delhi Assembly elections last time in Delhi is a fight for status to show that it is alive still.

After the Aam Aadmi Party (AAP) said that Congress does not deserve even a single seat in Delhi, but owing to 'Alliance Dharma' is offering one seat on take it or leave it basis, now AAP has gone in for seat sharing understanding offering Congress 3 LS seats and 4 for itself. The change of heart in Delhi CM Kejariwal has not come for free. As the sword of imminent arrest in the PMLA liquor case hangs right over his head,

he wanted an ally who will help him out lamenting to the public he was target of BJP's vendetta and that he had become a political martyr. Should the loss margins be higher, AAP will also be in for more trouble in the coming Delhi Assembly elections. Congress on the other hand needs to show a fight in Delhi to show it is still alive in politics and it knows the drubbing would be too harsh should there be a three cornered fight. Congress has almost decided on the candidates for its 3 Delhi share LS seats. In all certainty one could have been Ajay Maken, the CWC Member and Treasurer of All Indian Congress **Committee (AICC) who has** held ministerial position in former Delhi Chief Minister late Shiela Dixit and also later in Dr Manmohan Singh's Union ministry, but his RS win has put this seat in question for Chandni Chowk LS constituency for the Congress. Second sure probability should be Arvinder Singh Lovely, the current President of Delhi Pradesh Congress Committee who also has held ministerial position



Kuldeep Kumar has been named for the East, while Sahiram has been named for the South Delhi seat.

The case for BJP is different. It has to retain all the 7 won Delhi LS seats. Congress-AAP poll alliance has created more buzz in the **BJP circles. Most interest**ing would be BJP's strategy to retain all the 7 LS seats it won in 2019. It is a question of National status image for BJP. Going by reports the BJP is said to be working on 3 possible formulas of old and new faces combination: all 7 new faces, 4 New and 3 old and 5 old and 2 new faces. New faces will not make any difference to BJP's win dynamics, as in any case whole of BJP has decided to go for the polls with the unblemished popularity of Prime Minister Narnedra Modi, the BJP's Lotus symbol and of course the achievements of the government and its schemes that has millions of satisfied end beneficiaries.

Whatever could be BJP's decision on the formula, reports are stronger that BJP is toying with the idea of bringing in Bollywood superstar Akshay Kumar to fight from Chandini Chowk LS constituency where he would be challenging the congress candidate, most probably Ajay Maken. The second sure candidature for the North West Delhi LS constituency could be that of Bansuri Swaraj, the current Co-convener of BJP's Delhi Legal Cell and daughter of BJP stalwart and firebrand leader late Smt Sushma Swaraj. Here too would be challenging a congress candidate, possibly Sandeep Dixit. Sitting MP from East Delhi, Gautam Gambhir, could be facing some issues for re-nomination despite is good work during his tenure owing to reported disconnect with BJP and RSS workers and some bosses. Whatever be the developments, Delhi is sure to see a battle for political supremacy where BJP would be fighting against the AAP-Congress combine in this all important capital city of the country.

AI BUSTS ₹18KCR GST EVASION

GST evasion detection now gone high-tech. The **Directorate General of GST Intelligence (DGGI)** has busted and registered 14,597 fake Input Tax Credit (GST-ITC) cases worth Rs 18,000 crore in just 9 months in 2023 alone. So far 98 people have been arrested by the Tax sleuths. The busting of this whooping GST evasion was done using Artificial Intelligence (AI) and Data Analytics. This is good news that government is on the right path to save millions to the exchequer.

Using Artificial Intelligence and Data Analytics, amonth advanced tools, DGGI sleuths apprehended tax evaders involved in creating fake firms and companies to claim fraudulent Input Tax Credits. In one case, a firm in Haryana generated E-way bills and created Rs. 1,100 crore fraudulent ITC.

During the period of April-December 2023, of the current fiscal, central tax officials registered a staggering 14,597 cases of **GST** evasion. Maharashtra (2.716) followed by Gujarat (2,589), Haryana (1,123),

and West Bengal (1,098) emerged as the states with the highest number of GST fraud cases.

Various data analytic and artificial intelligence tools such as NETRA (Networking Exploration Tools for Revenue Augmentation), BIFA (Busi-Intelligence ness and Fraud Analytics) & AD-VAIT (Advanced Analytics in Indirect Taxation) are being used to identify risky taxpayers, suspected of passing or availing fake input tax credit, including. Based on the feedback received from the field formations, these tools are from updated/modified time to time.

Actions are being taken right from the GST registration. The GST registration process now has robust checks in the form of physical verification of premises and Aadhar authentication. The said checks have enabled in early detection of fraudulent registrations and also curbed fraudulent registrations to a great extent.

In a bid to further strengthen the registration process, pilot proj-



ects involving risk-based biometric-based Aadhaar authentication are underway in Gujarat, Andhra Pradesh, and Puducherry. This initiative aims to enhance the authentication process, thereby minimizing the potential for fraudulent registrations.

Highlighting the efficacy of these advanced technological tools, Minister of State for Finance Pankaj Chaudhary noted that **GST** intelligence officers are now able to successfully identify fake input tax credit cases and that the current busting of evasion cases is a proof. The

concerted efforts of GST officers, coupled with the deployment of advanced technologies, underscore une government s commitment to combating tax evasion and ensuring compliance within the **GST** framework resulting in halting of losses and increase in GST collections.

Recent report of the Central Board of Indirect Taxes and Customs has highlighted the issue of bogus registrations and fake invoices in the country, Delhi topping the list. The report for the third quarter has revealed shocking facts about the extent of

tax evasion prevailing in Delhi making it clear that Delhi has achieved the inglorious distinction of recording the highest tax evasion in the country. In all, 483 bogus firms were detected, which accounted for □3,028 crore of tax evasion. It is indeed dubious that the Capital of the country tops the list of tax evasion amongst all states and UTs amounting to much as ₹827 crore. The systems made so tight that such evasions are not possible without the connivance of some unscrupulous tax officials. Highlighting these, the Delhi LG has written to Delhi Chief Minister Arvind Kejariwal initiate investigations to get to the bottom of these frauds and book all found guilty. Tax evasion cases are on the rise meaning thereby there exist several loopholes in the system those are being taken undue advantage upon, surely with the collusion of some tax officials. These need to be addressed quickly, else these fraudsters would empty the government coffers sooner or later.

Neutral Patnaik



Naveen Patnaik, the current, 15th and the longest-serving Odisha Chief Ministers in India's political history and is considered one of the key veteran leaders in the country. Naveen Patnaik is the son of the legendary Biju Patnaik, a former Chief Minister of Odisha. Naveen has been serving as CM for 22 years.

Naveen Patnaik, 78, representing Hinjili Assembly constituency since 2000 also is a writer and author, who won several awards for his able administration as Chief Minister. He was a classmate of Sanjay Gandhi and three years junior to Rajiv Gandhi while in Dhoon School. For most part of his youth he had been away from both politics and Odisha, but after his

father Biju Patnaik's demise, he had to enter politics in 1997. Same year he split from Janata Dal and founded the Biju Janata Dal, named after his father. Soon after, recognizing his potentials, he was inducted into the Union ministry as the Union Minister of Steel and Mines under Atal Bihari Vajpayee's government.

In the subsequent years, Patnaik's leadership skills and political acumen became evident as he successfully steered the BJD to victory in the 2000 Odisha state elections, leading to his appointment as the Chief Minister of the state.

His mild mannerism, stern stand against corruption and Pro-poor policies have catapulted him to heights of popularity

and in the development of a huge support base in Odisha, which has voted him to power in the last five consecutive terms. Like his father, he has managed to ably control the bureaucracy transforming it into a 'development war machine' of the state. His simple nofrills attached personal lifestyle, non-controversial and detachment from material possessions are the key to his unwavering mass support from the people of Odisha and beyond that has been voting him to power for last two decades. Patnaik's early life was marked by his international experiences and his dedication to public service. A staunch lover of cultural history, he is one of the founding members of Indian National

Trust for Art and Cultural Heritage. His elder sister is the writer Gita Mehta.

Largely neutral with no chosen political alliance, since assuming office in 2000, Patnaik has led the state through various challenges and has implemented numerous initiatives to foster development, welfare, and inclusive growth of Odisha. Soft-spoken, his cordial relationships with all in polity and bureaucracy have earned him friends across the board that has helped him meet challenges at all times.

One of the notable achievements of Patnaik's tenure has been his effective disaster management strategies. Odisha is prone to natural disasters, particularly cyclones, and Patnaik's administration has been widely acclaimed for its proactive approach and efficient handling of crises such as Phailin in 2013 and Fani in 2019, have received widespread acclaim and have been recognized as model examples of disaster management.

His pro-poor and pro-people policies have earned him his mass respect and love from the people of the State. A slew of schemes like the Biju Pucca Ghar Yojana (housing scheme), the Madhubabu Pension Yojana (pension scheme), and the Ama Gaon Ama Bikash (village development program) have all been received well by the people and is the secret for Naveen Patnaik's growing popularity among the people.

Vijayan For Gender Audit



In an attempt to wooing women voters ahead of the Lok Sabha polls, Kerala Chief Minister Pinarayi Vijayan said a gender audit will be conducted in workplaces across Kerala and steps will be taken to ensure equal pay for women, on par with men.

Kerala CM Vijayan emphasizing the need for jobs to be more favorable for women, he highlighted Kerala's achievements in women-friendly policies, including introducing menstrual leave for students and implementing gender budgeting in local government bodies.

Addressing the Chief Minister's Face-to-Face Programme with women in the state, Vijayan said until recently, the emphasis was only on educating women. But they also need to be convinced of the need for them to participate in the formal workforce from now on. Jobs should be made more favorable for women. Gender audit in workplaces is the first step towards creating an environment for pay parity with those of men, Vijayan said. He also said that Kerala has become a role model in the country by introducing menstrual leave for students in all state universities under the Department of Higher Education.

As per the National Survey on Higher Education, the state has the highest participation of women in the higher education sector, he said, adding to his point about how it must also translate to more women joining the formal workforce.

Criticising the central government, saying it follows gender budgeting just for namesake, Vijayan said not even once has the figure gone above 6% of the total budget whereas in Kerala, the gender budget is 21.5% of the total budget this year. Since 2017-18, the annual gender budget has been introduced every year along with the state budget," he added.

Addressing the massive crowd at the CIAL convention centre here, the Left leader said women are the driving force behind the Sanitation Mission and the Green Army of the state. He said women can also manage the "social waste" of communalism which pollutes the entire society. The attempts to showcase matters related to beliefs into symbols of aggressive communalism must be resisted. Women play a major role in making sure that even children understand these, he added.

Speaking about women's growing role in the startup space, Vijayan said that out of the newly launched startups in Kerala, 40 per cent entrepreneurs are women and out of the Rs 8,000 crore investments in startup sector, Rs 1,500 crore are from women entrepreneurs. "Women need financial freedom to gain social progress," he asserted.

Cong Forced To Contest!

In a country where prospective candidates fight to grab a party ticket for the elections, Kerala is witnessing reverse trend in the Congress.

No one wants to lose a war. Majority Congress MPs in Kerala State have been shying away from re-nomination gauging the voters mood and trend that is going against the party that in any case has not been proactively campaigning. Adding to the wound is the unending infighting among the different power centres within the State party unit. Several of the sitting MPs earlier had openly said they would not want to contest again. This should have come as a melody to other prospects? No. None in the party want to risk their political prospects by losing the election. Amazingly, the Congress has decided to concede the elections to their opponents, even before the poll date announcement.

It is thought provoking to analyse why the Congress leaders wouldn't want to contest the Lok Sabha polls this time around? There are several reasons. One is the party infighting that is clawing a party-united fight challenging the stronger left party and its allies. More interesting is the fact that the Congress leaders feel that Congress has all the chances of winning the State

Assembly in 2026 and they are eyeing leadership roles if and when this happens.

Congress Party command thinks otherwise. It feels new faces in the fray will increase the woes as the CPI-M along with its allies are marching ahead to garner all of the 20 Lokh Sabha seats, with their proactive and aggressive poll campaigns and the Kerala Chief Minister Pinarayi Vijayan clicking high on the popularity and people satisfaction rating for now. In the current scenario, Congress wants all its sitting MPs to contest again so that winning probability increases in the face stiff opposition from the Left Democratic Front (LDF) and BJP-NDA combine that has all the possibility of shift of Hindu and Christian voters. Almost all the 15 sitting MPs of the Congress are likely to be in the fray again. Even as some sitting MPs openly expressed their desire to keep off from the Lok Sabha elections, they are forced to remain in the fray especially since there is not much push from other leaders for the seat. In fact in a first of sorts all the sitting Kerala MPs are getting re-nomination unopposed! Party insiders said that many leaders seem to be skeptical about the prospects of Congress at the Centre, whereas there are high hopes of Congress returning to power in Kerala in the 2026 Assembly polls. Hence, many sitting MPs want to focused on Kerala politics.

Sitting MPs Kodikunnil Suresh, T N Prathapan and K Muraleedharan were among those who had shown reluctance to contest in the Lok Sabha polls. Congress leader Shashi Tharoor had expressed his desire to be in Kerala politics earlier.

Though Kerala Pradesh **Congress Committee presi**dent K Sudhakaran too preferred to keep off from the fray citing his organisational responsibilities, he is under pressure to contest from his sitting seat Kannur as the CPM is planning to field senior leader M V Jayarajan from there. There were also reports that AICC general secretary K C Venugopal is also under pressure to contest from his previous constituency Alappuzha, which was the lone seat the Congress lost in the 2019 election in Kerala. Even as a formal announcement regarding Congress leader Rahul Gandhi's candidature at Wayanad is awaited, party leaders hope that he will contest again from the high-range constituency, which is considered a safe seat. However, this becomes a mere mirage as CPI announces nomination of Annie Raja from Rahul Gandhi's Wayanad LS seat.

Annie Raja In Wayanad

Forthcoming 2024 Lok Sabha elections are springing surprises everywhere with mass exodus on side and crossing over to BJP on the other side and some shying away from contesting. One also sees parties who are foes in one State are thick of friends in the other, which is unique to Indian brand politics. The Communist Party of India (CPI), a Congress ally outside Kerala State, the second-largest coalition partner in Kerala's ruling Left Democratic Front (LDF), has announced the names of its candidates for four crucial seats in the upcoming Lok Sabha polls. Veteran party leader Annie Raja has been nominated to contest from the crucial Wayanad constituency, a seat presently held by Congress leader Rahul Gandhi and who is contemplating to contest again from the same seat which is considered safe for the Congress. Former agri-



culture minister V S Sunil Kumar and the party's youth wing AIYF's leader C A Arunkumar is being fielded from Thrissur and Mavelikkara seats respectively. Meanwhile, another experienced leader and former MP Pannian Raveendran will contest from Thiruvananthapuram, a crucial seat represented by senior Congress leader Shashi Tharoor. Congress is yet to announce its candidates for Kerala, except reports that all the sitting Congress MPs would be forced to contest again. The grand old party Congress hasn't yet confirmed its candidate for the Wayanad seat, which was won by Rahul Gandhi in 2019. Rahul Gandhi in 2019 fought from two constituencies, UP's Amethi parliamentary seat, a seat that he had retained from2004 to 2019 and also from Wayanad in Kerala. As Rahul lost the Amethi seat that he had retained for 15 long years, to BJP's Smriti Irani, he was forced to retain the Waayanad seat. The Kerala LS election also is heating up and is interestingly building up. Really, politics is all about opportunistic possibilities of all sorts.

India Turning A Religious Nation

Kerala Chief Minister Pinarayi Vijayan expressed concern over the alleged attempts being made to turn India into a religious nation, and accused those in power at the Centre of trying to blur the lines between religious institutions and the state. Without mentioning Prime Minister Narendra Modi, he said nowadays those who hold constitutional positions are turning into priests during religious ceremonies. The Left veteran was apparently referring to the recent consecration ceremony of the Ram temple in Ayodhya in which PM Modi was the 'yajman meaning master of a yajna'. "Attempts are being made to turn India into a religious nation. This evokes great concern," Kerala CM Vijayan said, speaking during the valedictory session of the 10th Mujahid State Conference at Karipur in the northern district of Kerala. He labelled as "pathetic" the attempts by certain leaders "even in Kerala" to justify such events.

In present India, C M Vijayan further also accused the Centre of sabotaging projects meant for minority communities.

Left Demands VVPA



Left parties are asking the government on transparency in the forthcoming general elections due in April-May 2024. The **Communist Party of India** (Marxist) (CPI(M) has demanded that at least 50\$ VVPAT (Voter Verifiable Paper Audit Trail) be tallied with EVM's (Electronic Voting Machine) count. It also announced that it will campaign across the country on the issue. Since 2019, BJP government had introduced more vehemently the VVPAT system, where VVPAT slips from five randomly selected polling stations per assembly constituency (or segment in cases of Lok Sabha seats) are matched with the electronic voting machine (EVM) count for greater transparency. **CPI(M)** says that this now be increased to 50% of the voting segments. "Given the widespread concerns over the functioning of the EVMs, CPI(M) will campaign across the country that there should be the following re-sequencing of the electronic units in the polling booths, voting units, control units and VVPAT. At least 50%

of VVPAT must be tallied with that recorded in the control unit," says CPI(M) after a three-day meeting of its Central Committee. The CPI(M) also raised

the issue of the Citizenship (Amendment) Act, 2019, (CAA) and alleged that the government has pushed the framing rules to the eve of elections to sharpen communal polarisation. "Since December 2019, the Modi government has not framed the **Rules under this Act. Now,** on the eve of the general elections, it is pushing for its implementation with a view to further sharpen communal polarisation and hoping to reap electoral gains, particularly in Eastern India," CPI(M) said. The Central Committee also gave a call to all state units to "continue and intensify struggles against growing unemployment, price rise and assaults on people's livelihood' by the policies of the Modi government.

They also expressed solidarity with the Samyukt Kisan Morcha and the joint platform of Central Trade Unions supporting their demands.

CPI(M)-TMC War Of Words

It was known that West Bengal Chief Minister Mamata Banerjee's Trinamool Congress (TMC) and the left parties do not see eye to eye in the State. Both TMC and CPI(M) have been having a war of words blaming each other playing spoilt sports in the State at the cost of the welfare and good of the people of the State.

With the 2024 general elections just 8 weeks away, the poll heat naturally is in high-pitch with high-decibel speeches and statements accusing each other for the breaking of the newly blamed opposition grouping the I.N.D.I. alliance bloc. While the CPI(M) says that TMC is finding excuses for leaving the new bloc, TMC's Mamata Banerjee on the other hand says that the CPI(M) played spoilt sport to shatter the cordial ties with the Congress.

CPI-M State Secretary Mohd Salim said Trinamool Congress is trying to get down from the "I.N.D.I. Bloc train" and now blaming CPI-M for it, a day after West Bengal Chief Minister Mamata Banerjee blamed CPI-M for spoiling her relationship with Congress. "When INDIA Bloc was formalized in Bengaluru, I have said many can board a train from Howrah station but who will get down where, it is his / her decision. It is not known to the co-travellers. Mamata Banerjee is trying to get down and thus finding excuses. It may be a pre-decided thing. But why are you blaming CPI-M now?" Salim questioned. The Left Front will fight against the corrupt Trinamool government in Bengal, CPI-M State Secretary Mohammmed Salim asserted. Earlier, CPI-M's Salim showed solidarity with Rahul Gandhi's Bharat



Jodo Yatra and said Rahul Gandhi is facing so many obstacles to take forward the people's yatra in Bengal. "Media has said time and again that Mamata Banerjee is anti-BJP face. CPI-M was nowhere. What she is saying now has been said by her before every election" Salim said. CPI-M Bengal leadership, including Salim and Sujan Chakraborty, had joined Rahul Gandhi's Yatra-2 in Murshidabad, a day after TMC supremo Mamata blamed CPI-M for playing games to maker TMC relationship with Congress turbulent.

Banerjee has always been fighting against the left parties to retain power in the State.

West Bengal CM Banerjee stated that her relationship with Congress was cordial until it was spoiled by the continuous interference of the CPI-M. Banerjee mentioned that she offered Congress two seats in Malda, but they didn't agree. She accused the CPI-M of working as an agent for the BJP. Despite the earlier alliance, Banerjee asserted that Trinamool Congress would contest all 42 Lok Sabha seats in West Bengal. This statement came amid political dynamics and discussions about potential alliances for the upcoming elections. I cannot pardon **CPI-M**, the party which has beaten me several times," she alleged and added TMC would field candidates in Congress strongholds of Malda and Murshidabad. Banerjee walked a km in Malda, ahead of an administrative meeting, timed to coincide with Rahul Gandhi's Bharat Jodo Nyay Yatra. "I offered Congress two seats in Malda where their MPs have won for years. I told them that I will help them win those two seats. But they did not agree. Do they want all 42 seats then," Banerjee asked in Malda, a **Congress stronghold since** the days of former railway minister Ghani Khan Chow-

dhury. "Our fight will continue against BJP and we will fight alone. Only Trinamool can defeat them. You have blessed us in last assembly polls, and we have done developmental work," she said.

As the CPI(M)-TMC poll war of words continue, Congress is said to have started connecting with her again and TMC is said to have softened its stand in the face of SandeshKhali uprise bothering here and threatening her prospects in the State. As WB-CM Mamata will never offer LS seats to CPI(M), it is only natural that the Congress will have to accommodate CPI-M for which it needs more LS seats from TMC.

People are also surprised at his absolute influence over the CMO that he just been transferred out of the territory and not suspended as allegations of corruption and arrogance continues to pile up even now, after the transfer order. But allegations had been pouring in on his misconduct with MLAs and his high-handed and arrogant handling of CMO affairs. All applications for grant of funds from Chief Minister Relief Fund for people welfare causes goes to Amuthan first for processing before they reach the table of the CM. It is alleged that Amuthan sits over these application files for months and does



not pass on to the Chief Minister. He is also being alleged to misappropriating be the funds of the government from the budget allocated from CM **Relief fund allegedly** producing fake bills as if from workers and needy people from constituencies. Even fabricated medical and hospital bills are used to siphon out the money from CM Relief Fund allocated budget.

It is alleged that Amuthan keeps telling the political leaders and the MLAs that he paid a whooping Rs 12 crores to the CM to get this plum posting on delegation. 

CAG SOUNDS CORRUPTION IN EDUCATION DEPT

Corruption knows no bounds. Corruption and misappropriation of funds allocated for students' good also is not spared. After innumerable scams in land, mining, Coal, NREGSY, Food Grains distribution, Chit Funds and even Water, among others, lesser known education sector scam also has been unearthed. Fraudster's newer ways of siphoning off government exchequer is amazing. Newer scams have come to the fore in **Odisha Education depart**ment as sounded by none other than The Comptroller and Auditor General of India (CAG).

It is all about institute-officials nexus where several students are trapped to become their accomplices. Non-existing and inelligible institutes and students are used for the scam.

Unscrupulous officials know the loopholes and find best avenues to swindle government money. It is shocking to know how smartly some governments officials take undue advantage of well-intended government schemes to siphon off money from the exchequer. They do it smart, so they don't get caught quickly. Despite several checks and rules, the conniving officials do find ways to swindle money. Even students are not spared.

irregularities Severe and illegal activities of The Department of Higher Education of Odisha Government have come to the fore. Instances of fixing University Grant Commission (UGC) Pay Scale to ineligible Lecturers in several Colleges on the basis forged and fake documents have been found. **Involvement of Section Of**ficers, Section In-charge, Head Clerks and other staffs have been found colluding in preparing and or accepting forged and fake documents, even with scribbling with pen on paper have been found.

Recently, The Comptroller and Auditor General of India (CAG) had sounded suspected fraud and corruption in the implementation of the post-metric scholarship (PMS) scheme under Direct Benefit Transfer

(DBT) in Odisha.

In its report on the performance audit of the implementation of DBT in payment of PMS to eligible students in the State, the CAG observed that due to the absence of detailed checklist for inspection of Private Educational Institutions, over 5,185 beneficiaries of 15 ineligible institutions with fake students list, had been granted PMS, amounting to 15.79 crore, during the finanacial year 2016 to 2020.

The Ministry of Social Justice and Empowerment, in its revised guidelines issued in May 2018, made it mandatory fo the inspection of private institutions by officials nominated by the district collectors. However, the CAG noted that there was no provision for inspection of private educational institutions for sanctioning of PMS, which is the key source for illicit siphoning of government scheme funds.

Joint physical inspection of select 16 institutes, affiliates with the National Council of Vocational Research & Training (NCVRT) and Bharat Sevak Samaj (BSS), were carried out in 2021, by the Welfare Extension Officers (WEOs) and Assistant District Welfare Officers (AD-WOs) in the presence of CAG audit officials.

Of the 16 institutes verified, shocking to all, it was found that 8 were not in existence at all and even the local residents were not aware of existence of any such institutes. The Prerana, the PMS scheme portal. was also not equipped to identify and filter out these ineligible institutes and as a result at least Rs 15.79 Crore was misappropriated by ineligible and non-existing entities with the alleged connivance of Odisha government officials.

The CAG also found that PMS has been granted to the students even if they discontinue their studies, even after knowing they were not eligible for the benefit. For instance Sakuntala Sudarshan Institute of Technology in Mayurbanj district about 280 students had discontinued their studies during 2016-2021 but yet all of them were alleged-



ly paid PMS running into several crores, which was in full knowledge of the institute and the education department officials signaling rampant corruption in the department.

In another striking instance earlier in 2021, The Economic Offences Wing (EOW) of Crime Branch had arrested Prakash Chandra Rath, a retired under secretary to State government, for his alleged involvement in a scholarship scam amounting to Rs 36.1 lakh split between the official and the ineligible institutes and students.

Under the e-Medhabruti scheme, a Plus II student can get Rs 3000 scholarship annually for two years,a Plus III student gets Rs 5,000 annually for 3 years and PG student gets Rs 10,000 annually for 2 years. Besides this the Odisha government provides additional Rs 10,000 scholarship annually to students who want to pursue technical and professional courses. According to the prescribed norms income of the parents should not exceed Rs 6 Lakh per annum. Fraudster Rath is alleged to have majorly misused the norms in this e-Medhabruti scheme.

Rath was in-charge of Higher Education department's scholarship section. The department had lodged a complaint with the agency alleging financial mismanagement and irregularities in payment of scholarship during 2014-15 academic year. In its complaint, the department had alleged that several ineligible students were awarded scholarships leading to a huge loss to the government exchequer. EOW had registered a case in 2017 and launched an investigation into the matter.

After receiving applications, it was the responsibility of Rath to place them before the financial advisor for sanctioning the scholarships. However, Rath in criminal conspiracy with others had sanctioned scholarships to about 235 ineligible students by violating existing norms noted EOW sleuths. Rath had also allegedly received separate kickbacks for sanctioning the amounts bypassing the prescribed norms to students who were not entitled to scholarships. The case has still not been resolved owing to intricacies as to how so many fake students lists were prepared for the direct transfer and how it was withdrawn and split between the fraudsters.

The CAG also pointed out poor functioning of career counseling cells in Utkal University (UU), North Odisha University (NOU) and 32 known degree colleges. It is also alleged several hundred crores have been siphoned out in the name of organizing job fairs.

Various government departments have not submitted utilization certificates (UC), signifying alleged misappropriation of allotted amounts. In its report on state finances, the CAG said UCs for amount aggregating Rs 36,193 crore remained outstanding against 36 government departments as of March 2004 onwards. During 2019-20, government released Rs 28,465 crore as grants-in-aid to various agencies. Out of this, UCs were not received in respect of Rs 16,301 crore (57.27%).

There is, therefore, no assurance that expenditure of Rs 16,301 crore had actually been incurred for the purposes for which it was authorised, said the report.

Earlier Odisha Chief **Minister Naveen Patnaik** had dropped higher education minister Rohit Pujari in the wake allegations. There are allegations that the present **Principal Secretary of Higher Education Depart**ment Arabinda Agrwal, IAS, has been involved in fraud and cheating activities siphoning off several hundred crores from the exchequer in collusion with some Principals and Lecturers, including holding or making transfers of officers. For instance a lecturer Subrat Das of **Talcher Autonomous Col**lege has not been transferred for over 20 years.

It is also alleged that the said Principal Secretary, who as the District Collector of Angul, in nexus with mafia had been allegedly found involved in land and other scams and that court cases are in process against him.

It is easy to pile up allegations, but in the case of Odisha education scams, CAG appears to have evidence of wrong-doings by several officials which all need to be properly investigated and the culprits be booked and their ill earned assets be immediately ceased and returned back to the government exchequer to which they all justly belong. THE MASTER STRATEGIST

PADMA SHRI FOR "NARIYAL AMMA"

Kamachi Chellammal, also known as "Nariyal Amma", is a 67-year-old farmer hailing from Rangachang in South Andaman of the UT of Andaman and Nicobar Islands cluster who received the prestigious civilian award Padma Shri this year, 2024, for her outstanding contribution to organic coconut plantation. Chellammal is known for her innovative methods of transforming traditional farming and organic coconut plantation.

She uses coconut leaves and husks as mulching on the plantation to preserve moisture in the soil during the post-rainy season. Mulching is the act of covering the soil with mulches such as bark, wood chips, leaves, and other organic materials in order to preserve moisture and improve the condition of the soil.

Chellammal said her method not only helps in minimising moisture loss from the soil but also reduces the weed population which is extremely important for a healthy coconut plantation. She also adopted Integrated Pest Management strategy, instead of harmful chemicals, in which she opted for 'trap plants', which varies from one plantation to another. This attracts insects to release pheromones in the air which disrupts the natural mating cycle of pests. This helped her control the pest population. Chellammal also



did coconut-based multi species cropping by effectively utilising interspaces in her 10 acres of land. This integrated farming system helped her to overcome the challenges of the low market price of coconut, before the implementation of MSP, thereby generating more revenue. For multi species cropping, "Nariyal Amma" uses various plants such as elephant foot yam, banana, groundnut, pineapple, sweet potato, green chilly, tube rose, gladiolus, marigold and green vegetables.

Over the years, Chellammal encouraged other farmers to adopt organic farming.

Expressing gratitude to the Centre she said, "I live in a remote village and that too in Andaman and Nicobar Islands. Why will someone confer me with such a prestigious award? I was confused but later, someone from the Andaman administration told me that I was really awarded with the Padma Shri".

Her son Ramachandran who helps Chellammal in her farming too was delighted with the news and said that they are now planning to promote agro-tourism in their farmland. "I personally feel that agro-tourism has a lot of potential and I am sure our variety of crops, spice gardens, and fish farming will draw not only the local people, and students but also a lot of tourists," he said. Hailing from smaller and remote areas is no bar from doing things innovatively. The government should not stop just at this award, but should make arrangements to help her build on her agro talents and practical experience and also provide her with ample finances to help her further develop in this type of organic farming that would help million others in their initiatives across the country.

POACHING ON THE INCREASE

Poachers, from neighboring ly Mayanmar, regularly sneak into Andaman and Nicobar Islands, mainly to collect sea cucumbers and turbo snails. Sea cucumbers are highly endangered species and they help in keeping the ocean's bed clean by eating decaying matter which settles on the sea bed. However, they are used for medicinal purposes in the international market. Turbo snails are also in high demand in several Asian countries to be used in exotic cuisine and for decorative purposes, including showpieces, jewellery and buttons. The remote Indian islands cluster has become the poaching ground for this exotic and premium priced species. Located in the easternmost part of India, Narcondam in North and Middle Andaman district is only 126 km from Myanmar's Coco Island. It is formed of andesite, a volcanic rock. The island is classified as a dormant volcano by the Geological Survey of India (GSI). The island covering an area of approximately 7.6 square kilometres is a hunting ground for the poachers from Myanmar for the declared endangered species, Sea Cucumbers and Turbo Snails.

Recently, the Andaman police during a search operation apprehended two Myanmarese poachers from Narcondam Island who said,

majorboring during the interrogation, that six more poachers gularly from their country were han and hiding in the forest of main-Narcondum.

Immediately, a search team of Andaman police swung into action only to find bodies of the six poachers. The bodies were found lying a few metres from the shore in a forest on the small Narcondam island. Preliminary investigations revealed that the motorised wooden dinghy in which they entered the Indian waters developed some snag, they could not return to their homeland and hence, they took shelter in the jungles of Narcondum. It appears that they ran out of ration and drinking water and most probably died of starvation and dehydration. There were no injury marks on their bodies. Post mortem reports are awaited. A&N Police officials said.

More than 100 poachers from Myanmar have been arrested from the archipelago in the last two years and large numbers of sea cucumbers and Turbo snails seized from them. This is a dangerous development as the island is strategic and such illegal incursions of other countries could pose a security threat to the country. The coast guard and naval patrolling should increase many fold in the best interest of security of the islands cluster and also the country.

Lakshadweep Not To Be Messed Around

Kavaratti: Prime Minister Narendra Modi's early January visit to Lakshadweep has drawn global attention to the archipelago and its immense tourism potential. But the government is not keen on mass tourism promotions for this remote islands cluster. Despite the current craze and potential, the Union Ministry of Tourism is adopting a careful and sustainable tourism development model, since it is an "ecologically fragile" and "very eco-sensitive destination", to showcase Lakshadweep. But at the same time government is keen on not "overcrowding" the islands to preserve its ecology and ensure that the local environment is not jeopardized or spoilt. Government is not to mess around this potential of this remote island cluster, or for that matter any such lesser known Indian destinations, just for the sake revenue earning tourism purpose. Besides promoting domestic islands, less popular spots in India are also being identified to develop tourism and smaller promotional programmes are being put in place.

The Union Ministry of Tourism will adopt a sustainable tourism development model to showcase Lakshadweep but is keen on not "overcrowding" the islands to preserve its ecology and ensure that the local environment is not spoiled, a senior govern-

ment official said.

Government's current priority is to develop the infrastructure appropriate for the island that can withstand the tourism influx later, when fully developed. Taj Hotel group is coming up with hotels there. They have already started the work. Many more should folllow. The high-end tourists will find Lakshadweep, a beautiful beach destination compared to any other world class destinations.

Several initiatives are being taken to promote tourism in Lakshadweep, including the construction of additional rooms and plans afoot for a big airport, with the archipelago being discussed worldwide after the visit of Mr. Modi, its administrator Praful Patel had recently said.

The Ministry has also identified the islands which would be developed as tourist destination spots in Lakshadweep, but the focus would be to adopt a sustainable tourism development model since it is a "very eco-sensitive destination." Lakshadweep has many islands of which have been selected like Minicoy, Suheli Par, Agatti and also Bangaram. As of now, the Ministry is cautious about not bringing in too many players in Lakshadweep as it does not want the island to be "overcrowded" at this point in time the tourism ministry official said. We are ensuring that these destinations are maintained well and that their eco-sensitivity is taken care of. When tourists travel, they should feel that the destination is same even when they visit after 20 years," the official added. UT of Lakshadweep Member of Parliament Mohammed Faizal while welcoming the developments has said that he would fight to ensure the original cultural fabric is maintained and the developments though needed would not destroy the serene natural environment. Very thoughtful of the government to keep in mind to preserve the original natural ecosystem that these destinations boast of.

Exactly what she did decade ago to unseat the left from its two decades of State rule is now haunting her.


The directionless meltdown of Congress owing to multiple power centers and leadership vacuum and the opposition that is bogged down by the self-centered political ambitions of its bosses is stirring in parallel to the focused consolidation within the BJP. In the National Council meeting of the ruling party, attended by over 11,000 delegates, that included panchayat-level leaders, Prime Minister Narendra Modi set the aggressive poll campaign tone with the target of winning 370+ seats for his party and 400+ seats for the NDA combine.

PM Modi with his formidable team of Home **Minister Amit Shah, Party** President J P Nadda and Party Secretary B L Santosh unveiled the doable strategy to achieve the 370+ target. ₹4000 CR AXIS ILLICIT TRADING

Axis bank, one of India's largest and leading private multinational financial services banker has run into bumps with alleged illicit profiteering circumventing laws in trading with shares of a particular group company. According to a report

by Bar and Bench, allegations are that Max Life **Insurance and Max Finan**cial Services reportedly allowed their shareholder Axis Bank Ltd and its group companies Axis Securities Ltd and Axis Capital Ltd to generate unjustified profits, undue gains, from the purchase and sale of equity shares of Max Life in a totally non-transparent manner thereby, violating the mandatory directions of the Insurance Regulatory and Development Authority of India.

The allegation points to a 'blatant' fraud within Max Life Insurance and Max Financial Services whereby the owners have made huge illicit money running into several thousand crores in nexus with Axis Bank. The estimate says this alleged Axis Bank shares trading fraud is close to Rs 4,000 Crore.

Bharatiya Janata Party (BJP) leader Subramanian Swamy has moved the Delhi high court alleging a []1,500 crore scam by Axis



Bank. The BJP leader has accused the private lender of undue gains through transactions in shares of Max Life Insurance, Bar and Bench reported.

It is alleged that the bank's group entities acquired a 12.002% stake in the said Max companies at a ridiculously low price ranging from Rs 31.51 to Rs 32.12 per share, totaling 736 Crores. This is when the Max shares of the Financial services alone was trading beyond Rs 964 a share. It is obvious that this amount is very clearly much lower than the fair market value. This being true, Axis and its cooniving associates have made a clean at least Rs 930 per share, which is huge. The difference in price between the purchase and market trading value have allegedly been shared between the two group owners.

"On simple calculation, resulting to make undue profits/gains from the purchase on the sale of equity shares of Max Life in a non-transparent manner, Axis Bank has unlawfully gained approx Rs 4000 Crores," the plea read.

As anyone would expect, Axis bank has denied the charges and says it has followed prescribed regulations. Axis bank meanwhile witnessed turbulence in its share value that almost dropped by 2% amidst accusation of Rs 1,500 Crore fraud in shares trading scam by the senior BJP leader Swamy.

Stock market trading for ages has been one of the most preferred, safest and easiest route to book paper losses and profits and more so to hide and also generate illicit cash earnings and convert them to legal earnings. **Companies and financial** institutions have been doing these with ease owing to several loopholes which are intentionally ignored by the law makers, but only few who are caught with media glare come to the public light, say some finance professionals. With the government bent upon tightening the financial flow system, one only could hope in the coming decade such instances would dwarf, but it is hard to expect this to end in a cash-based flourishing economy despite reforms.

ZEE SIPHONS OFF ₹2000 CR

Zee, the mega media house, after the failed merger with Sony, is all over the headlines again, this time for its murkier accounting that has unearthed a fraud of US\$241 million which is said to have been siphoned or diverted from the already ailing company's coffers to benefit specific individuals of the company. This adds to Zee founder, Subhash Chandra, his son Punit Goenka's, woes who are already in deep waters and fighting to revive the business. An investigation by the Securities and Exchange Board of India (SEBI), the Indian stock market regulator, into Zee Entertainment's founders has allegedly uncovered potential diversions of about Rs 2000 Crores rupees (US\$241 million) from the company's coffers to entities benefiting the founders and certain other top executive officers of Zee. This figure is said to be nearly ten times greater than what SEBI investigators' initially projected.

India's market watchdog finding this huge hole of more than \$240 million in the accounts of Zee Entertainment Enterprises Ltd., is a yet another blow to the embattled media firm less than a month after its mega US\$10 Billion merger plan with Sony Group Corp's local unit collapsed. The merger would have bolstered Sony by giving it access to Zee's deep library of content in regional Indian languages while improving Zee's financial health. The regulatory probe into the father-and-son duo's alleged financial improprieties had led to much wrangling between Sony and Zee since mid-2023. It made Sony wary of letting Goenka helm the merged entity while Goenka refused to give in, as the CEO spot was promised to him as a part of the 2021 merger proposal pact. The standoff ultimately led to Sony scuttling the deal in January. However, the market rumours were on trying to spike Zee share prices in the market. Even after calling off the merger, Zee continues to be on a difficult path with its shares making headlines almost every week. A few days back, there were reports that the mega-deal might have another chance for revival. Later Zee Entertainment issued a clarification, refuting reports of resuming discussions with the Sony group to revive their \$10 billion merger deal, which was terminated last month. In a regulatory filing, Zee Entertainment stated that the company was not engaged in any negotiations regarding the Sony merger deal and added that the reports indicating a revival of talks were incorrect. It is said that the amount of Rs 2000 Crore found missing in the account, signifying a deep suspicious hole, is not final and may change after Sebi reviews the responses from the company executives. The regulator has been calling in senior officials at Zee including founders, Subhash Chandra, his son Punit Goenka and some board members to explain their stance which they have still not done to the satisfaction of the market regulator. SEBI, in an order last August, barred Zee founder Chandra and his son Goenka, from holding executive or director positions in any listed firm after finding that they had "abused their position" and siphoned off funds "for their own benefit" though some reprieve was given to them later.

PCC President K A Alagiri and S Rajesh Kumar, the MLA from Vijaydharai's neighboring constituency, was named the Tamil Nadu Assembly's CLP Leader. This in itself became an irritant for her continuance in TN PCC and opined Congress was averse to providing leadership roles to women. She was not wrong. Her discomfort with Congress increased with the party choosing, earlier, Vijay Vasanth for the Kanyakumari LS by-election that she expected would come to her. She felt that the party has sidelined her and was naturally frustrated. Vijaydharani, a lawyer by profession, believes that PM Modi's programs and governance are par excellent and says she wants to strengthen his initiatives and increase his hold in the State. She is tipped to be the BJP contender from Kanyakumari or may be Nagarkoil LS constituency in the coming 2024 gener-

al elections challenging the UPA candidate, possibly from the Congress. She asserted that her move will strengthen Prime Minister Narendra Modi's hold in the southern state. S Vijayadharani comes from the family of celebrated Tamil poet late Kavimani Desiga Vinavagam Pillai. The entry of S Vijayadharani into the BJP comes as a booster as it recently suffered a setback after AIADMK snapped ties with it. The BJP was unable to win any of the 39 Lok Sabha seats in Tamil Nadu in the 2019 general elections. The BJP, however, now has a larger presence in Kanniyakumari. The BJP having a negligent presence in the state counts on its state chief Annamalai's hard work to expand its footprint in the state even as it tries to cobble an alliance with a few smaller parties. BJP workers in the State feel Vijavdharani's entry will further strengthen the party in the State.

Mehta admitted that it would need huge sustained long-term investment especially for vigorous R&D, including from the Indian Government, to reach a level of manufacturing high-end advanced technology drones to fill in for the import of defence application drones.

India to be Chip manufacturing superpower soon. This is one of the dream of Prime Minister Narendra Modi. under the Atma Nirbhar program. India is on the right path to becoming semiconductor and Chips manufacturing super power. India is already one of world's software superpower. No electronic hardware can function without software. After decent mastering of software sector, India is now progressing fast-paced to become world's hardware manufacturing hub.

In 2021, India launched its **India SemiConductor Mission** to develop sustainable semiconductors and a display ecosystem. The mission includes plans to set up semiconductor and LED display manufacturing factories in India. This mission is progressing well going by the numerous initiatives by mega corporations and their fast-paced setting up of factories across India and the collaborations deals signed with overseas experts in the field, mostly from Taiwan, Israel, Japan and USA. Taking this mission forward, Vedanta and Innolux propose to start LCD display mass production in India with an estimated cost of US\$4 billion. Innolux owns TFT-LCD and touch sensor fabs. LCDs are expected to dominate the market. A proposal by Mr Anil Agarwal's Vedanta, a diversified conglomerate and a British mining and metals group, with Taiwan-based Innolux as a technology provider is estimated to begin mass production of LCD displays in India in the next 18-24 months after receiving government approval. Vedanta has onboarded Innolux as a technology partner to set up the LCD display screen manufacturing factory in the country. The venture would generate minimum 5000 job opportunities and development of the areas around the factory. Of the total workfoforce 2,000 would be engineers around 80 to 100 top and expert technicians would be from Innolux to India during this project. Around 300 engineers would be sent to Innolux, Taiwan for



training in mass production.

Vedanta has submitted the proposal to the Ministry of Electronics and IT (Meity) under the programme for semiconductor and display fab ecosystem for entitled incentives. Innolux President and COO, James Yang, who has experience of project rollout, said that the venture can begin the first phase of mass production of LCD displays within 24 months. Project Phase-2 to take another 6 to 9 months. Innolux owns 14 TFT-LCD fabs and 3 touch sensor fabs in Jhunan and Tainan, Taiwan, with production lines of all generations.

Currently, companies in India import their entire display requirement from overseas. The manufacturing initiative is designed to meet India's national policies for satisfying domestic demand, replacing imports, and potentially enabling exports.

The venture would later also focus on advanced display technologies like OLED. Despite potential advancements, mature display technology will still be LCD. LCD is the foundation for premium technologies. OLED is essentially a derivative of LCD technology, and while it has its applications, LCD remains fundamental. Similarly, MicroLED also builds upon LCD technology. Besides the display proposal, the government has received a USD 8 billion proposal from Israel-based Tower Semiconductors and a multi-billion semiconductor fabrication plant project from Tata Group, as several others are in the advance stages of completion. Micron, the USbased memory chip giant, plans to invest \$825 million, with the government also providing remaining funding in two phases. In September 2023, Micron began construction of a semiconductor assembly plant is expected to roll out its first batch in as early as December 2024. Murugappa Group's CG Power and Industrial Solutions Ltd. (CG Power) has formed a joint venture with Renesas Electronics America Inc. (Japan) and Stars Microelectronics (Thailand) Public Co. Ltd. (Stars) to establish an outsourced semiconductor assembly and testing (OSAT) facility in India.

According to Government of India, the microprocessor chips that power all things digital will soon be fully made in India. About US\$10 billion in subsidies are at stake, ready to fund 50 percent or even 70 percent of any company's outlay. supported by "production-linked incentives". Anil Agarwal, the chairman of Vedanta says the world should expect "Vedanta made-in-India chips" by 2025. Sights have already been on a barren plain in Gujarat, Dholera, designated for the future home of India's first "semicon city." Dholera's vast grid is otherwise virtually empty. It's the size of Singapore, big enough for a starter. Cutting through barren but fertile fields fit for the intended purpose, development new broad and modern roads connecting office complexes and power stations, freshwater canals made from diverted river and the gigantic infrastructure coming up in the dusts of barren lands along with an international airport are all coming fast to change the entire landscape. India is definitely moving towards becoming world's most admired chip and display units manufacturing hub.

₹1000 CR BOGUS GST BILLS RACKET BUSTED

Fake ITC Claim of Rs 180 Crore through 100 bogus firms busted by Karnataka's GST sleuths in collaboration with Kerala State GST authorities.

Karnataka's Commercial Taxes Department, in collaboration with Kerala State GST authorities, has arrested Mohammed Siddiq, for his role as a key mastermind in a multistate GST fraud centred around fake GST claims. He faces charges related to obtaining dummy GST registrations through forged and fake documents and facilitating a scrap business across Kerala.

Tamil Nadu, and Karnataka. The operation exposed a significant network involved in acquiring dummy GST registrations through forged documents and facilitating a scrap business across Kerala, Tamil Nadu, and Karnataka.

In a joint operation, the **Commercial Tax authorities** of Karnataka and Kerala have busted a large-scale fraud encompassing more than 100 bogus firms engaged in the issuance of fake tax invoices and creation of fake Input Tax Credit (ITC).

According to Commercial

Tax Department, Bengaluru, Siddiq played a pivotal role in generating fake tax invoices, without actually delivering any goods. These fake Tax Invoices allowed dealers to make spurious claims of ITC without remitting the corresponding taxes to the respective Governments following the initial transactions. Department officials re-

vealed that these bogus firms collectively issued counterfeit invoices totaling Rs 1,008 crore, resulting in an illegal Input Tax Credit of Rs 180 crore. This case revealed the

loopholes in the system where several fraudsters were issuing fake invoices without supplying the goods in reality, collecting the GST but never paid the same to the GST department.

This system was designed to offset outward tax liability, evading GST cash responsibilities on outward supplies that has led to substantial losses to the Government exchequer. Tax sleuths identified the complicity of certain auditors and GST practitioners in these fraudulent activities.

The Department claimed

to have successfully dismantled a GST fraud racket involving approximately 100 bogus registrations across Karnataka, Kerala, and Tamil Nadu.

It may be recalled here that early this month, the Officers of Headquarters Preventive Unit, Central Tax GST Office in Mysuru, had unearthed a sophisticated fake invoice racket, involving a tax evasion of over Rs. 14 crore for GST bills of Rs. 60 crore and had arrested Imran, proprietor of Rub Traders, Mysuru, on Jan. 8.2024.

Forthcoming 2024 general elections should be interesting to watch. DMK supremo and Tamil Nadu Chief Minister M K Stalin has finalized the LS seats sharing understanding with all his poll allies ending weeks of suspense.

Tamil Nadu's 39+1 LS constituencies will see the DMK allies basically in a three-cornered fight lead by the BJP that is rising in its

popularity expanding its footprints along with its NDA allies and AIADMK which severed its ties with NDA recently. The DMK allies with their share of seat allocations, DMK (21 including UT of Puducherry), Congress (8), VCK (2), CPI-M (2), CPI (2), IUML (1), MMK (1) and KMDK (1), will fight from their given LS constituencies.

The LS seat allocations to its allies signifies CM Stalin's perfected understanding of the TN politics, respective allies sway influence, who will perform from where and avoiding splitting of votes and his confident winning streak attitude to garners all the 40 LS seats in the State that would offer him a greater bargaining power among the newly formed opposition grouping led by the Congress. Stalin is also an astute politician aptly mentored by his father late M Karunanidhi, who was a master politician who had the knack of dealing with critical challenges. He possibly was also conscious of the rising popularity and familiarity of BJP in the southern States, what with Prime Minister Narendra Modi visiting the Southern States more frequently in the last few months attracting huge crowds. This he knew is increasing the influence on the voters, especially the fence sitters and the hard core Hindutva supporters. Stalin has carefully analysed the strengths and shortcomings of his allies and adversaries and had decided to offer alternate representations to few of the allies to ensure votes are not split to trigger a win for the BJP or his other opponents and halt any crossovers to the BJP-NDA camp. For instance he possibly realized that Kamal Hassan is also a popular actor-turned politician and has his own sizeable share of supporting voters. But he also knew Hassan's Makkal Needhi Maiam (MNM) supporters are largely scattered except for its own stronghold Coimbatore. This would mean MNM voters might split the votes of DMK allies should Hassan decide to fight alone. So he has also offered a Rajaya Sabha seat to MNM to ensure DMK allies get the MNM voters and at the same time satisfy the political ambition of Hassan. Same possibly goes with Vaiko's MDMK where a RS seat also has been offered. All said Stalin and DMK at this point of time have no opposition across the State and DMK remains the sole political power in the State. Poll campaign of DMK has started, so are that of his allies. It looks like he is all set to grab all the 40 LS seats on offer, come the 2024 general elections.

In the midst of long list of exodus from the grand old Congress party, the party Chief Mallikarjun Kharge appointed a controversial party leader, K Selvaperunthagai as the President of the Tamil Nadu Congress Committee replacing K S Alagiri.

The All India Congress Committee (AICC) leadership's decision to replace K S Alagiri with K Selvaperunthagai as the Tamil Nadu party chief has evoked mixed reactions among the state party leaders owing to Selvaperunthagai's vocal position on the Dalit issues and his past association with Tamil nationalism. The meteoric rise of Selvaperunthagai, fondly called Selvam, is an interesting story of an ordinary Reserve Bank of India employee turned powerful Tamil Nadu politician. The Congress MLA from Sriperumbudur, Selvam turned to Dalit activism and later served as a legislator of the Viduthalai Chiruthaigal Katchi (VCK) a political party championing the cause of Dalits in Tamil Nadu. Selvaperunthagai edged out two key party leaders of prominance, Karur MP S Jothimani and former IAS officer-turned politician Sasikanth Senthil, both considered close to Rahul Gandhi, in the race to become the Tamil Nadu Congress Committee (TNCC) President. It is said that AICC President Kharge was keen to have Selvam, a Dalit, as the TNPCC President bypassing other eligibilities. A senior Congress leader said Senthil and Jothimani are "known for their diligent and no-nonsense approach but need grooming". "There are concerns over Jothimani's skills to unify factions and maintain alliances. On the other hand, Senthil can be a transformative leader for the party akin to the BJP's K Annamalai but he needs to integrate with the state and district-level units of the party," the leader said.

TNCC President Selvam started his political career with Puratchi Bharatham Katchi (PBK) and later crossed over to Puthiya Tamilagam Party (PTP) which he again left for VCK. He was later elected to the Tamil Nadu Legislative Assembly as a member of the Viduthalai Chiruthaigal Katchi (VCK). Later, due to a disagreement with VCK party Chief Thirumavalavan, he left the VCK to join Bahujan Samaj Party (BSP) in 2008 and again left them and crossed over to Congress in 2010. There are allegations that Selvaperunthagai joined Congress just to protect his ill-gotten wealth and escape with ease from any legal action against him. Notably, Selvaperunthagai came to Congress in 2010 and lost the 2016 elections to the AIADMK candidate

Selvam's elevation is significant as he is the first leader from the Dalit community



since L Ilaya Perumal in 1979 to be appointed as the state Congress chief. Selvaperunthagai's achievements as an MLA, SC wing president and floor leader in Tamil Nadu Assembly are commendable, admit several Congress leaders. As a part of the Congress' property recovery committee, he was instrumental in the recovery of over 200 properties the party had almost lost. The new TNPCC President is credited with the trait of being cordial with all and would be able to take along both youth and seniors together as he takes the party forward.

Bringing in Selvaperunthagai to steer the state Congress unit is also being seen as the party leadership's attempt to blend its values with the realities of regional politics in order to consolidate the party's position against the BJP and the AIADMK. In the 2019 Lok Sabha polls, the DMK-led alliance had won 38 of the 39 seats in the state.

The new TN Congress President has several credits to his account. Selvam's effective role as the party floor leader in the state Tamil Nadu Assembly since the DMK came to power in 2021, his fiery opposition to both the AIADMK and the BJP, and more so his close proximity to DMK bosses, were all important factors for his elevation to the post of the TN-PCC chief, tilting the scales in his favour.

A senior TNPCC leader, though initially expressing surprise over the appointment, said he would support Selvaperunthagai as it was imperative to focus on his opposition to the BJP rather than his past. A section of leaders also sees him as a figure of resilience for warding off attempts by other parties to effect defections. A senior DMK minister said Selvaperunthagai was "one of the finest MLAs" in the alliance. "We have many allies and MLAs but very few like Selvaperunthagai fight the AIADMK and BJP consistently in the House," he said. The DMK rules the state in alliance with the Congress, VCK and the Left parties. The new TNPCC president brings with him onboard a wealth of political experience and money power for the state congress to benefit in the State.

AADHAV INCREASES VCK POWER Viduthalai Chiruthaigal

Katchi, (VCK) of Dr Thol Thirumavalavan, Founder and President of the political outfit, has bagged 2 Lok Sabha seats in their stronghold Thiruvallur.

Thiruvallur Lok Sabha constituency a comparitively newly formed Lok Sabha constituency after the 2008 delimitation. It was formed after merging the assembly segments of Gummidipoondi, Ponneri (SC), Tiruvallur, and Poonamallee (SC), which were earlier parts of Sripeconstituency rumbudur and the newly formed Avadi. Arjuna denied any influence of his father-in-law Lottery Martin and said ather than aligning with a national party, I chose the VCK as a platform to address societal inequalities and poverty through grassroots politics, in collaboration with Brother Thiruma. Arjuna has been playing his role in the party well implementing slew of planned and VCK chief approved initiatives to strengthen the party including the

Arjuna the new Dy General Secretary of VCK, with a vast experience as the Chief Strategist of DMK and AIADMK during earlier polls and loaded with the needed money power, one could expect VCK to increase its footprints across the State soon.

VCK performed well in the 2014 general elections polling close to 25% of the polled votes though lost to AIADMK then. Over the years Dr Thol Thirumavalavan has worked hard to enhance his and his party's popularity in the region.

Dr Thirumavalavan a doctorate in Religious **Conversions, is particular**ly popular for his aggressive postures which has gained him significant recognition among the people in his region, especially the dalits and also several other communities, the SCs. STs. OBCs and more so the Minorities including Muslim and Christian communities.

Dr Thirumalavan, is slowly becoming a power politician and a Dalit Icon, championing their causes. VCK organized two months ago a massive public meeting at Trichy, Tamil Nadu, termed Vellum Jananayagam (Democracy will win). This was a stupendous success meeting. Over a lakh attended this unique public meeting and showcased the unity of all the constituents of the newly formed opposition grouping I.N.D.I. alliance. This reflected his growing influence in the Tamil Nadu politics.

With people with political acumen and money power like Arjuna taking critical responsibilities should soon see VCK in more places to create a stir and change the political equations and dynamics in the Tamil Nadu political landscape.

VE HIMS Dhirajlal Nathwani Director-Corpo-

rate Affairs at Reliance Industries Limited (RIL) and Rajya Sabha MP from YSR Congress Party, Andhra Pradesh continues to be a headline catcher. His quick rise from rags to riches is said to have caught the eyes of the central investigating agencies. His nomination to Rajya Sabha from Andhra Pradesh Chief Minister Jagan Reddy's YSR Congress where he is unknown, but done on the influence of RIL Chairman, in itself an interesting story filled with suspense.

Strange are the stories of the rich, not necessarily famous, quickly rising from rags always kindles keen interests. Allegations of money laundering and corruption against Reliance (RIL) Parimal Nathwani are piling up. It is said that there are several cases pending against him, in different stages with central investigation agencies such as ED, IT, CBI, to name a few and he is actively pursuing avenues to wriggle out of them. His entry into RS, people allege, was basically to dilute the cases against him, which it is said is unfortunately not happening as he would have otherwise wished. Back in Andhra Pradesh, MLAs and MPs are asking themselves who this Nathwani is, as none appear to have seen him ever in the State or even in the Parliament. It is known that this RS member hardly goes to attend the parliament proceedings, leave alone actively participating in the prestigious House of Seniors. A source alleged that he hardly comes to the parliament house and even if he comes just signs and runs away. Even as recent as the last monsoon session a parliamentarian had raised the question in the House on the alleged fraudulent misinformation in his Affidavit filed with the Election Commission of India.

Many were surprised to see Nathwani recently in the Parliament during the **BJP-NDA** government's concluding current 5-year term session. Sources said that contrary to his earlier conduct, he was seen more frequently in the Parliament House selectively meeting and conversing with few Parliament Members. Nathwani, a shrewd small time railway ticket seller-turned-lobbyist will never do anything without a purpose. What was the reason for his frequent personal appearance in the Parliament House this time?

These allegations as it may be, using his influence in the Reliance Industries and his closeness with Mukesh **Ambani of Reliance, Parimal** Nathwani has inducted his son. Dhanraj P Nathwani, also into Reliance industries as a Group President. The son is nothing smaller to his father as he has developed close relations with the children of the tycoon so quickly. It is now alleged that the father-son duo influence in **RIL now has increased mul**tifold. It is said that both father-son duo now are eroding into Reliance Industries finances and earn in multiple of crores from Reliance alone year after year in the form of huge salaries, perks and other incentives which in fact they don't deserve, allege several employees. It is said that their annual compensation alone is over 18-20 crore which is unjustified, plus the interesting and tricky perks adding up.

Many in the Reliance are unhappy with the father-son duo in the company saying they are occupying top most positions they are not fit to be, bypassing several senior and capable existing employees and senior most management brains in the company. While father Parimal Nathwani is the Director of Corporate Affairs his son Dhanraj Nathwani is a Group President of RIL. It is said that majority in the Reliance don't like the Nathwanis, but are forced to work with them owing to their position in the company and more so their closeness to the Ambanis. Many whisper that Nathwarni literally runs a parallel Reliance and allegedly, gaining all the financials benefits to himself. As the time passed by and as Nathwani took full control of Reliance as its Corporate Head, it is alleged, he is ensuring that all liaison work with the company and the Ambanis are only with and routed through him and his son. Several top employees alleged that the Nathwanis have ensured that none can interact with the Ambanis without their approval.

Latest of the allegations against the Nathwanis is that how they got so much wealth in such a short time that Nathwani is said to be building his super-luxury palatial bungalow in the prime and premium Mumbai location at an alleged whooping cost of Rs 900 crore? Looks really interesting!

Nathwani's rise from being a small time railway ticket black market seller in railway platforms of Gujarat

Stations-turned-power-broker, now a RS MP, and also Director at Reliance and also considered very close to the RIL supremo Mukesh Ambani and his family, is meteoric. But the quick rise is not of any honest hard work, but is alleged to be out of illicit means. There are several serious alleged cases against Parimal Nathwani. How come he is still occupying the highest post of highest honor and respect in the Indian Parliament as one of its Rajya Sabha member, it is being questioned. It is said that a complaint of serious fraud, corruption and money laundering was filed with the Serious Fraud Investigation Office (SFIO). It is said that this was reviewed and recommended by the then **Chief of SFIO for extensive** investigation, but later withdrawn quoting law impediments, allegedly triggered owing to Nathwani's money power and influence. This in itself raises several questions, yet unanswered. Filing a serious criminal complaint with one of the apex fraud investigation agencies in itself calls for extensive investigations by suitable investigating agencies. Just withdrawing the complaint does not in any way absolve the individual from the piled allegations and accusations, or does it?

No smoke without spark somewhere. Allegations are mounting against this one time small railway platform ticket seller who also is alleged to be having illicit relationship with a senior railway employee through whom he once, allegedly, used to get his black market railway tickets. All cannot be dismissed as rumours or just simple allegations. There are several cases under investigation against him including his shell company M/S Khodiyar Consultants Pvt Ltd where both father-son duo are Directors and the same was raised as question the Parliament once. Senior Ambani, late Dhirubhai Ambani, ensured he kept the relationships cordial with the polity and bureaucracy all the time. In the initial stages, it is said that Mukesh also carried forward the same legacy of his father, but as Nathwani entered Reliance arena, he started getting distanced from all the political parties and bureaucracy. Though, Mukesh is one of the most respected and highly regarded business tycoon, it is said of late he rarely interacts directly with anyone. Now the circumstances have started changing. Nathwani



has not maintained good relations with any of the political parties. Gone are the days when both the ruling and opposition parties used to take the name of the Ambanis or reliance with great respect and regard. Now opposition is openly taking the name of Ambanis as government favoured business house. But the ruling party says that this is not true at all as the relations are not the same as it was during the Dhirubhai Ambani days. When allegations are that the Ambanis are a favoured entity of the ruling party, why then Nathwarni had to go all the way to Andhra Pradesh and join Jagan Reddy's YSR party, a non-supporter of the ruling party, to be nominated to RS as MP, using money power? Honest employees of Reliance now fear that the reputation and pride of Reliance Group may be at stake too soon because of the presence of father-son duo in the group, who are allegedly running a parallel Reliance. Now comes the question of why Nathwani this concluding session around was busy meeting several MPs and spending unusually longer time interacting with them in close quarters. People allege that with the current BJP-NDA government's 2nd term ending and with them expected to come back again, he is worried, naturally. People allege that he met several party leaders recently assuring them election funding to keep them all in good spirits and requesting for their support to dilute the cases against him.

True or false, time will only tell which is not too far away. He would wish a change in guard at the centre, but his dreams getting shattered on liquidation or at lease dilution of the alleged cases against him with the imminent return of the BJP government. His worries are natural for a person alleged to have illicitly earned his huge wealth in a short time frame.
